## The 9/11 Commission Rejects own Report as Based on Government Lies - By Gordon Duff Salem-News.com

(CINCINNATI, Ohio) - In John Farmer's book: "The Ground Truth: The Story Behind America's Defense on 9/11", the author builds the inescapably convincing case that the official version... is almost entirely untrue...

The 9/11 Commission now tells us that the official version of 9/11 was based on false testimony and documents and is almost entirely untrue. The details of this massive cover-up are carefully outlined in a book by John Farmer, who was the Senior Counsel for the 9/11 Commission.

Farmer, Dean of Rutger Universities' School of Law and former Attorney General of New Jersey, was responsible for drafting the original flawed 9/11 report.

Does Farmer have cooperation and agreement from other members of the Commission? Yes. Did they say Bush ordered 9/11? No. Do they say that the 9/11 Commission was lied to by the FBI, CIA, Whitehouse and NORAD? Yes. Is there full documentary proof of this? Yes.

Farmer states..."at some level of the government, at some point in time...there was an agreement not to tell the truth about what happened... I was shocked at how different the truth was from the way it was described .... The [Norad air defense] tapes told a radically different story from what had been told to us and the public for two years. This is not spin."

The 9/11 Commission head, Thomas Kean, was the Republican governor of New Jersey. He had the following to say... "We to this day don't know why NORAD [the North American Aerospace Command] told us what they told us, it was just so far from the truth. . . " When Bush's own handpicked commission failed to go along with the cover up and requested a criminal investigation, why was nothing done?

9/11 Commission member and former US Senator, Bob Kerrey, says, "No one is more qualified to write the definitive book about the tragedy of 9/11 than John Farmer. Fortunately, he has done so. Even more fortunately the language is clear, alive and instructive for anyone who wants to make certain this never happens again."

With the only "official" 9/11 report now totally false, where do we go from here? Who is hurt by these lies? The families of the victims of 9/11 have fought, for years, to get to the truth. For years, our government has hidden behind lies and secrecy to deny them closure.

In 2006, The Washington Post reported..."Suspicion of wrongdoing ran so deep that the 10-member commission, in a secret meeting at the end of its tenure in summer 2004, debated referring the matter to the Justice Department for criminal investigation, according to several commission sources. Staff members and some commissioners thought that

e-mails and other evidence provided enough probable cause to believe that military and aviation officials violated the law by making false statements to Congress and to the commission..."

What does Farmer's book tell us? Farmer offers no solutions, only a total and full rejection of what was told and his own ideas concerning the total failure of honesty on the part of the government, a government with something to hide.

Farmer never tells us what. Nobody could keep a job in the public sector speaking out more than Farmer has. What were Farmer's omissions? There are some. Now that we know that intelligence given the 9/11 Commission wasn't just lies from our own government but based on testimony coerced through torture from informants forced to back up a cover story now proven false, a pattern emerges.

We know that, immediately after 9/11, many more potential suspects and informants were flown directly to Saudi Arabia by Presidential order than were ever detained and questioned. We will never know what they could have said. Their testimony would have been vital to any real investigation were they not put beyond the reach of even Congress and the FBI.

Putting aside all other questions of recent evidence of CIA involvement with bin Laden prior to 9/11 or altered physical evidence involving the Pentagon attack, any failure to call to account the systematic perjury committed by dozens of top government officials, now exposed as a certainty is an offense to every American.

What do we know? We know the conjecture about 9/11 still stands but for certain, we know we were lied to, not in a minor way, but systematically as part of a plot covering up government involvement at nearly every level, perhaps gross negligence, perhaps something with darker intent.

Are we willing to live with another lie to go with the Warren Report, Iran Contra and so many others? Has the sacrifice of thousands more Americans, killed, wounded or irreparably damaged by a war knowingly built on the same lies from the same liars who misled the 9/11 Commission pushed us beyond willingness to confront the truth?

### Russian Scientists: H1N1 linked to Genetically Modified Food

Scientists from Russia's Ministry of Health are warning in a secret report to Prime Minister Putin that they have discovered a 'critical link' between the H1N1 influenza (Swine Flu) virus and genetically modified amylopectin potatoes that are consumed in massive quantities nearly exclusively by Westerners and sold in fast food restaurants as French Fries.

Pandemic influenza virus is that the South American Nation of Chile is the only country in the World outside of The United States, Canada, United Kingdom and Australia to allow the planting of these genetically modified potatoes due to their Free Trade Pact with the US and who are reporting 1,694 cases of this disease.

Also important to note are that most of the World's largest Nations do not allow the planting of these genetically modified potatoes and therefore are reporting very limited outbreaks of the H1N1 Pandemic influenza, including Russia with 3 cases, China, the World's most populated country, with 318 cases, and India, the World's second largest country, with 16.

These reports further state that with the linkage between the H1N1 Pandemic influenza virus and fast food French Fries made from genetically modified potatoes the most venerable people to being infected are the youngest who, by far, are the largest consumers of these types of cheap Western foods, and which was recently confirmed by the Washington Post News Service that reported:

"Of the 5,000 confirmed and more than 100,000 probable cases of swine flu, the average age of infected people is 15; two thirds are younger than 18." "The new strain of influenza appears to have mutated to become

more infectious for humans, the online edition of science magazine Nature reported Monday, referencing research by a team including Prof. Yoshihiro Kawaoka of Tokyo University's Institute of Medical Science.

The surface of influenza virus particles are covered with thorn-shaped proteins called hemagglutinin (HA), which allows the virus to stick to human cells.

After analyzing multiple samples of the new flu virus, the team ascertained that in some cases the HA of the new H1N1 strain have mutated, allowing the strain to stick to human cells more easily.

According to Kawaoka, the same mutations have been found in HA of the H5N1 strain of influenza, the highly virulent bird flu, which kills about 60 percent of those it infects. Kawaoka said the virus is still in the process of mutating into a form even more infectious to humans."

"Brazilian scientists have identified a new strain of the H1N1 virus after examining samples from a patient in Sao Paulo, their institute said Tuesday. The variant has been called A/Sao Paulo/1454/H1N1 by the Adolfo Lutz Bacteriological Institute, which compared it with samples of the A(H1N1) swine flu from California."

More ominously to be examined in these reports is the response of the United States to this Pandemic which, to date, is the World's largest infected Nation (reporting 7 more H1N1 flu deaths today) and which has already declared a Public Health Emergency and, just yesterday, passed a bill in its Congress allocating \$7.7 Billion to prepare themselves for this catastrophic disease.

# Thatcher adviser: Copenhagen goal is 1-world government

## 'Global warming' to be used as 'pretext' for 'change'

A former science adviser to British Prime Minister Margaret Thatcher says the real purpose of the United Nations Climate Change Conference in Copenhagen on Dec. 7-18 is to use global warming hype as a pretext to lay the foundation for a one-world government.

"At [the 2009 United Nations Climate Change Conference in] Copenhagen this December, weeks away, a treaty will be signed," Monkton told a Minnesota Free Market Institute audience on Thursday at Bethel University in St. Paul.

"Your president will sign it. Most of the Third World countries will sign it, because they think they're going to get money out of it. Most of the left-wing regimes from the European Union will rubber stamp it. Virtually nobody won't sign it," he told the audience of some 700 attendees.

"I read that treaty and what it says is this: that a world government is going to be created. The word 'government' actually appears as the first of three purposes of the new entity.

"The second purpose is the transfer of wealth from the countries of the West to Third World countries, in satisfaction of what is called, coyly, 'climate debt' – because we've been burning CO2 and they haven't. We've been screwing up the climate and they haven't. And the third purpose of this new entity, this government is enforcement."

In an hour and a half lecture illustrated by slides featuring scientific data on a wide range of climate issues, Monkton refuted claims made by former Vice President Al Gore in his movie and book entitled "An Inconvenient Truth," as well as scientific arguments made by the United Nations Intergovernmental Panel on Climate Change.

Monckton argued that President Obama will sign the Copenhagen treaty at the December meeting, without seeking a two-thirds ratification of the treaty by the Senate, or any other type of Congressional approval.

"So, thank you, America. You were the beacon of freedom to the world. It is a privilege to stand on this soil of freedom while it is still free," he continued. "But, in the next few weeks, unless you stop it, your president will sign your freedom, your democracy, and your humanity away forever.

"But I think it is here, here in your great nation, which I so love and I so admire – it is here that perhaps, at this eleventh hour, at the fifty-ninth minute and fifty-ninth second, you will rise up and you will stop your president from signing that dreadful treaty, that purposeless treaty. For there is no problem with the climate and, even if there were, an economic treaty does nothing to [help] it."

Monckton is a well-known critic of the theory of anthropogenic causes for global warming who has argued repeatedly that global warming hysteria is an ideological position of the political Left advanced in the

interest of imposing global taxes on the United States in the pursuit of international control of the U.S. economy under a one-world government to be administered by the U.N.

Monckton's lecture can be viewed online and his slides also can be accessed on the Internet.

Where's the global warming?

As evidence mounts that the United States is headed toward a cooling cycle that may last decades, global alarmists within the Obama administration remain resolved to push cap-and-trade legislation through Congress on the increasingly dubious theory that man-made carbon emissions are creating global warming.

In what has to be seen as increasingly bad news for global warming alarmists, scientific evidence is mounting that temperatures in the United States have cooled at a rate that would be projected to lower temperatures 7.3 degrees Fahrenheit over the next century.

Maybe Obama's Science Czar is Right: Is a New Ice Age on the Horizon?

**WND has reported White House science czar John Holdren's prediction that one billion people will die in "carbon-dioxide induced famines" in a coming new ice age by 2020.**

Even though Holdren's current position is that the U.S. needs to enact cap-and-trade to slow global warming, Holdren predicted in a 1971 textbook co-authored with Paul Ehrlich that global over-population was heading the Earth to a new ice age unless the government mandated urgent measures to control population, including the possibility of involuntary birth control measures such as forced sterilization.

Holdren's prediction that one billion people would die from a global cooling "eco-disaster" was announced by Malthusian population alarmist Ehrlich in his 1986 book entitled, "The Machinery of Nature."

Holdren based his prediction on a bizarre theory that human emissions of carbon dioxide would produce a climate catastrophe in which global warming would cause global cooling with a resultant reduction in agricultural production resulting in widespread disaster.

On pages 273-274 of "The Machinery of Nature," Ehrlich explained Holdren's theory by arguing "some localities will probably become colder as the warmer atmosphere drives the climactic engine faster, causing streams of frigid air to move more rapidly away from the poles." (Emphasis in original text.)

The movement of the frigid air from the poles caused by global warming "could reduce agricultural yields for decades or more – a sure recipe for disaster in an increasingly overpopulated world," Ehrlich wrote.

## USDA to unveil “Know Your Farmer, Know Your Food” initiative. By Ken Meter

As I prepare for five days of announcements next week, when USDA plans to unveil its new “Know Your Farmer, Know Your Food” initiative, the buzz across my desk is about the potential for urban agriculture.

EPA reminds that brownfield moneys can be used to convert polluted land into working farms in inner-city areas. I saw the excellent film “The Garden,” documenting the destruction of the largest community farm in the U.S. (South Central LA) in 2006. Will and Erika Allen are coming to Minnesota again. Over breakfast, friends asked about the potential for urban food production.

I think the potential is enormous, especially in formerly industrial cities, where the big factories are not going to come back, but there are large tracts of vacant land that already have water mains (think irrigation) running under them. Each of these cities spends billions of dollars for food, and can generate significant local income by building the farms and distribution channels needed to cycle that food within city borders. We’ll also need to grow new urban farmers, and tap the excellent skills that many new immigrants already have in growing food.

Hoping the USDA will focus next week on turning urban lands into productive farms, I’ve finished revising a brief resource guide for urban agriculture I handed out at the Urban Extension Educators conference when I spoke there in May. Let me know if this is useful, or how to improve it!

Did you know that forty-one percent of all U.S. agricultural commodities are sold from farms in metropolitan counties?

Were you aware that 55% of the money made from producing farm commodities was made in metropolitan areas in 2007 (\$15.7 billion of \$28.7 billion)?

Moreover, Department of Defense studies show that Victory Gardens during World War II produced 40% of all produce consumed by Americans, after two seasons of gardening. This shows the potential for small-scale activity adding up to a big difference.

This is all part of a bigger shift that America, and USDA, are going to need to make—to focus on food, people, and communities, rather than primarily on commodities. That, in fact, is the theme of this year’s Community Food Security Coalition Conference in Des Moines from October 10-13—“From Commodities to Communities.”

## Federal Court Judge Rejects Obama’s attempt to stop Eligibility Case!

Barack Obama is sweating it out after his Department of Justice (“DOJ”) attorneys walked

into court expecting United States Federal District Court Judge David Carter to dismiss the birth certificate case. Why you ask? Simply because they “think” Obama is President. Their arguments were hollow and unconvincing. and after hearing hours of argument, the Judge Carter “took the matter under submission.” He has still not issued a ruling, 10 days later!

## Is The President Above The Law and the Courts? by Gary G. Kreep, USJF.net

DOJ attorneys tried to explain to the Judge that no Court in the United States had the jurisdiction to rule on whether Barack Hussein Obama was eligible to serve as President of the United States? In their view he could only be impeached and/or disqualified from the Office of President under the 25th Amendment to the U. S. Constitution.

NOT TRUE! USJF pointed out to the Court that both the impeachment statutes, and the 25th Amendment required a sitting President, but if Mr. Obama is not eligible to serve as President, he could not be, and never was, a sitting President, so those options for removal could not apply. Therefore the courts would have jurisdiction.

### The Judge raised issues critical to our case:

1. Did Senators question the eligibility of Mr. Obama? (Only Senators Coburn and Shelby and a number of House members.)

2. Were objections made by Members of Congress when the vote of the Electoral College was certified? (NO, then Vice-President Cheney had not performed his required duty of asking for objections, so there could have been none raised.)

DOJ attorneys argued that only Congress, and/or the Electoral College, could decide on the eligibility of Mr. Obama. Fortunately, the USJF legal team filed pleadings pointing out that the DOJ legal arguments in this regard WERE WRONG! And, I was there to argue against those claims.

People at the hearing and those who have found out what happened there since have been contacting USJF, thanking us for standing up for the truth!

But the fight is not over yet! We expect a

ruling from the Court any day now. If we defeat the dismissal motion, then we’re immediately filing pleadings (“discovery”) seeking Mr. Obama’s birth certificate, his college records, and so much more. AND, we’ll be seeking to depose Mr. Obama ASAP!

## Durango Attorney Attempts Supreme Court Investigation of Free Press Publisher/Editor for “practicing law without a license.”

Durango Attorney Arthur Jacobs filed a complaint and investigation request against Jeff Maehr for supposedly practicing law without a license. He filed this complaint, along with photo copies of the Free Press ads for the Law Club meetings and foreclosure information offers.

Mr. Maehr responded to allegations with a 6 page document, to which the Supreme Court answered directly to Mr. Jacobs, denying his request.

The Free Press asks Mr. Jacobs exactly what was his intent on filing this frivolous complaint, and why he would want to stifle free speech and meetings where public information is discussed.

Had Mr. Jacobs taken the time to adequately investigate the meetings and information provided, he could have saved himself some time, not to mention embarrassment, and the Supreme Court’s time.

An interesting issue which became part of the Supreme Court’s initial notice to Mr. Maehr was their violation of two points of law in their own procedures and notice. This was brought to their attention, along with a complaint against Mr. Jacobs for libelous accusations, and attempts to create fear, legally called a “chilling effect,” in club members and the general population in an attempt to stop private citizens from representing themselves.

All Americans are expected to know the laws, and therefore, they certainly have the right to use these laws and do not NEED an attorney who is a ward of the court, and subject to serving the

#### CONGRESS MOVES TO CONTROL ALL U.S. WATER

Conservatives are warning Americans about the ambitions of federal lawmakers to control all waters within the United States including those on private property, in the latest power grab by progressive politicians.

"waters of the United States."

"The US Constitution's Tenth Amendment automatically reserves power for controlling waters to the states, not to the Oval Office and US Congress," said political strategist Mike Baker.

"This is just one more power grab by out-of-control politicians who only adhere to constitutional law when it suits them," he added.

Section 3, Paragraph 8 stipulates that "this Act will treat, as 'waters of the United States', those features that were treated as such pursuant to the regulations of the Environmental Protection Agency and the Corps of Engineers in existence before the dates of the decisions referred to in paragraph (10), including--

(A) all waters which are subject to the ebb and flow of the tide;

(B) all interstate waters, including interstate wetlands;

(C) all other waters, such as intrastate lakes, rivers, streams (including intermittent streams), mudflats, sandflats, wetlands, sloughs, prairie potholes, wet meadows, playa lakes, or natural ponds;

(D) all impoundments of waters of the United States;

(E) tributaries of the aforementioned waters;

(F) the territorial seas;

(G) wetlands adjacent to the aforementioned waters."

After being overruled by the U. S. Supreme Court in two recent decisions that the words "navigable waters" in the Clean Water Act limited federal agencies to regulation of navigable waters only, Democrats and liberal Republicans in Congress are striking back.

They are attempting to pass the Clean Water Restoration Act of 2009 (S 787) that would amend the 1972 Clean Water Act and replace the words "navigable waters" with "waters of the United States."

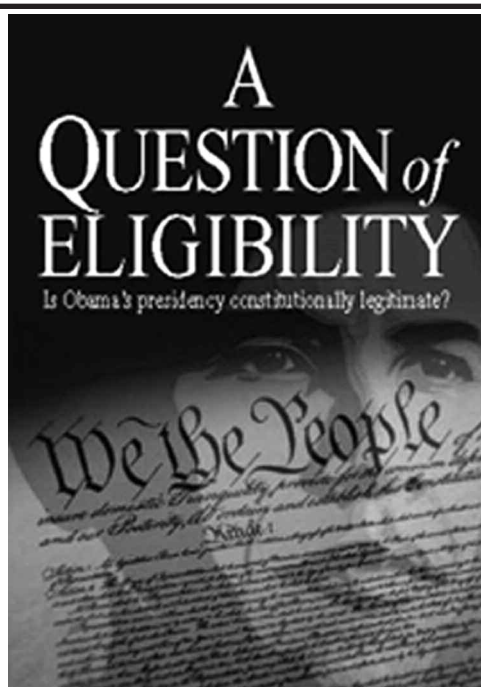

# What Constitutes Proper Courtroom Decorum?

What is the first thing that comes to mind in response to my experience at the Alamosa County Courthouse on Wednesday, September 9. It all started with a piece of property, two rental homes that had changed hands twice in the last ninety days of which my son was the unfortunate tenant. Without going into detail about whether or not the houses were in code -- they weren't. In fact, my son went into an agreement with the original owner to accept the premises as is and do the necessary repairs -- I really don't want to get into the legal ramifications available to the "defendant" -- my son -- that is too long and drawn out to explain here and is not the real point of my concern. But, let's talk about the courts and the mechanics of eviction.

When the third owner of the property raised the rent \$275.00 on both properties neither of which met habitable housing standards, this was the straw that proverbially broke the camel's back. These properties did not meet the "implied warranty of habitability" protection available to all tenants who rent a dwelling. Here is truly a case where the underdog loses, not because he had not been wronged, but merely because he is economically disadvantaged -- without resources. But, I digress.

The issue I would like to address is the "act" that played out in the courtroom. On the one side you have a young man, who has been doing repairs on the two houses, which were clearly out of code for several months. On the other side you have the new owner demanding immediate possession of the two homes.

As I sat in the audience and watched the scene unfold I felt it was very unbalanced and prejudiced from the beginning, but that is simply my opinion. While I have traveled throughout the country and experienced a variance of law from state to state in regards to litigation firsthand, courtroom decorum has remained relatively the same, respect to the court and respect to the litigants. This has always been my experience until I witnessed Judge Michael Gonzalez in action this September morning.

My wife and I were present to give my son moral support in this eviction process due to non-payment of rent, or which there are few defenses. In fact, my son refused to pay the rent until repairs were made under the "implied warranty of inhabitability." It was the defense on which my son stood and one which his honor couldn't be bothered to hear, whether or not my son, the tenant, and defendant in the case, complaints were legitimate or not. It is now left to the Alamosa County Code Enforcement to decide what the judge refused to consider in the courtroom that morning. It is unconscionable to me that a defendant cannot present their case in a courtroom. And while this is alarming to me, as it should be to all citizens of this country, that a defendant in a courtroom not be able to present their defense, the decorum displayed by his honor was also intolerable and unacceptable by the citizens of this county or any county in this country.

During my son's proceedings it became apparent, at least in my mind, that the judge was being biased, favoring the new landowner over a disenfranchised member of our community. I allege this because his honor never allowed my son to present his defense, nor did he view more than forty photographs he had in his possession proving the condition of the dwelling he had been renting and repairing and presently being evicted from.

While this imbalance greatly disturbed me -- what followed disturbed me even more. After the judge refused to consider my son's defense, he told him that he, his wife, and their 18-month old son had to be out of the house in 5 days. My son, believing the hearing had concluded, then stood up and walked out of the proceeding area of the courtroom, and stepped into the spectator area, where I being a spectator held my hand out to stop him and told him to remain until the judge finished talking, giving due respect to the court.

Shortly after I stopped my son, we heard this shrieking echo thunder through the courtroom, only to discover that the source lay in his honor, Judge Michael Gonzalez. I am unclear what had so suddenly transformed his honor, or maybe it wasn't a transformation at

all. Maybe what I was feeling, but uncertain in regard to feeling a bias of the court toward economically disadvantaged citizens were true. That, or a severe case of "black robe disease."

My son, who had not shown any aggression or defiance to the judge or the courts stood frozen as the judge shrieked, "You are really starting to piss me off!" Following that derogatory comment he continued to saturate the courtroom with his high octane venom as he demanded my son to sit down before he had him arrested. I sat there and tried to filter through my mind what "grounds" his honor had and noticed the blank look in my son's eyes, you know the look, like a deer caught in the headlights, followed by the uncertainty of his next act for fear his next act, whatever it might be, would bring him and his family further harm.

I pointed my son to the chair in the gated area as the judge continued his threatening barrage of words. Later, I witnessed and became party to this same vile disregard to law abiding citizens by the court deputy outside the courthouse, which is an obvious sign that his honor's unprofessional behavior spreading like a virus to other court officials that surrounded him

Someone must have forgotten to tell his honor what constitutes proper courtroom decorum. We the People (like it or not) understand that in a courtroom a judge holds ultimate authority. It is not necessary for a judge to scream like a child who is not getting their way. It was a misunderstanding and a simple, calm request for the defendant to return to his seat would have sufficed. This display of uncivilized behavior by his honor was not warranted in this situation and we were later informed that the judge had apologized to the other spectators after we left.

This poses several questions for the public. Was this judge's

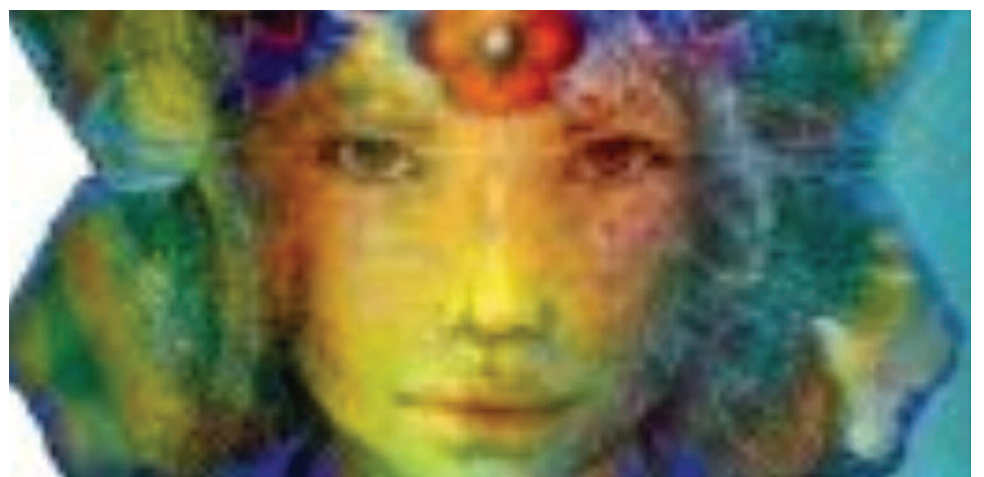

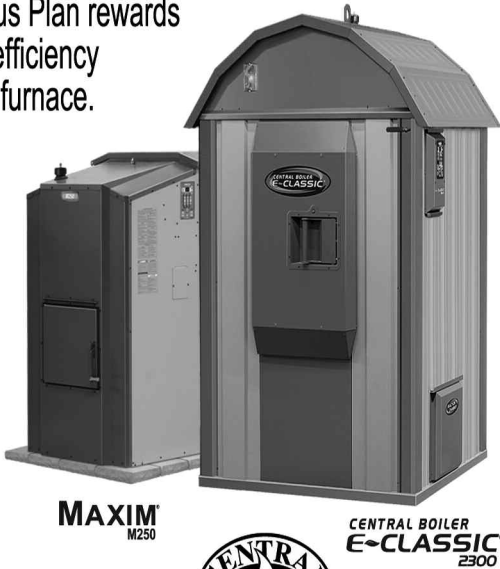

Most every Christian has heard about the “Rapture.” This is a time that the vast majority of Christians believe will occur at the time of the end when all Christians will be removed from Earth to Heaven and escape the tribulation time.

But, does this have actual Biblical backing, and if so, where is it? Let's address the rapture by looking at a number of scriptures that have to be answered that call into question any rapture taking place as many believe.

The first question we need to answer is “when is the rapture supposedly going to take place?”

1Th 4:16 “For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first: 1Th 4:17 Then we which are alive [and] remain shall be caught up together with them in the clouds, to meet the Lord in the air: and so shall we ever be with the Lord.” NKJV

The above 2 verses are the primary scriptures used to support a rapture theory. Of themselves, this simply teaches that the dead in Christ and those still alive who are a part of the true Church will be raised... RESURRECTED to, or changed to, spirit, but it doesn't address “WHEN” this rising into the atmosphere is to take place.

Some make a big to-do about the words translated "shall be caught up" as if these words had some spiritual significance that supports the rapture belief. The words are taken from the Greek - ( to seize (in various applications): - catch (away, up), pluck, pull, take (by force)). This simple means what it says and nothing more... that when the resurrection takes place, we will rise - be brought up to where Christ is... in the clouds. To build a doctrine out of this alone is dangerous.

The second question to ask is, WHERE is the “church” when this "catching up" takes place in the scenario of the end time?

Rev 12:14 “And to the woman were given two wings of a great eagle, that she might fly into the wilderness, into her place, where she is nourished for a time, and times, and half a time, (3 and 1/2 years) from the face of the serpent.

:15 And the serpent cast out of his mouth water as a flood after the woman, that he might cause her to be carried away of the flood.

:16 And the earth helped the woman, and the earth opened her mouth, and swallowed up the flood which the dragon cast out of his mouth.

:17 And the dragon was wroth with the woman, and went to make war with the remnant of her seed, which keep the commandments of God, and have the testimony of Jesus Christ.” NKJV

These scriptures are clearly at the end time, and we see a number of issues being revealed. The woman is clearly the Church of God... God's true people. This church is taken to a place of protection for three and one half years, away from Satan's influence and attacks. The scriptures show that this protection is right here on Earth, and lasts during the tribulation time.

God provides miracles that protect this group of people and this makes Satan angry, after which Satan goes back to make war with... WHAT? The "remnant of her (the Church's) seed which keep the commandments of God, and have the testimony of Jesus Christ." This is obviously still members of the true church, but they have an apparent problem with their relationship with Christ which requires correction. More on that later.

An interesting parallel or type of this can be seen in how God dealt with Pharaoh and ancient Israel. Pharaoh eventually allowed Israel to leave their bondage, led by God, but then Pharaoh changed his mind and sent an army to take Israel back. Pharaoh is a type of Satan who holds the world in bondage to sin. God provides escape for some of His people, and protects them from the people who want to put them back into bondage. God allowed the waters of the Red sea to swallow the army up, just as the "earth" swallows up this "flood" or army, being sent to stop these people of God from escaping.

Rev 6:11 And white robes were given to every one of them; and it was said to them, that they should rest yet for a little season, until their fellowservants also and their brethren, that should be killed as they [were], should be fulfilled. NKJV

The above scripture is symbolic of God's plan for those who were already killed (rest), like many others are going to be killed as they were. This is a clear reference to saints being killed - martyred - during the tribulation time... and NOT protected.

If the “rapture” is real, why are there still Christians being martyred on Earth at the end time?

Next we have to ask, just when does Christ return to this Earth, and where does He return to ON Earth?

Rev 8:6 “And the seven angels which had the seven trumpets prepared themselves to sound. Rev 11:15 And the seventh angel sounded; (last trumpet) and there were great voices in heaven, saying, The kingdoms of this world are become [the kingdoms] of our Lord, and of his Christ; and he shall reign for ever and ever.” NKJV

1Co 15:52 “In a moment, in the twinkling of an eye, at the last trump: for the trumpet shall sound, and the dead shall be raised incorruptible, and we shall be changed. NKJV (Those alive at the resurrection).

When Christ returns, it is at the “last” trump...actually symbolized by the Day of Trumpets, one of God's Holy Days. It is THEN that the resurrection takes place...

Rev 1:7 Behold, he cometh with clouds; and every eye shall see him, and they [also] which pierced him: and all kindreds of the earth shall wail because of him. NKJV

Christ returns to Earth at the sound of the last trumpet, and every eye will see this return. This return is AFTER the tribulation period as Revelation clearly shows, so how can a "rapture" take the saints prior to the last trump?

Christ's return is with an army from heaven, and this is the host that all resurrected and changed saints will join “in the air.” This army will be what fights all the gathered nations at the battle of Armageddon in Israel.

Rev 16:14 “For they are spirits of demons, performing signs, which go out to the kings of the earth and of the whole world, to gather them to the battle of that great day of God Almighty. NKJV

When the resurrection takes place, at Christ's return, all of God's people will join Christ. Where does Christ Himself go after His return? He goes to a specific place...

Zec 14:4 “And his feet shall stand in that day (The last trump - Christ's return to Earth) upon the mount of Olives, which [is] before Jerusalem on the east,”

Notice that when Christ comes to resurrect the saints, and gathers them...

Mark 13:27 “And then shall he send his angels, and shall gather together his elect from the four winds, from the uttermost part of the earth to the uttermost part of heaven.”

... that Christ then goes, that same day, to the Mount of Olives, the very spot where He left His apostles long ago...

Acts 1:9 “Now when He had spoken these

their writings and the writings of those from whom they took wisdom and direction," said officials at ALRA.

"This is a terrible bill that would give the Federal government jurisdiction over anything that is wet including seasonal mud flats. This means that the Feds could enter your property and dictate what you can do with bodies of water on your land," said political strategist Mike Baker.

"It also means that the Great Lake States and Provinces could not protect the Great Lakes from being pumped dry to feed the growth of California and the Southwest. In that area, Democrat Senator Russ Feingold has sold out his own state: Wisconsin."

"Senate Bill 787 will change federal jurisdiction over "navigable" water, to give the federal government control over all water everywhere, in municipal reservoirs, and on private lands, and in private wells. This bill ignores state water law authority and the Fifth Amendment of the U.S. Constitution," stated Barbara H. Peterson, a farm lands protection activist.

"If the Feds own the water, then they can do anything they want to with it, and I have to ask permission to get a drink or water my animals," she stated.

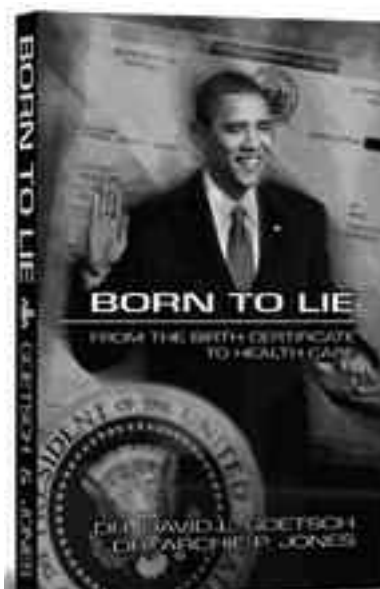

things, while they watched, He was taken up, and a cloud received Him out of their sight. 10 And while they looked steadfastly toward heaven (the sky/atmosphere/clouds) as He went up, behold, two men stood by them in white apparel, 11 who also said, "Men of Galilee, why do you stand gazing up into heaven? This same Jesus, who was taken up from you into heaven, will so come in like manner as you saw Him go into heaven." NKJV

The same type of clouds... the same spot He left from. **Why would a “rapture” take place, taking everyone to heaven, when Christ Himself is staying right here on Earth?** Why is He staying? Because the Kingdom of God has just been ushered in, and He will be King over all the Earth, and those resurrected will be ruling with Him for the next 1000 years...

Rev 5:9 “And have redeemed us to God by Your blood, out of every tribe and tongue and people and nation, 10 And have made us kings and priests to our God; And we shall reign on the earth ." NKJV

These “Saints” are alive on Earth (not raptured) and preaching to the whole world during the tribulation period, and then are resurrected at the same time ALL the saints are resurrected... at the last trump... when the loud voices in heaven are heard and EVERY eye sees Christ return.

Col 1:15 “He is the image of the invisible God, **the firstborn** over all creation. :18 And He is the head of the body, the church, who is the beginning, the firstborn from the dead, that in all things He may have the preeminence. NKJV

Rev 1:4 “Grace to you and peace from Him who is and who was and who is to come, and from the seven Spirits who are before His throne, 5 and from Jesus Christ, the faithful witness, **the firstborn from the dead**, and the ruler over the kings of the earth. NKJV

Christ is the first (and only to date) human to be “born” into the Kingdom of God via His resurrection. No other human has ever been so ‘born’ as Christ, but this will change in the future, when God begins to gather His harvest...

1 Cor 15:20 “But now Christ is risen from the dead, and has become **the firstfruits of those who have fallen asleep**. NKJV

1 Cor 15:23 “But each one in his own order: **Christ the firstfruits**, afterward those who are Christ's at His coming. NKJV

Christ led the way, and we are to follow. Being “born again” will simply be our being born into the family of God.

Think of it this way: When we are conceived in our mother’s womb,

we are alive, and growing, developing... but not yet “born” till we are delivered. In the same way, all true Christians are developing, growing in grace, knowledge, into the stature and fullness of Christ, till we are “born again” in the resurrection, receive our new spirit bodies, and are then spirit beings.

The greatest threat the rapture theory makes is in the hope countless people have who believe that it will occur prior to the tribulation... thinking it will save them from this time period. There “is” protection for a portion of the true church, but it is right here on Earth.

The question, finally, to ask yourself is this: "What will I do if the rapture does NOT occur as I expect?" Will this cause you to lose hope that God is in charge? Will you panic when things fall apart around you and you are not whisked away?

**The greatest issue is not "escaping" tribulation, but drawing close to God so that we may be counted worthy to escape...**

Luke 21:36 Watch therefore, and pray always that you may be counted worthy to escape all these things that will come to pass, and to stand before the Son of Man."

This isn't just saying to "pray that you may be counted worthy..." but to "pray always..." that the results of prayer, and drawing close to God in spiritual understanding, may allow you to escape "all these things" which Christ spoke about. The rapture is a false myth that will not occur as most expect it will. We need to be aware of the truth of Christ's return, and be preparing for it and to rule with Him once here on Earth.

Rev 20:4 “And I saw thrones, and they sat on them, and judgment was committed to them... And they lived and reigned with Christ for a thousand years... but they shall be priests of God and of Christ, and shall reign with Him a thousand years. NKJV

THAT is why no one is raptured to heaven... we have an awesome destiny if we rightly divide the scriptures, draw close to God “in spirit and in truth.” This shouldn’t discourage anyone... it should stir us up, and motivate us to seek God’s truth and will with all our hearts. Remember... there are three classes of people God spends time warning...

1. Matt 25:1 "Then the kingdom of heaven shall be likened to ten virgins who took their lamps and went out to meet the bridegroom. 2 Now five of them were wise, and five were foolish . 3 Those who were foolish took their lamps and took no oil (Holy Spirit) with them, 4 but the wise took oil in their vessels with their lamps.” NKJV

2. Rev 12:16 “And the dragon was enraged with the woman, and he went to make war with the rest of her offspring, who keep the commandments of God and have the testimony of Jesus Christ.” NKJV

3. Rev 3:14 "And to the angel of the church of the Laodiceans write, 'These things says the Amen, the Faithful and True Witness, the Beginning of the creation of God: 15 "I know your works, that you are neither cold nor hot. I could wish you were cold or hot. 16 So then, because you are lukewarm, and neither cold nor hot, I will vomit you out of My mouth. 17 Because you say,'I am rich, have become wealthy, and have need of nothing' — and do not know that you are wretched, miserable, poor, blind, and naked — 18 I counsel you to buy from Me gold refined in the fire, (tribulation period) that you may be rich; and white garments, that you may be clothed, that the shame of your nakedness may not be revealed; and anoint your eyes with eye salve, that you may see. 19 As many as I love, I rebuke and chasten. Therefore be zealous and repent. 20 Behold, I stand at the door and knock. If anyone hears My voice and opens the door, I will come in to him and dine with him, and he with Me. 21 To him who overcomes I will grant to sit with Me on My throne, as I also overcame and sat down with My Father on His throne. NKJV

These three groups are likely one and the same group of people... all being warned multiple times. The rapture theory is a cleaver ploy Satan is using to provide a false sense of security, and therefore, encouragement in letting down our guard... letting up in overcoming and growing. Let’s not get caught by this trap.

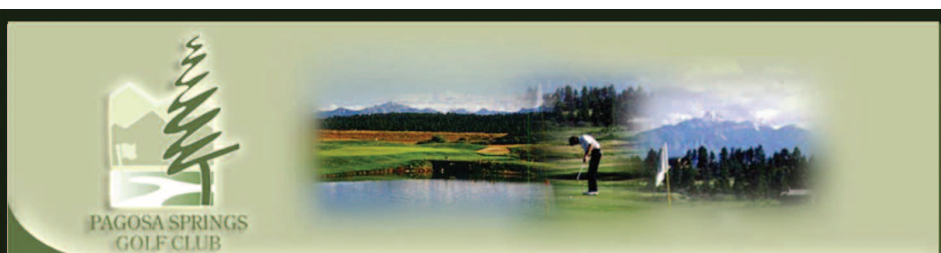

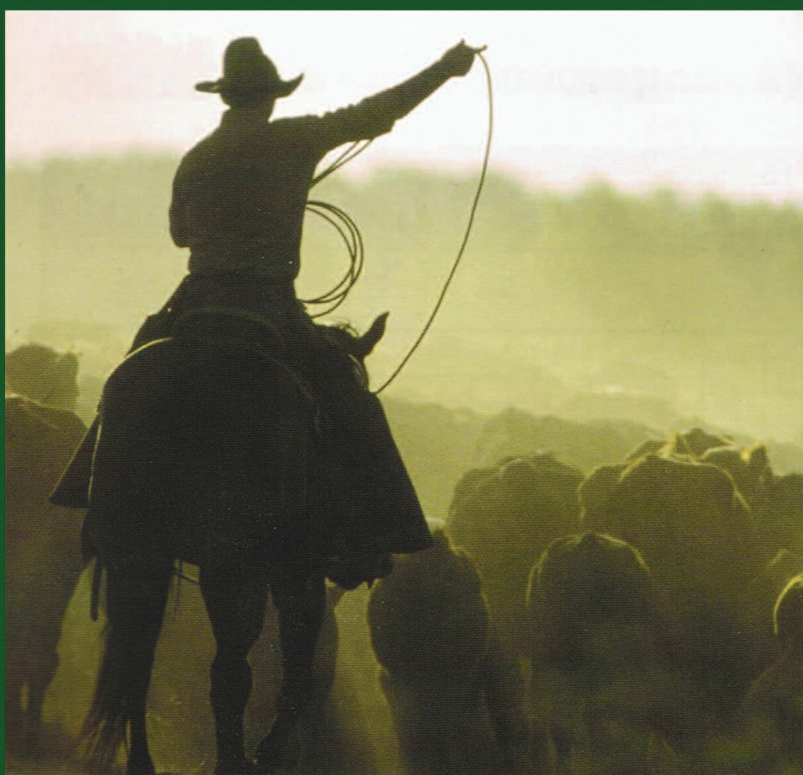
