Lara was then charged with criminal trespass and had to deal with court issues for several months.

#### ON CAPITOL HILL

Stimulus to ban religious worship; 'This isn't like a convenient oversight, this is intentional' By Bob Unruh


President Obama's proposed economic stimulus plan makes a deliberate – and unconstitutional – attempt to censor religious speech and worship on school campuses across the nation, according to a lawyer who argued related cases before the U.S. Supreme Court 20 years ago and won them all.

"This isn't like a convenient oversight. This is intentional. This legislation pokes its finger in the eyes of people who hold religious beliefs," Jay Sekulow, chief of the American Center for Law and Justice, told WND today. His was the organization that decades ago argued on behalf of speech freedom on school campuses, winning repeatedly at the U.S. Supreme Court. Since then, the 2001 Good News Club v. Milford Central School District decision was added, clarifying that restricting religious speech within the context of public shared-use facilities is unconstitutional.

The problem in the proposed stimulus bill comes from a provision that states: "PROHIBITED USES OF FUNDS. - No funds awarded under this section may be used for - (C) modernization, renovation, or repair of facilities - (i) used for sectarian instruction, religious worship, or a school or department of divinity; or (ii) in which a substantial portion of the functions of the facilities are subsumed in a religious mission."

The wording that specifically targets religious speech already has been

#### **Free Press Well Received Despite Rough Start**

Well, despite multiple setbacks, obstacles, errors and surprises, we finally got the first issue out. We are encouraged by all the positive comments and excitement of seeing the paper out again and addressing controversial issues, in various categories. We also appreciate the constructive comments that help us to grow in this project. We had calls within hours of the paper being out that showed it was being dispersed quickly.

This has been a major endeavor with a huge learning curve because we had to start, essentially, from scratch. What have been some of the challenges? First, learning a brand new program that creates the paper. Didn't have any help at all. Second, we were several days away from publishing, and we were notified that the printer didn't carry the old stock size which the Free Press used to be printed on which the layout was created under.

This meant, of course, we had to completely resize every page and article to either a larger size format, or a smaller one. If you haven't noticed, the first Free Press was larger than all previous editions, by 3 inches, top to bottom. This resizing created the obvious empty spaces on some of the pages. The time to take to resize all ads and pictures simply wasn't available. We considered delaying the paper further, but there were time-sensitive ads involved. Talk about frustration.

Another glitch came when the printer printed the wrong file sent to them. They normally print evenings, but they printed several hours earlier, so they did not get the newest file uploaded to their office.

The early printing was due to the bank payment not going through the previous day because of bank rules on sizes of payments in a 24 hour period. This delayed printing for a day, and they were anxious to get the paper done because of other jobs waiting to be printed, so they brought in several workers early to get it out and they missed the newer, updated file.

That week was one of the most stressful in my entire life. However, we survived it, and this edition is much improved. The larger size will accommodate larger ads now, and have more room for additional letters, articles, etc., and larger print size which we've had positive comments on as well, so get to writing.

We certainly appreciate the support in spite of the glitches and errors. It is humbling... and kind of discouraging... when one works so hard to get something out to help others, and there are so many glitches at once. Of

worked on trying to get the data disks, the software program, advertiser information and records, the website domain, etc., and simply didn't get cooperation as we needed. (Ray Baker did help as he could).

We did get some data disks, but nothing else, including the very paper software promised by Rick Baker, and the domain he agreed to transfer. I could go into the actual facts, along with presenting email evidence of the sale of the paper to me, as well as witnesses to the transfer, along with website data showing that the paper was passed on, but I won't. (This evidence is available for anyone to examine).

When it was being claimed, in late January, (Why so long in making any obvious mention of some change of mind?) that Rick was still the owner of the Pagosa Free Press, (making us out to be liars) despite evidence to the contrary, and despite his not returning the agreement sent to him which he requested, (dated October 8, 2008), we decided to simply give Rick the name back and to move forward and not wade into a threatened law suit... (one we'd win hands down by the way for breach of contract).

We had decided this for several reasons: 1. We wanted to take

the high road in this issue and not be bogged down with foolish antics. 2. We wanted to change the name anyway, because we felt the paper was beneficial beyond "Pagosa" and will be welcome by a broader scope of communities.

3. We wanted to distance ourselves from any negative elements associated with the past publication which people remember. Now, mind you, we don't mind a fight for truth and justice, but one must pick their battles, and this one wasn't worth fighting. As we sow, we reap. That can't be escaped, by anyone.

Any legal discussion is for information only and it is up to each of us to research the topics before making any decisions or acting on information within these pages. Any questions on legal issues should be discussed with an attorney, or researched approved by the majority Democrats in the U.S. House – all GOP members opposed it. In the Senate, Jim DeMint, R-S.C., proposed an amendment to eliminate it, but again majority Democrats decided to keep the provision targeting religious instruction and activities. Critics argued schools would accept any money offered, then impose a ban on religious events.

DeMint warned organizations such as the Fellowship of Christian Athletes, Campus Crusade for Christ, Catholic Student Ministries, Hillel and other religious groups would face new bans on access to public facilities that would not apply to other organizations.

"This is a direct attack on students of faith, and I'm outraged Democrats are using an economic stimulus bill to promote discrimination," DeMint said. "Democrats should be ashamed of themselves for siding with the ACLU over millions of students of faith."

DeMint's comments have been posted online and also are embedded here:

"These students simply want equal access to public facilities, which is their constitutional right. This hostility toward religion must end. Those who voted to for this discrimination are standing in the schoolhouse door to deny people of faith from entering any campus building renovated by this bill," said DeMint.

The senator said the stimulus bill now becomes an "ACLU stimulus" that has the goal of triggering lawsuits "designed to intimidate religious organizations across the nation."

"This language is so vague, it's not clear if students can even pray in a dorm room renovated with this funding since that is a form of 'religious worship.' If this provision remains in the bill, it will have a chilling effect on students of faith in America," he said.

DeMint cited Obama's statement at the National Prayer Breakfast this week that faith "can promote a greater good for all of us. This provision is an assault against both. It's un-American and it's unconstitutional. Intolerant and it's intolerable," DeMint said. The ban on religious organizations is linked to the \$3.5 billion intended for "renovation of public or private college and university facilities."

The ACLJ, (American Center for Law and Justice) which focuses on constitutional law, said the provision "has nothing to do with economic stimulus and everything to do with religious discrimination."

"The thing is I litigated these cases on these exact issues 20 years ago," Sekulow told WND. "Not only did we win, two of the decisions were unanimous and the other was 8-1.

"We're seeing a rollback to the 1970s regarding church-state relations," he said. "That's what is troubling. It is a complete rollback that now institutionalizes discrimination through targeting religion."

Sekulow said he already is drafting a complaint that will challenge the constitutionality of the provision, to be used if it isn't removed. He said under current court precedents, it will be a open-and-shut victory. However, he also warned that the problem is the damage that can be done within the probable four years it would take to get the issue to the U.S. Supreme Court and what that court would look like at that point. Under Obama, he said, "there will be an ideology shift." New appointments to the bench by Obama, he said, would be "much more left of where Justices (Ruth Bader) Ginsburg and (Stephen) Breyer are."

### Draft & Involuntary Service in America?

#### "National Service" and Conscription: A Question of Ownership

Government - mandated "community service" is integral to Barack Obama's vision of "change." Obama has described such service as a key element of creating "a new era of responsibility -- a recognition on the part of every American that we have duties to ourselves, our nation and the world; duties that we do not grudgingly accept, but rather seize gladly, firm in the knowledge that there is nothing so satisfying to the spirit, so defining of our character than giving our all to a difficult task."

Actually, there is nothing novel about Obama's emphasis on government-imposed citizen "service." National service, in some form, has been endorsed by every U.S. president since George Bush the Elder. But none has promoted it as insistently as Barack Obama.

Of course, most Americans are hardly strangers to responsibility. They hold jobs, provide for families, and perform volunteer work for schools and churches. Thousands of acts of service occur literally every second of every day in America, both in the form of mutually beneficial business transactions and charitable deeds performed out of conviction.

The problem with such service, apparently, is that it is neither mandated nor brokered by the government. So from the perspective of those who believe that life should be organized by the state, such spontaneous service simply doesn't count.

Before it created a small but significant scandal, the Obama campaign's position paper on national service promised that as president he would "inspire" Americans to render "universal

voluntary service."

It was not explained how service could be both "universal" and truly "voluntary": Was the assumption that differences over opinion regarding the proper type of "service" would simply vanish? Or would the reluctance of many Americans to surrender valuable time to carry out government-approved activities be overcome by the sheer power of Obama's charisma?

Obama's vision of "Universal Voluntary Service," as originally outlined in his campaign literature, displayed far greater ambition and more than a touch of authoritarianism: "Obama will call on citizens of all ages to serve America, by developing a plan to require 50 hours of community service in middle school and high school and 100 hours of community service in college every year." The blueprint likewise called for the

expansion of AmeriCorps from 75,000 to 250,000 and the creation of five separate "Corps" of government-funded "volunteers" to deal with education, health, energy, veterans affairs, and homeland security.

One element of the Obama plan, the "Classroom Corps," employed frankly militaristic language, stating that the administration would "enlist" retired teachers, "recruit" civic leaders, and "draft" parents, grandparents, and others to serve as mentors.

The campaign for "universal voluntary service" is bipartisan and enjoys enthusiastic support from the mainstream media. Richard Stengel, Time magazine's managing editor, is co-chair of Service Nation, a non-profit established to promote Obama's service campaign. Former GOP presidential candidate John McCain has joined with Obama in promoting government-imposed service.

Tony Blankley, who served as chief of staff for former House Speaker Newt Gingrich, has called in his new book American Grit for the reintroduction of a universal military draft

Blankley's proposed system is similar to legislation being promoted by House Democrat Charles Rangel; it would require all Americans who turn 18 to spend two years either in military service or in a governmentselected "Homeland Security" role. He proposes a "compulsory program for all Americans aged eighteen or nineteen, men and women, after most have graduated from high school. The military, reviewing these graduates' transcripts, extracurricular activities, medical reports, would select however many they needed to fulfill their draft allotments for a two-year period of military service. Those not chosen by the military would undertake a two-year service obligation.'

Setting a tone likely to be emulated by other Republicans, Blankley condemns Obama's national service proposal not because it represents a presumptuous imposition on the lives of Americans, but because it wouldn't provide soldiers for ongoing and envisioned military conflicts.

"We will soon be faced with the choice of severely scaling back our role in the world or expanding the army through conscription," observes Blankley, blithely assuming that the former option is simply inadmissible. Since "there is a limit to the number of people willing to volunteer to be a soldier," the government must return to a system its critics consider nothing less than military slavery.

All "national service" proposals, whether civilian or military, are rooted in the assumption that individuals owe service to the State -- indeed, that the State has the first claim on the individual's time, labor, and wealth.

Although the legally protected practice of chattel slavery ended roughly a century and a half ago, politicians routinely insist that the government is entitled to claim uncompensated labor from the citizenry in the name of "community" or "national" service.

The first American public figure of significant stature to endorse this concept was philosopher and psychologist William James, who in 1910 urged "a conscription of the whole youthful population. . . for a certain number of years as part of the army enlisted against Nature." James envisioned a national system of conscript labor to build roads and bridges, skyscrapers and tunnels; to extract ore from the ground, and fish from the sea; and to do various other kinds of manual labor as a way of having "the childishness knocked out of them."

Military conscription, which is the most severe form of "national service," is based on the idea that the people exist to protect the government.

Through government-imposed labor, James insisted, young men "would have paid their blood-tax" to the amorphous entity called "society" without serving in the military. In fact, it was through this proposal for universal conscription that James infected American political discourse with the phrase "moral equivalent of war," an expression that has become one of our more obnoxious cliche's.

William James was not the first or only one to propose universal conscription. The eighth plank of the Communist Manifesto dictates a "universal liability of all to labor" as the state directs, and the creation of state-supervised "industrial armies."

After seizing power in Russia through the Bolshevik coup, Vladimir Lenin demanded that his subjects consider themselves part of a "great army of free labor" to be deployed as the ruling oligarchy saw fit: "The generation that is now 15 years old... must arrange all the tasks of their education in such a way that every day, in every city, the young people shall engage in the practical solution of the problem of common labor, even the smallest, most simple kind."

Undergirding such grand pronouncements is the shared assumption that only labor or "service" that is mandated and supervised by the state is worthwhile. Left to attend to their own business, human beings have an amazing capacity to serve each other in mutually beneficial ways.

But this is done without the intrusive and presumptuous involvement of social engineers who desire to correct what they see as defects in the way other people live. For such people "service" is simply unsatisfactory unless it somehow helps build and fortify the state. And to them the state of crisis produced by a war, or the "moral equivalent" thereof, is useful as a pretext for the regimentation of society.

This is why aspiring social engineers welcomed the onset of World War I, which offered unprecedented opportunities for government intervention in private life.

During World War I, Bernard Baruch, chairman of the Wilson administration's War Industries Board, brazenly endorsed the concept of state ownership of every American:

"Every man's life is at the call of the nation and so must be every man's property. We are living today in a highly organized state of socialism. The state is all; the individual is of importance only as he contributes to the welfare of the state. His property is his only as the state does not need it. He must hold his life and possessions at the call of the state."

Baruch insisted that this form of human bondage -- that is, the ownership of one person by another -- was not prohibited by the 13th Amendment, since "involuntary service for a private master is and has been clearly and repeatedly defined by the Supreme Court as slavery." This isn't the case, he insisted, regarding the military draft of conscripted labor, since in those arrangements there "is but one master. . . and that master is America."

In its decision in the 1918 Selective Draft Cases, the Supreme Court took a very similar approach to the 13th Amendment in dealing with the World War I military draft: Grandly describing compelled military service as "the supreme and noble duty" of a citizen, the High Court simply insisted that the amendment didn't apply.

The common understanding is that government exists to protect the lives and individual rights of citizens. Military conscription, which is the most severe form of "national service," is based on the idea that the people exist to protect the government. This principle was given voice in a July 1863 editorial supporting the draft in which the New York Times claimed that "our national authority has the right -- to every dollar and every right arm for its protection" (emphasis added).

In any form, governmentcompelled "service" is an assertion of state ownership of the individual, and a violation of the most fundamental property right -- selfownership. In the Western tradition of individual liberty under law, no other human being, individually or acting as part of a collective, can properly claim ownership over any part of our lives, or the product of our exertions, without our consent. That consent can be expressed through contract, commerce, covenant, or charity. It cannot properly be obtained through coercion or fraud.

Thomas Jefferson, in a letter written to John Adams during the

## Phone Scam Hits Local Business!

The Free Press received a call from a local business owner regarding a strange call she recently received to her business. Cris Powe, who owns "Christine's Cuisine," a local catering service, received a call from a supposedly "deaf" person who was using a translation service to communicate to Cris. The caller requested 150 chicken salad sandwiches. Because of the translation difficulty, the caller switched to emailing Chris.

He stated he would send his shipper to pick the sandwiches up, and requested that Chris pay his shipper \$1480 for the shipping and cost of the sandwiches, and that he would provide her his credit card to pay her back. (Duh)

Of course, Cris realized this was an idiotic request, and told him no, after which he was no longer interested in the sandwiches. Cris happened to mention this event to a friend, Bob Goetzinger, who, appropriately 6 months ago, was selling beagle puppies. He received a phone call from a "deaf" man through a translator service requesting a puppy be shipped to

him. This caller wanted to pay Bob with a check for \$1500 and requested Bob send him, along with the puppy, the balance of \$1200, in cash. Needless to say, this, too, was rejected by Bob as an obvious attempt to rip him off.

This sort of scam has been going on for years across America. This author had this attempt several times in his own business, and reported it to the FBI. Scams such as these usually involve requests for large orders of some kind to be shipped to some destination, oftentimes International, and the offer to pay with a credit card, which in most cases, is stolen. These two examples are almost childish in their expectations of grown adults but these people play the odds.

If such a call comes, it would be good to obtain as much information as you can on the caller, his or her contact information, and when they provide a credit card for something that isn't as ridiculous as the two examples above, contact the credit card company immediately and check to see whether this card has been reported stolen, and notify Police.

Freedom From Government

President Obama signed an executive order last week continuing the faith-based initiatives program created by former President Bush. When the program was created, I warned that giving taxpayer money to private religious organizations would eventually lead to political control and manipulation of them. This week has provided some evidence that this was a justified concern.

The logic behind funding faithbased initiatives seemed reasonable to some. Private organizations are much more effective in charitable endeavors than government programs and bureaucracies. Therefore, why not "outsource" some of the government's welfare-state activities to these worthy organizations? This appealed to many conservatives, especially after the follow-up executive order exempting recipients from discriminatory hiring laws, which assured many that taking federal funds would not jeopardize their control over their own operations. But beware the government program started under an administration you like, for it may look a lot different under the one you don't. Exemptions that Bush gave, Obama can take away.

But now, dependencies on federal money have been set, operations have been expanded accordingly, and many charities are waiting breathlessly for the administration to tell them what new conditions they will have to meet. With the stroke of a pen, religious charities might not be able to take into consideration a job applicant's faith, sexual orientation or lifestyle if they wish to remain eligible for that taxpayer money that was so enticing a few years ago. Similarly, if FOCA (Freedom of Choice Act) is passed, will Catholic Church hospitals be forced to offer abortion services to retain their federal funding? Can they

remain solvent without it?

This is the major problem with basing a private business model on the receipt of government funds. This money does not come without control, or the future possibility of control. We are seeing parallel control grabs in industries that have recently been the recipients of taxpayer largess. Government officials are now discussing executive compensation on Wall Street, banking, and in the auto industry. How much is too much to pay someone? When is a bonus deserved? But because politicians have bought their way into these industries, these are now political decisions. It is easy to utilize class envy to whip up public support for these interventions, but government always slides down the slippery slope. Politicians are also discussing other aspects of these businesses in which they are not expert, such as, what should lending standards be? What sort of cars should we direct the auto industry to make? Once government money infiltrates a balance sheet, "taxpayers" meaning "politicians" have a say in how you operate.

Money is the Trojan horse that government uses to infiltrate and infect organizations. Funding that, on the outset, is designed to strengthen and support, will bureaucratize and regulate in the end. It is sad to see charities now having reason to focus on lobbying, regulatory compliance and paper pushing to get and retain money taken by force, rather than beefing up private, voluntary fundraising activities. Truth Attack is a coalition of Freedom Movement organizations, including tax honesty movement groups, constitution-oriented groups and a number of veterans' groups who share an interest in restoring a constitutionally limited federal republic. It is determined to unify the freedom movement, focusing resources on one issue, "one tentacle", at a time. The first tentacle is what Truth Attack cites as the biggest fraud perpetrated in the history of man-kind, what it claims is the illicit application of the income tax to American citizens and families.

According to Truth Attack and many others, including the United States Supreme Court, all Americans have a fundamental, constitutionally protected right to earn a living through their own labor. The exercise of a fundamental right is, also according to Truth Attack and the Supreme Court, constitutionally exempt from taxation. Cryer points out that "The power to tax is the power to destroy. If Congress can tax our rights, it can destroy our rights. What is next? A tax on going to church? A tax on free speech?"

Truth Attack also has thousands of members, Truth Troopers, located in all fifty states. In what Truth Attack calls "Operation Stop Thief!" Truth Troopers, joined by thousands from across the spectrum of the Freedom Movement, assembled in front of more than 700 post offices on April 15 last year, handing out information to over a half million last minute tax return filers. OST II is scheduled to be repeated this April 15 and Truth Attack hopes to double the number of post offices covered.

Cryer is quick to point out that the ripples, the ill effects of the income tax, don't stop with the economic crippling of the American family and the States, "It has been proven beyond any doubt that the burden of the income tax is directly related to crime rates, divorce rates, frequency of child abuse and even teen pregnancy rates." Cryer cites a comprehensive study, Income Tax Causes Crime, that Cryer says "leaves no room for doubt that suspending the illicit application of the income tax to working American families will relieve the stresses causing and aggravating those social ills."

"President Obama claims he wants to help what he calls the 'ordinary' people as well as the 'prominent' people. This is his chance to prove that he serves both 'classes' of citizens, both the American aristocracy like the owners of the Federal Reserve and big business and peasants like the rest of us," Cryer concluded.

#### 911 - Unanswered Questions

How many World Trade Center buildings collapsed on September 11th, 2001? Two, you say! Would you believe three?

WTC building seven imploded roughly two hours after the second WTC tower had collapsed. You can see video news coverage of the event

http://www.youtube.com/watch?v=Nv x904dAw0o . WTC building seven was setting outside the World Center complex between two other buildings not belonging to the complex. Bldg 7 folded in the center and collapsed in classic demolitions fashion in approximately 6.5 seconds, which is near free fall speed, without damaging the buildings on either side.

The 911 commission reported that fires started by debris from the collapsing towers had caused its implosion. This was only the third steel structured building in the history of steel structured buildings, both before and since 911, reported to have collapsed from fire. The other two were the WTC towers.

This should cause one to take a closer look at the demise of the two WTC towers. Each tower completely collapsed in around 10 seconds – again, near free fall speed. This implies that the hundreds of interior and exterior steel columns of the two towers offered no more resistance to the descending tops than thin air.

The tops of the towers had completely disintegrated before they

had collapsed to the half way point yet the collapse continued, accelerating as if through thin air, until the fall was complete. Does that seem logical to you? Indeed the laws of physics were surely miraculously relaxed that infamous day.

The WTC towers were known as buildings 1 and 2. WTC buildings 3,4,5, and 6, which set inside the WTC complex, were stripped of their exterior coverings by tons of falling debris and gutted by fires, yet these steel structures remained standing and had to be taken down by demolitions during the clean up. WTC building 7, which set outside the complex and was pelted by debris as were the buildings on either side of it, completely collapsed. I say once again, building 7 and the two towers collapsed at near free fall speed. The only buildings that were destroyed that day all belonged to the World Trade Center complex. Again I ask, "does this seem logical to you?"

DESPITE ACTIONS OF POLICE AND LOCAL COURTS, HIGHER COURTS HAVE RULED THAT AMERICAN CITIZENS HAVE A RIGHT TO TRAVEL WITHOUT STATE PERMITS. By Officer Jack McLamb (Retired) Aid & Abet News.

For years professionals within the criminal justice system have acted on the belief that traveling by motor vehicle was a privilege that was given to a citizen only after approval by their state government in the form of a permit or license to drive. In other words, the individual must be granted the privilege before his use of the state highways was considered legal. Legislators, police officers, and court officials are becoming aware that there are court decisions that disprove the belief that driving is a privilege and therefore requires government approval in the form of a license. Presented here are some of these cases:

CASE #1: "The use of the highway for the purpose of travel and transportation is not a mere privilege, but a common fundamental right of which the public and individuals cannot rightfully be deprived." Chicago Motor Coach v. Chicago, 169 NE 221.

CASE #2: "The right of the citizen to travel upon the public highways and to transport his property thereon, either by carriage or by automobile, is not a mere privilege which a city may prohibit or permit at will, but a common law right which he has under the right to life, liberty, and the pursuit of happiness." Thompson v. Smith, 154 SE 579.

It could not be stated more directly or conclusively that citizens of the states have a common law right to travel, without approval or restriction (license), and that this right is protected under the U.S Constitution.

CASE #3: "The right to travel is a part of the liberty of which the citizen cannot be deprived without due process of law under the Fifth Amendment." Kent v. Dulles, 357 US 116, 125.

CASE #4: "The right to travel is a well-established common right that does not owe its existence to the federal government. It is recognized by the courts as a natural right." Schactman v. Dulles 96 App DC 287, 225 F2d 938, at 941.

As hard as it is for those of us in law enforcement to believe, there is no room for speculation in these court decisions. American citizens do indeed have the inalienable right to use the roadways unrestricted in any manner as long as they are not damaging or violating property or rights of others. Government -- in requiring the people to obtain drivers licenses, and accepting vehicle inspections and DUI/DWI roadblocks without question -- is restricting, and therefore violating, the people's common law right to travel.

Is this a new legal interpretation on this subject? Apparently not. This means that the beliefs and opinions our state legislators, the courts, and those in law enforcement have acted upon for years have been in error. Researchers armed with actual facts state that case law is overwhelming in determining that to restrict the movement of the individual in the free exercise of his right to travel is a serious breach of those freedoms secured by the U.S. Constitution and most state constitutions. That means it is unlawful. The revelation that the American citizen has always had the inalienable right to travel raises profound questions for those who are involved in making and enforcing state laws. The first of such questions may very well be this: If the states have been enforcing laws that are unconstitutional on their face, it would seem that there must be some way that a state can legally put restrictions -- such as licensing requirements, mandatory insurance, vehicle registration, vehicle inspections to name just a few -- on a citizen's constitutionally protected rights. Is that so?

For the answer, let us look, once again, to the U.S. courts for a determination of this very issue. In Hertado v. California, 110 US 516, the U.S Supreme Court states very plainly:

"The state cannot diminish rights of the people." And in Bennett v. Boggs, 1 Baldw 60, "Statutes that violate the plain and obvious principles of common right and common reason are null and void."

Would we not say that these judicial decisions are straight to the point -- that there is no lawful method for government to put restrictions or limitations on rights belonging to the people? Other cases are even more straight forward:

"The assertion of federal rights, when plainly and reasonably made, is not to be defeated under the name of local practice." Davis v. Wechsler, 263 US 22, at 24

no rule making or legislation which would abrogate them." Miranda v. Arizona, 384 US 436, 491.

"The claim and exercise of a constitutional right cannot be converted into a crime." Miller v. US, 230 F 486, at 489.

There can be no sanction or penalty imposed upon one because of this exercise of constitutional rights." Sherer v. Cullen, 481 F 946

We could go on, quoting court decision after court decision; however, the Constitution itself answers our question - Can a government legally put restrictions on the rights of the American people at anytime, for any reason? The answer is found in Article Six of the U.S. Constitution:

"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof;...shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or laws of any State to the Contrary not one word withstanding."

In the same Article, it says just who within our government that is bound by this Supreme Law:

"The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution..."

Here's an interesting question. Is ignorance of these laws an excuse for such acts by officials? If we are to follow the letter of the law, (as we are sworn to do), this places officials who involve themselves in such unlawful acts in an unfavorable legal situation. For it is a felony and federal crime to violate or deprive citizens of their constitutionally protected rights. Our system of law dictates that there are only two ways to legally remove a right belonging to the people. These are:

-by lawfully amending the constitution,

-or by a person knowingly waiving a particular right.

Some of the confusion on our present system has arisen because many millions of people have waived their right to travel unrestricted and volunteered into the jurisdiction of the state. Those who have knowingly given up these rights are now legally regulated by state law and must acquire the proper permits and registrations. There are basically two groups of people in this category:

1. Citizens who involve themselves in commerce upon the highways of the state. Here is what the courts have said about this: "...For while a citizen has the right to travel upon the public highways and to transport his property thereon, that right does not extend to the use of the

highways...as a place for private gain. For the latter purpose, no person has a vested right to use the highways of this state, but it is a privilege... which the (state) may grant or withhold at its discretion..." State v. Johnson, 245 P 1073. There are many court cases that confirm and point out the difference between the right of the citizen to travel and a government privilege and there are numerous other court decisions that spell out the jurisdiction issue in these two distinctly different activities. However, because of space restrictions, we will leave it to officers to research it further for themselves.

2. The second group of citizens that is legally under the jurisdiction of the state are those citizens who have voluntarily and knowingly waived their right to travel unregulated and unrestricted by requesting placement under such jurisdiction through the acquisition of a state driver's license, vehicle registration, mandatory insurance, etc. (In other words, by contract.) We should remember what makes this legal and not a violation of the common law right to travel is that they knowingly volunteer by contract to waive their rights. If they were forced, coerced or unknowingly placed under the state's powers, the courts have said it is a clear violation of their rights. This in itself raises a very interesting question. What percentage of the people in each state have applied for and received licenses, registrations and obtained insurance after erroneously being advised by their government that it was mandatory?

Many of our courts, attorneys and police officials are just becoming informed about this important issue and the difference between privileges and rights. We can assume that the majority of those Americans carrying state licenses and vehicle registrations have no knowledge of the rights they waived in obeying laws such as these that the U.S. Constitution clearly states are unlawful, i.e. laws of no effect - laws that are not laws at all. An area of serious consideration for every police officer is to understand that the most important law in our land which he has taken an oath to protect, defend, and enforce, is not state laws and city or county ordinances, but the law that supersedes all other laws -- the U.S. Constitution. If laws in a particular state or local community conflict with the supreme law of our nation, there is no question that the officer's duty is to uphold the U.S. Constitution.

Every police officer should keep the following U.S. court ruling -- discussed earlier -- in mind before issuing citations concerning licensing, registration, and insurance: "The claim and exercise of a constitutional right cannot be converted into a crime." Miller v. US, 230 F 486, 489.

and the ramifications are far more serious. Are we so complacent, so apathetic, so comfortable, or at least so willing to sacrifice our money, our freedoms, our rights, and remain ignorant and uninvolved with our own future? This happened to Germany, it happens across the world and it is happening to America today.

We are in a war for our very lives and

futures. If we scoff at this, we are not paying attention. If we trust government to "save us," we are greatly deceived, because NO government in history has ever "saved" their population when it was the very government that was the enemy. Evans states, "After a great deal of research, I have determined there is sufficient legal grounds for me - and for other sheriffs - to halt mortgage foreclosure sales. I cannot in clear conscience allow one more family to be put out of their home until I am satisfied they have been afforded every option they are entitled to under the law to avoid foreclosure."

Evans goes on to say, "For most people, their home is the greatest investment they will make in life. They have taken a big risk on behalf of

Any local sheriff has the power to see that citizens are protected from court proceedings that do NOT provide legal evidence in support of a foreclosure, judges notwithstanding. Challenging all foreclosures in court with simple demands for the proper documentation (actual signed papers) from the mortgage company can make all the difference in the world. In addition to this, anyone purchasing illegally foreclosed properties can be liable indefinitely because there is no statute of limitations on fraud, so if you are purchasing, or have purchased a foreclosed property, it would do you great service to be sure that the process was legal and was not involving fraud. You might have it back on you in the future. The Pagosa Law Club (See page 16) will be teaching about this topic among other important and helpful issues!

case. She happened to mention that one of the supposed witnesses who testified that Lara was in the business, when in fact she wasn't, was bribed by Paul Debock and was witness to this. When Lara told the judge that day, he postponed the hearing even though they had several hours of time left to resolve this... Seems this threw them a curve ball.

Once the evidence was collected, and the bribery witness confessed, all charges were dropped against Lara, and a warrant was issued for the arrest of Paul Debock, who was then in California. Extradition brought him back to Pagosa February 7th and on February 10th he was released on bail bond, and allowed to go back to California to obtain his personal possessions.

Lara presently has a case against Ensignal (due to Mr. Paul Debock's actions) for sexual harassment, discrimination and retaliation and the Equal Employment Opportunity Commission has filed charges on her behalf. Stay tuned for the whole story!



## Foreclosure Defense:

Second, these companies often sell this note to other banks or mortgage companies, who sell them again, and often hundreds of these security documents are bundled together and sold to even others who all have a hand in the pie.

Sometimes the funds involved in these continuing sales can be actual private investors who have no idea the risks they are taking in this scam.

The problem stems from what is called "contract law." Under any contract you are personally involved in (and you are involved in "contracts" in far more ways than you could imagine but don't realize it), you have specific rights. One of these is to know ALL the facts involved with the contract you are signing. This includes what is called "consideration."

"Consideration" is the element of "just where is the money I'm borrowing coming from... what is the actual source of this supposed "loan." There is a legal duty on the part of the banks and loan companies to disclose this and any other element pertinent to a contract. If it is not disclosed, this is fraud which essentially nullifies the contract.

economic house of cards. So, when these companies sell these loans, the actual paperwork is transferred through countless hands, and in a vast majority of the cases, they have no idea where the actual loan documents reside. This means that if they cannot produce the actual, unaltered security document with your signature, they cannot claim to be the "holder in due course" of that note and the legal recipient of your monthly payments.

I answered, "no." He then continued: "Well, what were you doing in Mrs. Sease's house tonight?" I replied that I did not know Mrs. Sease, nor had I ever been in her house. Said he: "Well, one of our men swears he saw you go in there."

At this I jumped off the bench and with my hand on old Colt's 45, demanded that he show me the dirty whelp that would tell such a lie on me.

And that if he said it to my face, one of us would have to die. I said this in a loud angry tone so that the mob in the hall could hear me.

Gordon said: "I believe, Anderson, you are telling the truth. But keep cool, and I'll put you face to face with the man."

We then walked into the hall and Gordon called the young man. As he stepped up I asked if he had lied about me. The result was the poor fellow weakened and said he could have been mistaken, but the man who entered Mrs. Sease's looked like me, but it being dark, he might have been mistaken.

That settled it for the night, but next day the mob became drunk and unruly and were determined to hang me as a spy. It would require too much space to give the details. The result was that through hard lying I saved my neck and was promoted. Sheriff Dyke made me one of his special deputies at \$4.00 a day, as long as I could remain.

This money came in handy and it was all "velvet," that is, belonged to me individually. Two days later, after being appointed deputy sheriff, I saved the lives of the county commissioners, the county judge and Attorney Russell, who, by the way, has since served as district judge of that district, and at the present writing, so I am told, is still an honored citizen of that county.

A plot had been planned for both sides to stack all the fire arms and leave two men from each side to guard them. Then a meeting of the commissioners could sit in the court house. The scheme was to have some rifles cached and make a raid on the fire arms and their guards.

Then the slaughter was to begin. All the county officials with the exception of Bendito Martinez had agreed to the plan. All were trying to get Martinez's consent. He finally caught my eye and I shook my head-as much as to say don't do it. That settled it. He stood pat and the plot fell through. I have heard it said that a Mexican can't take a hint, but Martinez

caught a hint in a very light shake of my head. Poor fellow, he soon afterwards shot a man dead in the Durango court room, which broke him up financially, though I hear he is getting on his feet again.

After holding the county officials and their armed escort at bay for about four days, peace was declared by the leaders of the revolutionists being promised an even division of the political pie in future. Then the commissioners held their meeting and all departed for New Mexico.

The blood of the insurgents had cooled off as the liquors in Bowland's saloon diminished, hence peace was declared under a flag of truce--a woman's white apron.

For the next six weeks I had nothing to do but play outlaw and eat Mrs. Taylor's good cooking. Whenever suspicious strangers appeared in town Sheriff Dyke would have me keep hid out until he could learn their business, for fear they might be Texas officers on my trail.

Poor fellow, he soon afterwards shot a man dead in the Durango court room, which broke him up financially

Often I would be the sole occupant of the Taylor residence and at such times I would read Mr. Taylor's private political letters. His old love letters would be laid to one side. I had secured a key that fitted his private desk.

There were piles of political letters and receipts for votes bought during past elections. The ruling price of votes was two dollars in cash or one sheep. Most of the interesting political letters were from Billy Adams, brother of the twice governor of Colorado, Alva Adams.

From these letters I learned many new lessons in up-todate western politics. I appeared before the grand jury in the adjoining county of La Plata, at Durango, the judge of the court being Chas. D. Hayt, and the prosecuting attorney, G. T.

Summer, with the result that sixteen of the leaders in the uprising were indicted. I then disposed of my horse and saddle and "sneaked" to an eastbound train for Denver.

I had been on the operation about two months and during that time I dared not write reports or letters to my wife, nor receive mail from Denver, as the postoffice at Pagosa Springs was in the hands of the insurgents. I had used the name of Chas. Anderson on this

operation.

Arriving in Denver. I was hurried away to the Republic of Mexico to run down an A., T. & S. F. Ry. brakeman who had stolen \$10,000 from the Wells-Fargo Express Company at La Junta, Colorado, during the excitement of a train wreck.

A ride of 700 miles on the Atchison, Topeka & Santa Fe Railway brought me to El Paso, Texas, and another 1,200 miles on the Mexican Central Railway brought me to the City of Mexico.

On arriving there the first thing I did was to write a nice letter to my friend Taylor in Pagosa Springs, telling him that I had got a telegram from my brother in Texas warning me to skip, as the grand jury had found a true bill against me for murder, and that I intended to remain in the City of Mexico a month or so until my brother could get money to me; then I was going to lose myself in the wilds of South America.

My address in the City of Mexico under a new assumed name was given to Mr. Taylor, and in the course of three weeks I received a nice long letter from him. He told me that the grand jury in Colorado had indicted him, Sheriff Dyke and fourteen of the other leaders, for running the county officials out of Archuleta county and burning their property.

He said that they were all then under heavy bond, and on account of the mysterious way in which I left, they had laid their downfall on to my giving them away before the grand jury; that they were mad enough to murder me if I could have been found; that I only had one friend in Pagosa Springs who stuck up for me to the last and refused to believe me guilty, and that was his wife.

He said that this showed how a woman could be a true friend when once her mind is made up. He assured me that no matter to what part of the earth I might drift, I could count on having true friends in Pagosa Springs, and that any time I should need money or help, to write him.

I have never seen any of the Archuleta county warriors since leaving there, hence I do not know whether I am regarded as an outlaw yet or not. I see by the papers that Taylor still lives in Pagosa Springs, which has grown to be an important railroad town, and that he is judge of the court there.

In dismissing the Archuleta county uprising, I wish to state

that these men had good cause for revolting, as politics in that county were rotten. Most of them were honorable citizens, though a little rough and wild. Of course, I felt "sore" at them for wanting to hang me up by the neck.

I shall always hold my friend Gordon G. as one of the "true blue" sons of the Lone Star State, as he knows how to stick to a friend

A few nights after my arrival in Mexico City, a big earthquake shook up the city. It shook the Guadaola Hotel where I had a room on the fourth floor, from stem to stem.

Many people in the city, according to reports, had been killed. The next morning the streets were still lined with natives praying. A few days later the big day of the Republic, the Fifth of May, was celebrated, and I then saw my first bull fight, and I never want to witness another.

If ever Uncle Sam should want a good soldier to help wipe Mexico off the face of the earth or make her promise to quit her coldblooded cruelties to dumb animals, he can count on me and I will gladly furnish my own ammunition.

They pitted three bulls imported from Spain against four native bulls. The ones from Spain were artists when it came to butchering horses. If they had killed a few of the ignorant and cruel Mexicans who were riding the poor beasts up to be gored to death, they would have won my applause.

One horse was sewed up six times and each time ridden back to be gored again, until finally killed by the bull. It was enough to disgust a Piute Indian, and still men, women and little children went wild and shouted for joy at the sight of blood and the suffering of the dumb brutes.

To show what a great head I've got for avoiding danger, I will cite a little instance. To Be continued.

#### **Home Wastewater Treatment Systems** By Paul Donharl

Have you ever wondered what happens to your wastewater when it goes down the drain or when you flush the toilet? If you live in a rural part of the county, not serviced by a central sewer system, your waste probably goes into a septic system, also known as an onsite wastewater treatment system. Today these systems come in several varieties.

Most systems in use today have a septic tank and dispersal field. Septic tanks commonly have compartments. Waste water and solids from the house dump into the first compartment of the tank. Heavier solids sink to the bottom. The lighter fats, oils and greases float to the top. In between these two layers is a third layer of nutrient rich liquid called "effluent." This passes through to the second compartment. Here bacteria which work without oxygen (anaerobic bacteria) begin to digest the nutrients and clean the liquid. This process is slow and the effluent almost always moves on to the dispersal field before the cleaning process is complete.

Dispersal fields are designed to receive the partially treated effluent. Aerobic (with oxygen) bacteria, in the field supply additional cleaning. The cleaned water evaporates back into the air or returns to the water table. Dispersal fields can vary from pipes buried in the soil, a media bed (gravel, sand, tire chips) using chambers or a mound system with pressure dosing. In this last stage of cleaning, a layer of bacteria and slime, called a "biomat," aids in further removal of pathogens and sewage solids.

When the effluent stream is overloaded with organics (garbage disposals are a main cause of this problem) the biomat can grow too thick, overloading the design limits of the dispersal bed. Final treatment cannot occur and partially treated sewage can surface or move laterally contaminating groundwater and wells. This is referred to as a failed

system. This is potentially dangerous as human contact or ingestion of harmful pathogens can cause serious health issues. Proper care and maintenance of your system can avoid this problem.

In part two we will discuss modern alternatives.

#### THERMAL MASS: **ESSENTIAL TO** PASSIVE SOLAR **HEATING!**



"Thermal mass" is essential to passively solar heating your home, according to David Brackhahn of FOXFIRE Construction, a Pagosa Springs natural building specialist. He has been involved in passive solar design and construction since 1976.

Savvy homeowners, motivated by respect for the environment and concern about rising costs, want to find alternative solutions. Many are concerned about continuing availability of conventional public With our energy resources. mountain winters, heating our homes can be both economically and ecologically challenging. Designing structures that passively utilize the sun's energy to provide additional space heating is a perfect solution, one that's cost effective, clean, and environmentally "friendly."

"Passive" solar heating utilizes simple principles of design that allow significant heating benefits from the sun without requiring electricity or fuel driven devices, such as fans or pumps. Passive solar begins with situating and shading a structure properly, in order to take full advantage of the natural movement and orientation of the sun during its daily and seasonal heating and cooling cycles. In a passive solar home, the people become a little more actively involved with the sun as their understanding of this marvelous resource grows. Simple acts, such as the timely opening or closing of a shade or window, not only maximize comfort but give people a sense of security and peace of mind from working in cooperation with nature.

A CALCULATED FIXED OVERHANG:



Brackhahn points out that a common mistake people often make in trying to solar heat their homes is in assuming that huge areas of southfacing glass is all you need. In reality, that alone will severely overheat your temperature, making

uncomfortably hot during the day, yet providing you no heat at all after nightfall when most needed. That's where "thermal mass" comes into the program.

"Thermal mass" is any heavy masonry material such as adobe, concrete, hard tile, brick (or even water in sealed in dark containers) which, when struck by available sunlight, will absorb heat, and then will continue to gradually release the heat back into the house over a period of hours, even after sunset. Dark colored thermal mass


structures absorb heat from the sun faster and better. Using sufficient thermal mass in areas where sun strikes, such as in floors, structural and decorative walls, "bancos" (masonry benches), and planters, creates more stable cycles of heat gain and heat release, making your living environment more consistently comfortable. All you really need for "back-up" heat is an efficient woodburning stove, for those few cloudy days when your thermal mass can't get "recharged" from the sun.

Good passive solar design also includes calculated fixed overhangs above your solar oriented windows.

The positioning of windows and extent of the overhangs is calculated for your site's specific degree of north latitude, allowing maximum winter sun into vour house, but shading it from hottest summer sun. (See diagram at left.)

Another good passive solar application, for those who prefer less direct sunlight in their homes, is the Trombe wall (pronounced "Trom"... named after Frenchman who designed it).

This externally-glazed, southfacing thermal mass wall, also known as a "heat chimney", creates a natural convection-loop current of solarheated air which warms you in winter and delivers a "bonus" in summer as well. By utilizing proper venting techniques in summer, a convection loop Trombe wall can be utilized to



circulate naturally cooled air through your home... efficiently providing you with "low tech" heating and cooling!

Beginning with good passive solar principles in the design phase of your home is wise, but there are also passive solar retrofit concepts which can greatly help an existing home become more efficient and comfortable, such as adding thermal mass by the addition of a properly built "sun space", sun room, or solar greenhouse on the south. In some applications this can even extend the growing season for our high altitude vegetable gardening!

## US Seizes Wind Power Crown! BusinessGreen

The US has officially overtaken Germany as the world's largest producer of wind energy following a record-breaking 2008 in which the country's wind capacity increased by a staggering 50 per cent. According to figures released last week by the Global Wind Energy Council (GWEC), the US installed 8.4GW of capacity last year giving it a total of over 25GW, compared to just under 24GW in Germany. The US led a bumper year for the global wind energy industry in which investment in turbine installations topped \$47bn and worldwide wind energy capacity grew almost 29 per cent, even higher than the average over the last decade.

'These figures speak for themselves: there is huge and growing global demand for emissions-free wind power, which can be installed quickly, virtually everywhere in the world,' said Steve Sawyer, Secretary General of GWEC. 'Wind energy is the only power generation technology that can deliver the necessary cuts in CO2 in the critical period up to 2020, when greenhouse gasses must peak and begin to decline to avoid dangerous climate change.'

While the US took the crown as the world's largest wind energy market other regions also enjoyed record breaking years.

Close to a third of all new capacity installed in 2008 was located in Asia with China doubling its installed capacity to over 12GW. The country is now on track to overtake Germany as the second largest producer of wind power next year and should meet its 2020 target of 30 GW of installed capacity ten years ahead of time.

#### Barricade fire gel earns EPA "Champion" award AJ Enterprises LLC

Barricade Fire Gel has been recognized by the U.S. Environmental Protection Agency for demonstrating the use of safer surfactants and for documenting a strategy for ensuring that only safer surfactants are used.

Barricade is the only fire gel to receive a "Champion" designation from the EPA as part of its Safer Detergents Stewardship Initiative. The company will receive its award at a ceremony Nov. 19 in Washington. Champion is the highest level of recognition offered under SDSI.

Surfactants are chemicals that stabilize mixtures of oil and water. Barricade is the only gel on the market free of nonylphenol ethoxylates (NPEs), which scientific studies have shown can have long-term effects on fresh- and salt-water fish. "Safer surfactants ...break down quickly to non-polluting compounds and help protect aquatic life in both

fresh and salt water," says the EPA.

"This award is important because it demonstrates that a fire protection gel can be both effective and environmentally friendly at the same time," said John Bartlett, president of Barricade Fire Gel, based in Hobe Sound, Fla. Barricade has been widely recognized for its effectiveness in protecting structures and wildland from surrounding forest fires. It is used by fire departments in areas susceptible to wildfires and is available for individual homeowners in retail markets.

#### THE BILL OF RIGHTS

## What does the Supreme Law of the Land tell us?

Continuing with this issue, we are printing the Bill of Rights of the United States <u>of America</u>, the Supreme law of the land, under God, so that you have a copy to access as we progress in all the things we will be learning over the coming months.

I say, United States of America, and NOT just the "United States," because they are two entirely different entities, as you will learn. If you have never read through these documents, or simply don't remember what they say, you will be amazed at where we are now in the Rule of Law in this country and how far we have strayed from our founding documents, to our financial and other detriment.

Many elements within these documents will be addressed in future articles and investigation as to how this supreme law of the land is being broken every minute of every day across the 50 States. This is unacceptable for a free people and we all need to become more involved with where we are headed. It really doesn't take a huge, impossible effort... just some courage, some cooperation, and some fortitude, just as our founding ancestory showed in bringing us the freedoms we now enjoy. Let the journey begin, and let's take back our country, our laws and our freedoms!

The Bill of Rights are usually understood to be the first 10 Amendments to the Constitution. Later Amendments were added over the years!

#### Amendment I

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

#### Amendment II

A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

#### Amendment III

No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.

#### Amendment IV

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

#### Amendment V

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

#### Amendment VI

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

#### Amendment VII

In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise reexamined in any Court of the United States, than according to the rules of the common law.

#### Amendment VIII

Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

#### Amendment IX

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

#### $Amendment \ X$

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

#### AMENDMENT XI

Passed by Congress March 4, 1794. Ratified February 7, 1795. Note: Article III, section 2, of the Constitution was modified by amendment 11.

The Judicial power of the United States shall not be construed to extend to any suit in law or equity, commenced or prosecuted against one of the United States by Citizens of another State, or by Citizens or Subjects of any Foreign State.

#### AMENDMENT XII

Passed by Congress December 9, 1803. Ratified June 15, 1804. Note: A portion of Article II, section 1 of the Constitution was superseded by the 12th amendment.

The Electors shall meet in their respective states and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice-President, and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate; -- the President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted; -- The person having the greatest number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives shall choose immediately, by ballot, the President. But in choosing the President, the votes shall be taken by states, the representation from each state having one vote; a quorum for this purpose shall consist of a member or members from two-thirds of the states, and a majority of all the states shall be necessary to a choice. [And if the House of Representatives shall not choose a President whenever the right of choice shall devolve upon them, before the fourth day of March next following, then the Vice-President shall act as President, as in case of the death or other constitutional disability of the President. --\* The person having the greatest number of votes as Vice-President, shall be the Vice-President, if such number be a majority of the whole number of Electors appointed, and if no person have a majority, then from the two highest numbers on the list, the Senate shall choose the Vice-President; a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be necessary to a choice. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the

\*Superseded by section 3 of the 20th amendment.

#### AMENDMENT XIII

Passed by Congress January 31, 1865. Ratified December 6, 1865. Note: A portion of Article IV, section 2, of the Constitution was superseded by the 13th amendment.

Section 1.

Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

Section 2.

Congress shall have power to enforce this article by appropriate legislation.

#### AMENDMENT XIV

Passed by Congress June 13, 1866. Ratified July 9, 1868.

Note: Article I, section 2, of the Constitution was modified by section 2 of the 14th amendment.

Section 1.

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

Section 2.

Representatives shall be apportioned among the several States according to their respective numbers, counting the whole number of persons in each State, excluding Indians not taxed. But when the right to vote at any election for the choice of electors for President and Vice-President of the United States, Representatives in Congress, the Executive and Judicial officers of a State, or the members of the Legislature thereof, is denied to any of the male inhabitants of such State, being twenty-one years of age,\* and citizens of the United States, or in any way abridged, except for participation in rebellion, or other crime, the basis of representation therein shall be reduced in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such State.

Section 3

No person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

Section 4.

Section 5.

The validity of the public debt of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in suppressing insurrection or rebellion, shall not be questioned. But neither the United States nor any State shall assume or pay any debt or obligation incurred in aid of insurrection or rebellion against the United States, or any claim for the loss or emancipation of any slave; but all such debts, obligations and claims shall be held illegal and void.

The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

\*Changed by section 1 of the 26th amendment.

#### AMENDMENT XV

Passed by Congress February 26, 1869. Ratified February 3, 1870. Section 1.

The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of race, color, or previous condition of servitude--

Section 2.

The Congress shall have the power to enforce this article by appropriate legislation.

#### AMENDMENT XVI

Passed by Congress July 2, 1909. Ratified February 3, 1913. Note: Article I, section 9, of the Constitution was modified by amendment 16.

The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration.

#### AMENDMENT XVII

Passed by Congress May 13, 1912. Ratified April 8, 1913. Note: Article I, section 3, of the Constitution was modified by the 17th amendment.

The Senate of the United States shall be composed of two Senators

from each State, elected by the people thereof, for six years; and each Senator shall have one vote. The electors in each State shall have the qualifications requisite for electors of the most numerous branch of the State legislatures.

When vacancies happen in the representation of any State in the Senate, the executive authority of such State shall issue writs of election to fill such vacancies: Provided, That the legislature of any State may empower the executive thereof to make temporary appointments until the people fill the vacancies by election as the legislature may direct.

This amendment shall not be so construed as to affect the election or term of any Senator chosen before it becomes valid as part of the Constitution.

#### AMENDMENT XVIII

Passed by Congress December 18, 1917. Ratified January 16, 1919. Repealed by amendment 21.

Section 1.

After one year from the ratification of this article the manufacture, sale, or transportation of intoxicating liquors within, the importation thereof into, or the exportation thereof from the United States and all territory subject to the jurisdiction thereof for beverage purposes is hereby prohibited.

Section 2.

The Congress and the several States shall have concurrent power to enforce this article by appropriate legislation.

Section 3.

This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by the legislatures of the several States, as provided in the Constitution, within seven years from the date of the submission hereof to the States by the Congress.

#### AMENDMENT XIX

Passed by Congress June 4, 1919. Ratified August 18, 1920.

The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex.

Congress shall have power to enforce this article by appropriate legislation.

#### AMENDMENT XX

Passed by Congress March 2, 1932. Ratified January 93, 1933.

Note: Article I, section 4, of the Constitution was modified by section 2 of this amendment. In addition, a portion of the 12th amendment was superseded by section 3.

Section 1.

The terms of the President and the Vice President shall end at noon on the 20th day of January, and the terms of Senators and Representatives at noon on the 3d day of January, of the years in which such terms would have ended if this article had not been ratified; and the terms of their successors shall then begin.

Section 2.

The Congress shall assemble at least once in every year, and such meeting shall begin at noon on the 3d day of January, unless they shall by law appoint a different day.

Section 3.

If, at the time fixed for the beginning of the term of the President, the President elect shall have died, the Vice President elect shall become President. If a President shall not have been chosen before the time fixed for the beginning of his term, or if the President elect shall have failed to qualify, then the Vice President elect shall act as President until a President shall have qualified; and the Congress may by law provide for the case wherein neither a President elect nor a Vice President shall have qualified, declaring who shall then act as President, or the manner in which one who is to act shall be selected, and such person shall act accordingly until a President or Vice President shall have qualified.

Section 4.

The Congress may by law provide for the case of the death of any of the persons from whom the House of Representatives may choose a President whenever the right of choice shall have devolved upon them, and for the case of the death of any of the persons from whom the Senate may choose a Vice President whenever the right of choice shall have devolved upon them.

Section 5.

Sections 1 and 2 shall take effect on the 15th day of October following the ratification of this article.

Section 6.

This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by the legislatures of three-fourths of the several States within seven years from the date of its submission.

#### AMENDMENT XXI

Passed by Congress February 20, 1933. Ratified December 5, 1933. Section 1.

The eighteenth article of amendment to the Constitution of the United States is hereby repealed.

Section 2.

The transportation or importation into any State, Territory, or Possession of the United States for delivery or use therein of intoxicating liquors, in violation of the laws thereof, is hereby prohibited.

Section 3.

This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by conventions in the several States, as provided in the Constitution, within seven years from the date of the submission hereof to the States by the Congress.

#### AMENDMENT XXII

Passed by Congress March 21, 1947. Ratified February 27, 1951. Section 1.

No person shall be elected to the office of the President more than twice, and no person who has held the office of President, or acted as President, for more than two years of a term to which some other person was elected President shall be elected to the office of President more than once. But this Article shall not apply to any person holding the office of President when this Article was proposed by Congress, and shall not prevent any person who may be holding the office of President, or acting as President, during the term within which this Article becomes operative from holding the office of President or acting as President during the remainder of such term.

Section 2.

This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by the legislatures of three-fourths of the several States within seven years from the date of its submission to the States by the Congress.

#### AMENDMENT XXIII

Passed by Congress June 16, 1960. Ratified March 29, 1961. Section 1.

The District constituting the seat of Government of the United States shall appoint in such manner as Congress may direct:

A number of electors of President and Vice President equal to the whole number of Senators and Representatives in Congress to which the District would be entitled if it were a State, but in no event more than the least populous State; they shall be in addition to those appointed by the States, but they shall be considered, for the purposes of the election of President and Vice President, to be electors appointed by a State; and they shall meet in the District and perform such duties as provided by the twelfth article of amendment.

Section 2.

The Congress shall have power to enforce this article by appropriate legislation.

#### AMENDMENT XXIV

Passed by Congress August 27, 1962. Ratified January 93, 1964. Section 1.

The right of citizens of the United States to vote in any primary or other election for President or Vice President, for electors for President or Vice President, or for Senator or Representative in Congress, shall not be denied or abridged by the United States or any State by reason of failure to pay poll tax or other tax.

Section 2.

The Congress shall have power to enforce this article by appropriate legislation.

#### AMENDMENT XXV

Passed by Congress July 6, 1965. Ratified February 10, 1967. Note: Article II, section 1, of the Constitution was affected by the 25th amendment.

Section 1.

In case of the removal of the President from office or of his death or resignation, the Vice President shall become President.

Section 2.

Whenever there is a vacancy in the office of the Vice President, the President shall nominate a Vice President who shall take office upon confirmation by a majority vote of both Houses of Congress.

Section 3.

Whenever the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that he is unable to discharge the powers and duties of his office, and until he transmits to them a written declaration to the contrary, such powers and duties shall be discharged by the Vice President as Acting President.

Section 4.

Whenever the Vice President and a majority of either the principal officers of the executive departments or of such other body as Congress may by law provide, transmit to the President pro tempore of the Senate and the Speaker of the House of Representatives their written declaration that the President is unable to discharge the powers and duties of his office, the Vice President shall immediately assume the powers and duties of the office as Acting President.

Thereafter, when the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that no inability exists, he shall resume the powers and duties of his office unless the Vice President and a majority of either the principal officers of the executive department or of such other body as Congress may by law provide, transmit within four days to the President pro tempore of the Senate and the Speaker of the House of Representatives their written declaration that the President is unable to discharge the powers and duties of his office. Thereupon Congress shall decide the issue, assembling within forty-eight hours for that purpose if not in session. If the Congress, within twenty-one days after receipt of the latter written declaration, or, if Congress is not in session, within twenty-one days after Congress is required to assemble, determines by two-thirds vote of both Houses that the President is unable to discharge the powers and duties of his office, the Vice President shall continue to discharge the same as Acting President; otherwise, the President shall resume the powers and duties of his office.

#### AMENDMENT XXVI

Passed by Congress March 23, 1971. Ratified July 1, 1971.

Note: Amendment 14, section 2, of the Constitution was modified by section 1 of the 26th amendment.

Section 1

The right of citizens of the United States, who are eighteen years of age or older, to vote shall not be denied or abridged by the United States or by any State on account of age.

Section 2.

The Congress shall have power to enforce this article by appropriate legislation.

#### AMENDMENT XXVII

Originally proposed Sept. 25, 1789. Ratified May 7, 1992.


No law, varying the compensation for the services of the Senators and Representatives, shall take effect, until an election of representatives shall have intervened.
