## LOCAL JUDGE DEMONSTRATES RESPECT FOR THE RULE OF LAW IN FORECLOSURE CASE!

Earlier this month, Judge James Denvir ordered attorneys seeking forceful eviction of an Archuleta County couple for a foreclosing bank to produce the ORIGINAL NOTE. Such action is aligned with the Rule of Law in Colorado found in Colorado Rules of Civil Procedure (C.R.C.P.) Rule 121, Section 1-14 because foreclosing attorneys had claimed the couple defaulted in the terms of a promissory note.

C.R.C.P. Rule 121, Section 1-14(f) Defaults, states clearly:

“(f) If the action is on a promissory note, the original note shall be presented to the court in order that the court may make a notation of the judgment on the face of the note. If the note is to be withdrawn, a photocopy shall be substituted.”

Having read previous articles in the Free Press, the couple facing forceful eviction began investigating the foreclosure file, the Public Trustee’s records (Archuleta County this is the Treasurer), and the public recordations, or lack thereof kept by the Archuleta recorder’s office. Once armed with the knowledge of the Colorado Rules and books on the subject of unlawful foreclosures, numerous failings became clear to the couple who filed for injunctive relief while pursuing further documentation, believing new evidence had become available which has lead to new questions regarding the standing of the foreclosing bank: INDYMAC FEDERAL SAVINGS BANK.

As you may know, INDYMAC FSB was created by the FDIC to deal with the mess left behind by failed bank INDYMAC in 2008. (See: www.fdic.gov/bank/individual/failed/banklist.html) The information from the Public Trustee’s file included numerous emails between public trustees across Colorado

questioning whether the trustees could lawfully foreclose for INDYMAC. Not having resolved said questions and without the original note or a marked copy of file, a local Treasurer’s deputy, as Trustee, foreclosed on said property.

Additional questions of standing are apparent where a search of the Colorado Secretary of State’s website seems to indicate the new entity INDYMAC FSB was not properly registered in Colorado before availing itself of a Colorado Court for an order authorizing sales under powers (C.R.C.P. 120) as required for non-resident entities. Colorado Revised Statute 7-90-802 states in part:

§ 7-90-802. Consequences of transacting business or conducting activities without authority

(1)(a) No foreign entity transacting business or conducting activities in this state without authority, nor anyone on its behalf, shall be permitted to maintain a proceeding in any court in this state for the collection of its debts until a statement of foreign entity authority for the foreign entity is filed in the records of the secretary of state.

(b) A court may stay a proceeding commenced by a foreign entity until it determines whether the foreign entity should have a statement of foreign entity authority on file with the secretary of state....

(3) A foreign entity that transacts business or conducts activities in this state without having a statement of foreign entity authority on file in the records of the secretary of state shall be subject to a civil penalty, payable to this state, not to exceed five thousand dollars.

Perhaps most egregious to this Archuleta couple was the filing of a document AFTER the redemption period [re-?]transferring interest to a securitized trust under the

## Viral Contamination in Flu Vaccines sent to 18 Countries:

Staff Report

According to the scientific network PROMED, Baxter International Inc. in Austria "unintentionally contaminated samples with the bird flu virus that were used in laboratories in 3 neighboring countries, raising concern about the potential spread of the deadly disease." As PROMED reports, the contamination has been discovered when ferrets at a laboratory in the Czech Republic died after being inoculated with vaccine made from the samples early this month.

"The material came from Deerfield, Illinois-based Baxter, which reported the incident to the Austrian Ministry of Health, Sigrid Rosenberger, a ministry spokeswoman, said today in a telephone

interview," the network-alert-system is quoting. "This was infected with a bird flu virus," Rosenberger said. "There were some people from the company who handled it."

"That mixing process, called reassortment, is one of two ways pandemic viruses are created," the Canadian Press article states. (Emphasis editors) Baxter admits sending live avian flu viruses to subcontractor --People familiar with biosecurity rules are dismayed by evidence that human H3N2 and avian H5N1 viruses somehow co-mingled in the Orth-Donau facility.

The company that released contaminated flu virus material from a plant in Austria confirmed Friday that the experimental product contained live H5N1 avian flu viruses. And an official of the World Health Organization's European operation said the body is closely monitoring the investigation

## When cops are thieves

If the County Sheriffs of Colorado has its way, law-enforcement agencies will soon be able to take your house, cars, cash and jewelry, sell it off and divvy up the proceeds quietly and privately among themselves. This organization, which lobbies for the interests of sheriffs across the state, is the force behind House Bill 1238, which rolls back a 2002 law guaranteeing Colorado residents reasonable protections against “asset forfeiture” — a fancy legal term for when the cops use the force of law to take your stuff.

The idea behind asset forfeiture is to deprive criminals of property used to commit crimes and the money they make by breaking the law. Think of a coke kingpin with several houses, a yacht, a few helicopters, lots of guns and ammo, as well as a fleet of fancy cars.

When he’s busted, the empire that cocaine built is taken from him, liquidated and put toward paying for the expense that went into bringing him down. Fair enough, right?

When it comes to drug kingpins, asset forfeiture seems just and reasonable. But every law has unintended consequences. Prior to 2002, the state’s asset forfeiture law too often resulted in property and cash being taken from innocent men and women — people who either hadn’t committed a crime or who were arrested but later acquitted. Further, the law gave law-enforcement officers a financial incentive to see every arrest as a potential opportunity for profit.

Consider the single mom who loaned her car to her cousin — only to lose it after the police pulled her cousin over and discovered marijuana seeds and a wad of cash hidden in the vehicle. It didn’t matter that the car didn’t belong to the cousin or that the woman was innocent or that losing the car was a major financial blow to her. The police sold the vehicle and pocketed the cash.

Then there was the disabled man who, prior to the state’s medical marijuana law, was busted for growing a couple of pot plants in his house.

He wasn’t a dealer; he didn’t sell dope to school kids. Instead, he used marijuana to control his chronic pain. The police checked county records and saw that he’d paid off his mortgage with settlement money from the accident that deprived him of his mobility. After discovering how much money was tied up in his house, they started forfeiture proceedings, depriving a man with no job and no ability to work of his home at great profit to their agency.

And what about the Mexican worker who came here legally to help build Denver International Airport? He bought a ticket home and boarded a plane with \$15,000 in hard-earned cash. Police searched him and found the cash. They discovered no drugs on him or in his luggage. Nor did they find any evidence that the money came from the commission of a crime. But because a drug-sniffing dog reacted to the money, they decided to keep it, even though studies have shown that 99 percent of bills in circulation are tainted with the scent of illegal drugs. After the man hired an attorney, he got 40 percent of his wages back, but the cops kept the other 60 percent because they could.

The above are real incidents provided to Boulder Weekly by attorneys who worked to get the 2002 reform bill passed and signed into law. (See “Pirate police,” cover story, March 21, 2002.) It was incidents like these that brought people together from the left and the right and all points in between to change state law to protect individual property rights and discourage abuses by law-enforcement agencies.

The 2002 law, still currently in force, works in a couple of different ways, requiring that a person be convicted before their property can be taken. It also removes the financial motivation for law enforcement to seize assets by dividing the money from forfeitures equally between local substance-abuse programs and

local county or city government for allocation through a public budgeting process. And it requires law-enforcement agencies to stay on the level by submitting an annual forfeiture report to the Department of Local Affairs.

Now, some in the law-enforcement community want to revert to the way things were before the 2002 law passed, when they could take people’s money, jewelry, cars and homes without first getting a criminal conviction and keep the majority of it without any public accountability. It’s a recession, after all, and they need money from somewhere.

House Bill 1238, sponsored in the house by Rep. Joe Rice, D-Glendale, and in the Senate by Sen. Brandon Shaffer, D-Boulder, would wipe away the 2002 reforms that curbed law-enforcement abuses. It would remove the requirement that a person be convicted of a criminal offense before their property could be taken. It would further allow a person’s property to be taken even if that person didn’t know his or her property was being used to commit a crime. It would even remove the requirement that law-enforcement agencies prove that the property they’re trying to seize was instrumental in committing a crime. And it would allow cops to keep the majority of the booty without any public accountability or reporting requirement.

In short, HB 1238 gives law-enforcement agencies both the incentive and the legal ability to abuse their authority at the expense of your individual property rights. As one local attorney, Dennis Blewitt, put it, “It turns cops into privateers.”

We need law-enforcement agencies to uphold our rights, not to rob us at gunpoint. Fortunately, the same bipartisan, grassroots coalition that came together to get the 2002 reforms passed is joining forces once again to defeat Rice’s ill-conceived bill. Boulder Weekly urges you to join that effort by contacting Sen. Shaffer and other local representatives and asking them to kill HB 1238. A bill like this is utterly at odds with the United State’s highest principles of justice, among them this gem: “innocent until proven guilty.”

direction of Deutsche Bank. Now previously unconnected puzzle-pieces began coming together, painting a new picture altogether. Absent the original note, absent properly executed assignments documented on the alleged “copy” of the original note from the original lender to INDYMAC to INDYMAC FSB, absent a recorded, verified unbreached chain of title, and absent evidence INDYMAC FSB purchased the note with valuable consideration to evidence an injury-in-fact to the court, and now with Deutsche Bank suddenly of record, the couple realized there was no evidence INDYMAC was the real party in interest (C.R.C.P Rule 17) with legal authority to invoke the court’s subject matter jurisdiction under C.R.C.P. Rule 120, likely resulting in a VOID, not merely void-able, order and that the Trustee sale, as a matter of continuing liability and justice, may not stand.

Courts across this country have tossed Deutsche Bank foreclosure cases out for the same reason: no standing. Is this perhaps the new scheme? Concealing completely the securitization of the mortgage/note until it seems too late? Hoping that breaches in the chain of title will go unnoticed by distressed homeowners and that courts will rubber-stamp orders authorizing foreclosure sales without the required documents (original note, all assignments properly executed) being made of record?

Are the people of Archuleta ready to DEMAND timely compliance with the legislature's intent to prevent others similarly situated from also experiencing such inflictions of extreme emotional distress? Will banks be held accountable for production of requisite documents?

Colorado does allow for local, local rules to be made and enforced as long as they comply with existing law. This author prays we might so pursue a local, local rule **REQUIRING** the original note, with all attachments/allonge – be attached with the initial filing of a request for court order authorizing sales under powers, a Rule 120 Motion, as has been adopted in Pinellas County, Florida- another lien theory state.

Such a rule would be in the protective interest of the citizens of Archuleta County and the interests of judicial economy, and would help minimize actions filed non-compliant with Rule

121 supra, barring those who would use our court system as a vehicle for injustice, else bank behaviors and concealed securitizations leave unknowing consumers at risk for future liability where undisclosed parties may later appear with further claims, and promissory notes have potentially been converted for substantial value as bank assets without a set-off to those mortgage loan applicants whose very signatures are being used in ways neither intended nor authorized.

NOTE: Defrauding a debtor of a promissory note is a crime, a potential felony depending on the face amount, under C.R.S. 18-5-206.

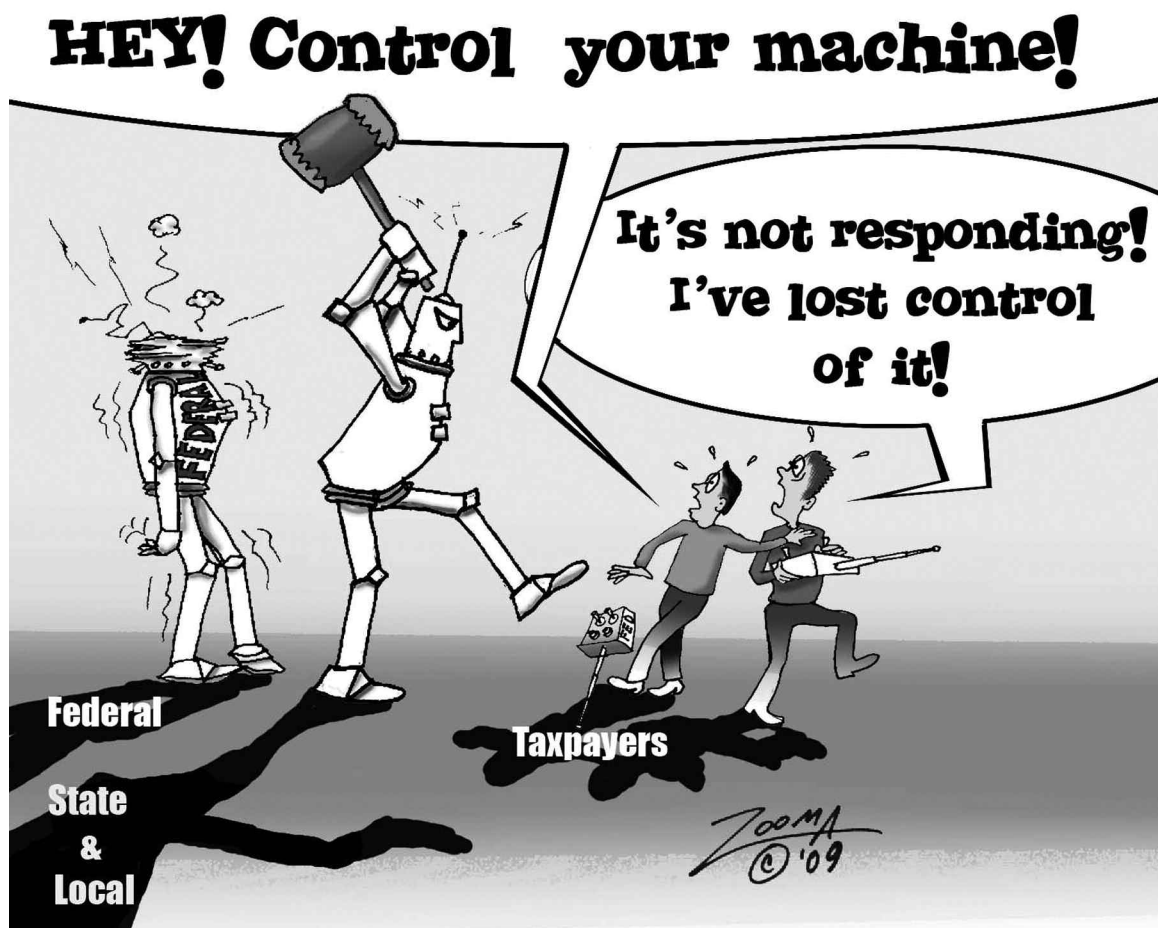
Will we awaken and realize the value to the banks has not been the loan and resulting payments with interest, but has been the use of our signatures creating a document (promissory note) we believed would merely be held as a default instrument? How many of YOU dreamed your note would end up on the secondary market as an “exhibit” in some securitization trust’s prospectus, swapped and traded via MERS without recordation of interests with your county recorder’s office ( notice)? We have been unknowingly induced with our signatures used by banks in ways unsound only now becoming apparent because the scheme- based on what one might label pure speculation and gambling vs. sound banking -is collapsing.

Production of the original note is only the FIRST step, but an important step, indeed. Material questions regarding standing remain, especially with the very banks who have securitized notes acquiring bail-out monies funneled to accounts undisclosed. If no repayment of the bailout money has been required, perhaps the notes have already been “paid” by bailout “gifts”- leaving the banks without the financial injury they yet continue to claim to the courts?

For taking the first step: thank you, Judge Denvir.

**Editor's Note:** Whether you are in foreclosure, or are right on target with your payments, you **MUST** know if you are paying the legal owner of the note, **AND** if your mortgage is secured and your name safe from identity theft. You can send a request for documentation to ,your original loaner, and you present loan servicer, and demand proof of who owns your note and the legal channels involved...

functions range from service projects, perhaps in conjunction with local charity groups such as the Neighbor2Neighbor program, to training in the constitution, legal protections of our freedoms and rights, and law enforcement. This is absolutely necessary knowledge to have...

The Free Press has been contacted by a local resident and businessman, Dennis Spencer, who has volunteered to help bring this group together. Mr. Spencer has extensive experience with forming a similar group in Texas, which had over 2000 members, becoming the second in command, and which became quite a successful group in preparing The People for a variety of possible challenges.

The Free Press recently reported on the meeting of the proposed Law Enforcement Support Team (LEST) which was organized by retired Police

Chief Donny Volger, and the personal reservations presented by many regarding constitutional and other issues within this group.

Many were concerned that if the City Police or County Sheriff's Department were going to be "managing" such a group, that they did not want anything to do with it.

Although most everyone on either side of this concern expressed appreciation for the Police and Sheriff's Department's willingness to uphold our Second Amendment right to keep and bear arms, and their willingness to help train citizens in firearms handling and criminal situations, many were leary of anything further beyond being of service to our local officers should they need it.

To date, the Free Press has received no contact from the proposed LEST on where this group stands and what we reported, but HAS received word from a reliable source, that one focal purpose for Donny Volger's interest in forming such a group is because of interest in running for Sheriff, and in stepping in where Sheriff Pete

Gonzalez leaves off.

The Free Press will follow up on this alleged interest, and possible motives involved, and welcomes information from relevant sources.

One concept being considered for a preferred type of citizen's group is that of "County Guard" groups (such as Archuleta County Guard, LaPlata County Guard, etc.) and follows in the concept footsteps of the National and State Guards, which essentially are militias authorized by the State and Federal Constitutions.

The autonomous standing of such a local, grass roots "guard" group without any regulated ties to other authorities assures the ability to stand on the full backing of the law and Constitution where so many Federal, State and Local government entities have failed miserably.

In this regard, the Free Press has been contacted by not only a number of citizens with law enforcement background, but Joel Mann who is certified in firearms training, and also a contact with legal expertise who just completed the BAR and is willing to support all the efforts

toward taking back our freedoms through the law and supporting the Constitution.

The Free Press has also been in contact with a number of the best legal and constitutional minds in the country who are willing to be part of a nationwide non-profit citizen's legal team being proposed and for which funding is being sought that would support such citizen's groups across the country.

Citizens of the local "Pagosa Law Club," (for lack of any name right now), are likely to be part of the "Guard" as well, further solidifying our rights and protections under the law.

We certainly hope all citizens will contact the Free Press and let us know of your interest in joining the group. We need people across the spectrum to join forces, and be willing to support each other in good times and bad.

Preparing now is vital, and we can't go wrong in taking this action, but we could dearly regret not preparing if hard times do come, which potential is screaming at us today.

## Archuleta County Sheriff's Department sniper training?

The Free Press received a tip recently, from a VERY reliable source, that the County is getting ready to spend money on two very questionable projects. The informant, whose name we are protecting due to their fear of possible retaliation by county officials, stated that the Sheriff's Department was planning to spend Deputy Shawn Curtis to the FBI Academy out of state, for the alleged price of \$10,000 and Deputy Tim Walter to "sniper school" in Durango, for the alleged cost of \$3500.

The Free Press contacted the Sheriff's Office and County Commissioner Bob Moomaw regarding these expenses, to admit or deny the information, and here is their response.

Bob Moomaw stated he was not aware of any budget allocations for this, but that the Sheriff's department doesn't have to ask for finances already within their budget. He simply stated he was not aware of either of these plans.

Undersheriff John Weiss, returned our call and stated that they always send their officers to weapons classes, and that their total budget was less than \$3000 for the year. Regarding the question of the firearms training being that of "sniper "school," he stated he did not know what type of training Deputy Walter was going to take.

Last year, the issue of the county having purchased a \$4000 sniper rifle was brought up by this same

contact, and the Free Press asked Officer Weiss about this. He stated he was not aware of any sniper rifle, and that he certainly didn't purchase such a rifle, but that he would check the facts and get back to us on this.

Regarding FBI school, Officer Weiss stated that he couldn't possibly send anyone to such a school due to costs, and that he definitely wasn't going to send anyone for \$10,000. When asked why we might want someone going to a Federal training academy, he stated that it was a general training school, addressing Federal, State and local issues, so it wasn't just a "Federal" training class.

He stated that anyone would be honored to be accepted to such a school, but that no one in our Sheriff Department was slated for such training. The Free Press remains a little skeptical of anything "federal" being brought into the county, as it usually means more control and loss of freedoms.

The Free Press reiterates that the source for this information is VERY reliable, so we must conclude that there is some basis for this information, so we must at least ask why would we want someone in our county trained as a sniper anyway?

What is happening that law enforcement is not telling us about if the ongoing investigations prove these tips to be true? Our country and county are in a financial crises, and we are possibly spending this kind of money, and for what good purposes?

Why would ANY county feel a

need to have a sniper in the county government? If they have a fear of some sort of terrorist activity, shouldn't they tell us so we, too, could prepare to defend our families and friends?

Is it drug cartel related threats in our area? Why else would we want to fund sniper training? Do We, the People, want such a thing? Do we NEED it, or is it just one more step in law enforcement police state tactics to prepare for dealing with county and state citizens when we are fed up with corruption and they have to face their true boses?

We ask that county officials be "transparent and open" with County citizens. Our citizens have the right to know what the servants are up to. All across the country, people are rising up to take back freedoms. We don't need or want babysitters.

We want good leadership that actually cares for the people and serves THEIR best interests, NOT THE STATES OR THE COUNTIES best interest.

The Free Press hopes that all citizens will take a stand on these issues. If the County is taking steps to create a larger police state power to attempt to control us, this is not what we want or need, and we will NOT accept it.

The Free Press will continue to work with sources investigating these issues, and will report to you, the People. We MUST join forces to make any real change and to protect our freedoms and rights.

Toward that end, we support the formation of a "County Guard" group (See page 1) to be a focal point for citizen activism.

### Oath to a Jar of Peanut Butter

Have you ever read the label on a jar of peanut butter? I really hadn't given much thought to such a common item as a food label until recently. Thinking about the issue of important documents, such as the United States Constitution, brought me to a controversial comparison.

Many of us in this country have served in a capacity that has honored us with the opportunity to align ourselves with a higher and nobler cause than we would otherwise be afforded. I speak of service to our friends, family, neighbors, and country through volunteering, or as many men have during draft, in the armed forces or civil service, such as police.

When embarking on this journey, in the U.S. Navy, I recall the pride and anticipation of raising my right hand and swearing an oath to a cause higher than myself. When I gave my oath, I did so with understanding and complete devotion to the same cause that so many had done before I had.

When interacting with many people today who have sworn an oath to the U.S. Constitution, and are currently serving in positions that require that oath, I am frequently confronted with, at least a worrisome conundrum and at worst a belligerent oppression. Have the vast majority of the usually well intentioned people that have sworn an oath in their



official capacity to the U.S. Constitution done so with devotion, commitment, and knowledge of what they are swearing? Have they actually read what they are committing allegiance to? Or is the oath swearing merely a bureaucratic formality like so many forms they had to fill out before they could serve?

The heart of this issue resides in the bureaucratic and convoluted hijacking of the U.S. Constitution. Does the USC actually mean what it says and do Americans have access to the tenets and assertions that it makes? I am not a constitutional scholar but neither do I think I need be an expert to comprehend the many basic concepts and rights that it enumerates, and neither should most Americans.

This brings me to my comparison. If a person is required to swear an oath, then shouldn't that person be able, and held accountable, to actually understanding that oath? In my experience of dealing with these individuals I have been given unacceptable excuses for the flagrant violation of the oaths they claim to have taken. They say that they defer the meaning of their oath to the attorney for their

After a trial of a hearing on a Florida Bar Association complaint alleging that Charles Chuck Behm, a Florida attorney, had violated bar rules by committing a criminal act by refusing to file federal income tax returns since 1999 Judge Tyree Boyer ruled that Behm committed no criminal act. department or to the higher courts at the State or Federal level and these officials say they are "just doing their job." I say that they are not doing their job if they are obviously violating their oath. If they believe that they are not allowed to understand the USC then why did they swear an oath to it? Why didn't they just swear an oath to a jar of peanut butter? At least with the label on a jar of peanut butter they are actually allowed to understand it, except maybe for that bar code and a word like hydrogenated which they can look up a definitive meaning for in the dictionary. If these people, such as police and other public servants, intellectually disconnect from their oaths and defer accountability for their individual actions to someone sitting behind a desk somewhere, why do they bother swearing an oath in the first place. ## Does proposed 'mileage tax' have hidden agenda?

A government-spending watchdog says a recently discussed plan for raising tax revenue for America's roads should scare anyone who drives a car.

Transportation Secretary Ray LaHood recently stated that he would be willing to implement a plan that will tax motorists on the amount of miles driven.

Massachusetts lawmakers have considered such a plan, and pilot programs have been implemented in the Northwest United States. In order to track the mileage, cars will have to be fitted with Global Positioning System (GPS) units.

This has prompted fear of a "big brother state," and some critics are calling it Orwellian intrusion. David Williams, vice-president of policy with Citizens Against Government Waste, has similar concerns. "[I]t looks like this could be a camel's nose under the tent," Williams offers.

"You know, this is the first step -- you put a GPS unit in every car

to, quote, 'track mileage.' Well, what else is it going to track? And what else are they going to monitor?" Yet it is consistent with what he sees government desiring these days. "...[I]t gets with the government's obsession with two things: knowing everything about us, and collecting money from us," he says.

But lawmakers have been talking about replacing the gas tax with the mileage tax. OneNewsNow asked Williams if that was a realistic goal. "Well, if this were to be like the income tax or the tax system, they probably would not get rid of something -- they would just add onto another layer," he states. "Because every time they talk about reforming the tax system...no one really says to get rid of the current tax system.

So [I suspect] we would see it as just another layer." Williams says lawmakers are talking about other tax sources for roads because the current system has been poorly managed.

For example, Williams says millions of dollars have been used to plant flowers instead of repair roads and bridges.

After all, it is "appointed unto men once to die" (Hebrews 9:27), "as in Adam all die" (1 Corinthians 15:22), and Jesus Himself said no one has gone to heaven except Himself (John 3:13).

"Some think what happened to Enoch is a huge mystery that we won't be able to solve until Jesus returns, but you can find out the truth of Scripture right now if you just crack open your own Bible and see the words on its pages," says WND Executive News Editor Joe Kovacs, author of the best-selling book, "Shocked by the Bible: The Most Astonishing Facts You've Never Been Told."

"I think I underestimated the public's confusion about what happened to Enoch, so I didn't focus on him in my book. But I'm very happy now to help people see with their own eyes what Scripture actually says, as well as what it doesn't say."

First of all, the King James Bible does not say Enoch never died, vanished into thin air or was somehow whisked off into heaven, the unseen dwelling place of God. Those words are simply not on its pages.

If you look closely, though, what the Bible actually does say is that Enoch died.

Yes, it's in your Bible. Enoch died. "In Hebrews chapter 11, there is a list of famous heroes from the Old Testament," says Kovacs. "There are great names mentioned including Abraham, Noah, Abel and Enoch. And guess what the Bible says about these outstanding characters who followed the true God of the universe. It says they all died."

These all died in faith, not having received the promises (Hebrews 11:13, King James Version) Feel free to open up any translation of your own Bible right now, and you'll see that these Old Testament heroes all died.

All these faithful ones died without receiving what God had promised them ... (New Living Translation)

All these people were still living by faith when they died. They did not receive the things promised ... (New International Version)

The Bible clearly says Enoch and the others "all died." Now that you're aware of that, what about those puzzling verses?

Some people get confused when they read, "By faith Enoch was translated that he should not see death; and was not found, because God had translated him: for before his translation he had this testimony, that he pleased God" (Hebrews 11:5).

Note what this verse does not say. It does not say Enoch went to heaven. Remember, Jesus said no one, and that includes Enoch, has gone to heaven except Jesus himself:

And no man hath ascended up to heaven, but he that came down from heaven (John 3:13, KJV). No one has ever gone into heaven except the one who came from heaven – the Son of Man (John 3:13, NIV).

The confusion is caused by the word "translated" in Hebrews 11:5. In its original Greek language, the word is "metatithemi," and means transported, transferred, removed, taken away or carried over.

That Greek word "metatithemi" is used just four other times in the Bible, and never has anything to do with not dying or sauntering off to heaven.

Well, we'll have to do something about that. When we are faced with something that flies in the face of all we've been taught all our lives, the first thing we want to do is to deny that it could possibly be true, or that "someone" wouldn't have discovered this long ago if it were a lie...

As with any new thing we face, whether a new job, new "toy" or whatever, there is a learning curve that takes place, like riding a bike. At first it is intimidating, but once we learn the facts and how to do it, we never forget it. It is the same with constitutional or legal issues. All it takes is some reading, and a desire to know the truth. The rest of it falls into place with that foundation.

So, rather than try to convince you with "my" words, I'll let the courts and professionals tell you in their own words what "income" really is: (Emphasis mine throughout)

- "Income Tax: A tax on the yearly profits arising from property, professions and trades, and offices." Henry Campbell Black, A Law Dictionary 612 (1910).

- "Income tax: An 'income tax' is a tax which relates to product or income from property or from business pursuits." Levi v. City of Louisville, 30 S.W. 973, 974, 97 Ky. 394, 28 105 L.R.A. 480.

- "The term 'income tax' includes a tax on the gross receipts of a corporation or business." Parker v. North British Ins. Co. 7 South. 599, 600, 42 La. Ann. 428. ("Includes" does NOT mean this court definition and all other definitions, it means JUST this definition - see document southwestfreepress.com/PDF/includes.pdf).

- "The statute and the statute alone determines what is income to be taxed. It taxes only income 'derived from' many different sources; one does not 'derive income' by rendering services and charging for them." Edwards v. Keith, 231 F. 110 (2nd Cir. 1916).

- "...income as used in the statute should be given a meaning so as not to include everything that comes in. The true function of the words "gains" and "profits" is to limit the meaning of the word "income." S. Pacific v. Lowe, 247 F. 330. (1918).

- "Under the Internal Revenue Act of 1954 if there is no gain, there is no income." - 26 U.S.C.A. '54, Sec. 61(a).

- "...Reasonable compensation for labor or services rendered is not profit..." Laureldale Cemetery Assc. v. Matthews. 47 Atlantic 2d. 277 (1946).

- "Simply put, pay from a job is a 'wage,' and wages are not taxable. Congress has taxed INCOME, not compensation. If there is no gain, there is no income." - Conner v. U.S. 303 F Supp. 1187 (1969).

"The fact is, property is a tree; income is the fruit; labour is a tree; income the fruit; capital, the tree; income the fruit. The fruit, (coming from the tree/property/wages-Editor) if not consumed (severed)(-courts

Four times, now, I have been a patient there since Nov. 17, 2006, sometimes for several days at a time.

At no time, while a patient there, however, have I veen allowed to use the telephone to make a local call. I have asked repeatedly to use the phone to inform my wife of my whereabouts, to speak with my Durango private attorneys, to contact my Durango private medical doctor or my Ignacio private family practitioner.

Always I was told, "A telephone will be brought to you soon." Never, I repeat, never while a patient at mercy, however, was I granted the use of the once for a phone call.

I know that criminal suspects housed at the La Plata County Jail are allowed to call out locally as needed.

Nevertheless, I have been repeatedly, routinely, held totally incommunicado and denied all opportunity to inform loved ones or necessary local persons of my whereabouts.

Article II, Section 25 of the Constitution of the state of Colorado provides that, "No person shall be deprived of life, liberty or property without due process of law."

Colorado Revised Statutes 27-10-117(1)(c) provides that hospital patients have a right to reasonable telephone access.

How much time will pass before due process of law causes persons who work at Mercy to respect the life, the liberty and the property of persons who are there as patients?

On the wall of the lobby of the Leonard C. Burch Administration Building near Ignacio, Colo., is a plaque stating that the Southern Ute Indian Tribe sovereign grants 12 acres of their sovereign Reservation at Three Springs, Colo., to Catholic Health Initiatives, to build a hospital, "for the improvement of the health of members of the Tribe and the surrounding community."

How does depriving a person of the liberty to inform loved ones or other local persons there

contribute to the improvement of the health of the Tribe and the surrounding community?

Meet The IRS - Americas Enemy Within

The IRS is not who you think they are. IRS agents are neither trained nor paid by the United States Government.

Pursuant to Treasury Delegation Order No. 92, the IRS is trained under the direction of the Division of Human Resources United Nations (U.N.) and the Commissioner (International), by the office of Personnel Management.

In the 1979 edition of 22 USCA 278, "The United Nations," you will find Executive Order 10422. The Office of Personnel Management is under the direction of the Secretary of the United Nations.

Pursuant to Treasury Delegation Order No. 91, the IRS entered into a "Service Agreement" with the US Treasury Department (See Public Law 94-564, Legislative History, pg. 5967, Reorganization (BANKRUPTCY!!!) Plan No. 26) and the Agency for International Development.

This agency is an international paramilitary operation and according to the Department of the Army Field manual (1969) 41-10, pgs 1-4, Sec. 1-7 (b) & 1-6, Sec. 1-10 (7)(c) (1), and 22 USCA 284, includes such activities as, "Assumption of full or partial executive, legislative, and judicial

authority over a country or area."

The IRS is also an agency/member of a 169 nation pact called the International Criminal Police Organization, or INTERPOL, found at 22 USCA 263a. The memorandum of Understanding, (MOU), between the Secretary of Treasury, AKA the corporate governor of "The Fund" and "The Bank" (International Monetary Fund, and the International Bank for reconstruction and Development), indicated that the Attorney General and its associates are soliciting and collecting information for foreign principals; the international organizations, corporations, and associations, exemplified by 22 USCA 286f.

According to the 1994 US Government Manual, at page 390, the Attorney General is the permanent representative to INTERPOL, and the Secretary of Treasury is the alternate member. Under Article 30 of the INTERPOL constitution, these individuals must expatriate their citizenship.

They serve no allegiance to the United States of America. The IRS is paid by "The Fund" and "The Bank." Thus it appears from the documentary evidence that the Internal Revenue Service agents are "Agents of a Foreign Principle" within the meaning and intent of the "Foreign Agents Registration Act of 1938" for private, not public, gain.

The IRS is directed and controlled by the corporate Governor of "The Fund" and "The Bank." The Federal Reserve Bank and the IRS collection agency are both privately owned and operated under private statutes. The IRS operates under public policy, not Constitutional Law, and in the interest of our nations foreign creditors.

The Constitution only permits Congress to lay and collect taxes. It does not authorize Congress to

delegate the tax collection power to a private corporation, which collects our taxes for a private bank, the Federal Reserve, who then deposits it into the Treasury of the IMF.

The IRS is not allowed to state that they collect taxes for the United States Treasury. They only refer to "The Treasury."

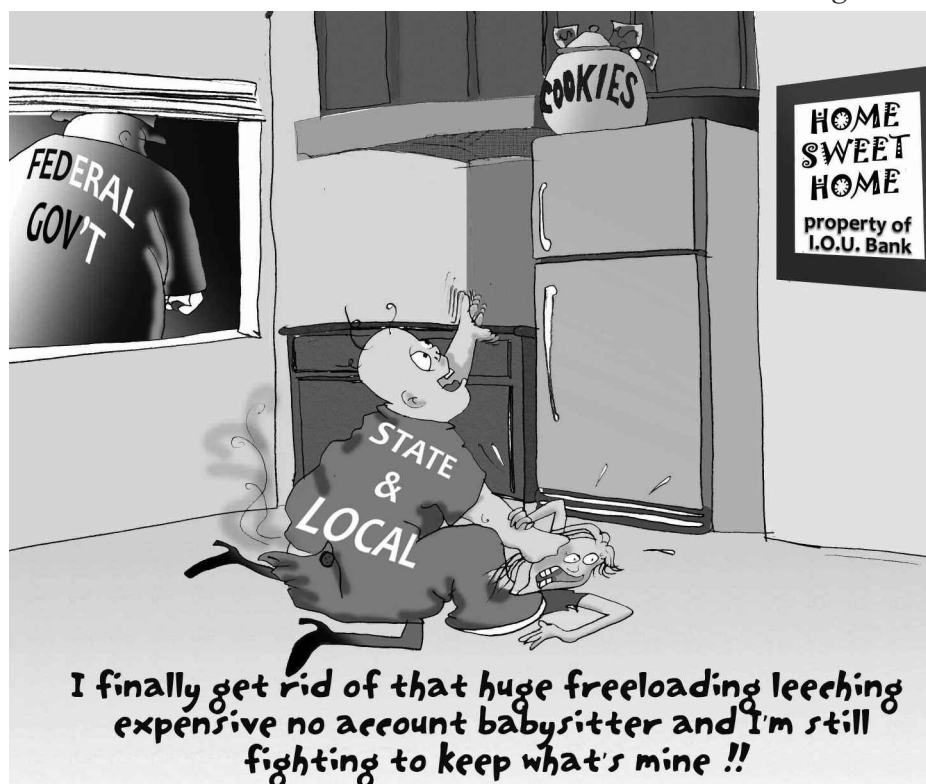

emphasis-Editor) as fast as it ripens, will germinate from the seed...and will produce other trees and grow into more property; but so long as it is fruit merely, and plucked (severed) (courts emphasis-Editor) to eat... it is no tree, and will produce itself no fruit." (Does not produce "income-Editor) Waring v. City of Savannah. 60 Ga. 93, 100 (1878).

- "Income within the meaning of the Sixteenth Amendment and Revenue Act, means 'gains' '...and in such connection 'gain' means profit...proceeding from property, severed from capital, however invested or employed and coming in, received or drawn by the taxpayer, for his separate use, benefit and disposal..."

- "Income is not a wage or compensation for any type of labor. Staples v. U.S., 21 F Supp 737 U.S. Dist. Ct. ED PA, 1937].

- "There is a clear distinction between 'profit' and 'wages' or 'compensation for labor.' Compensation for labor cannot be regarded as profit within the meaning of the law... The word profit is a different thing altogether from mere compensation for labor... The claim that salaries, wages and compensation for personal services are to be taxed as an entirety and therefore must be returned by the individual who performed the services which produced the gain is without support either in the language of the Act (16th Amendment-Editor) or in the decisions of the courts construing it and is directly opposed to provisions of the Act and to Regulations of the Treasury Department..." U.S. v. Balard, F. 2D 400

(1976), Oliver v. Halstead, 196 VA 992; 86 S.E. Rep. 2D 858:

- "Income is something that has grown out of capital, (i.e. wages produce something that grows to be MORE than the capital or portion of wages invested-Editor) leaving the capital unimpaired and intact." Gavit v. Irwin. (D.C.) 275 F. 643, 645.

- "Income, as defined by the Supreme Court means, 'gains and profits as a result of corporate activity and profit gained through the sale or conversion of capital assets.' Stanton v. Baltic Mining Co. 240 U.S. 103.

OK... take a breath... and don't let the "legalese" overwhelm you. Here's the jist of it... Your wage is an even exchange for your labor. You had to spend this labor, and you were paid for this. THERE IS NO LEGAL "GAIN" OR PROFIT in an even exchange. Remember what the courts stated... that "income" or "gain" is something that is "derived from" wages, or capital.

Your wage is your capital you received as an even exchange for your labor, but this is NOT "income." You take this "capital" and invest it, and it produces something MORE... above the original invested value... "derived from" the capital, and THIS, and THIS ALONE, is legal "income."

So does this mean you have to pay taxes on such things as interest gained, or other "income" that is "produced "FROM" your wages? YES, but it can only be taxed by government as either "direct" or "indirect," and the IRS taxes everyone outside either of these means, STILL making it unconstitutional, and therefore you are NOT required to obey an

unconstitutional "law" because it was void from the day it was inacted...

""When an act of the legislature is repugnant or contrary to the constitution, it is, ipso facto, void." 2 Pet. R. 522; 12 Wheat. 270; 3 Dall. 286; 4 Dall. 18. See also NORTON v. SHELBY COUNTY, 118 U.S. 425 (1886).

The 16th Amendment did nothing to create a change in the Constitutional taxation provisions as some might think...

"It manifestly disregards the fact that by the previous ruling it was settled that the provisions of the 16th Amendment conferred no new power of taxation." Evans vs. Gore, 253 US 245, 263 (1920).

So, all wages, salaries and compensation for work you do is NOT legal income, you are NOT a "taxpayer" until legally made so, and your wages do NOT make this happen. You cannot be liable for something that is not a legal fact.

It is a hard thing to accept and believe that we have been deceived all these years by a system that was designed to steal our money, under the color of law, so we could NOT produce "income," or more "trees," and more "property," in order to gain wealth and prosperity for ourselves and our children.

This is a simple, yet powerful truth that all American's can and should stand on to take back their rights, and put this monster called the IRS away for good.

For instance, in Galatians 1:6, it's rendered as "removed."

"I marvel that ye are so soon removed from him that called you into the grace of Christ unto another gospel." OK, now back to Enoch.

Enoch was a preacher of righteousness and we're told that he "walked with God" (Genesis 5:22) and that "God took him" (5:24).

Incidentally, Scripture also says "Noah walked with God," and Noah did not vanish into thin air to dwell with God in heaven. Noah died at the ripe old age of 950 (Genesis 9:29).

As mentioned before, "By faith Enoch was translated that he

should not see death; and was not found, because God had translated him: for before his translation he had this testimony, that he pleased God."

We already know that Enoch did in fact die, so what does it mean when the Bible says "God took him," "God had translated him" and that he should "not see death"?

"It means exactly what it says," Kovacs explains. "God literally took him. God transported or removed Enoch from his location so that he would not be found. Why? Because apparently there were people who wanted him dead."

More specifics about Enoch are provided in Jude 14, 15 where it mentions Enoch blasting false

prophets: "And Enoch also, the seventh from Adam, prophesied of these, saying, Behold, the Lord cometh with ten thousands of his saints, To execute judgment upon all, and to convince all that are ungodly among them of all their ungodly deeds which they have ungodly committed, and of all their hard speeches which ungodly sinners have spoken against him."

Enoch was a tough talker of his day, preaching a righteous message the ungodly of the world did not wish to hear. So it's not hard to understand that some of these wicked guys wanted to kill him.

"We're not given the details," says Kovacs, "but we are told that God transferred Enoch so that he would 'not see death,' in other words, not be slain. Remember, God also transported Elijah

miraculously, airlifting that prophet to another location.

Elijah did not go to the heaven of God's home, but merely to the 'first heaven,' the sky, and came back to live out the rest of his days right here on Earth. He even wrote some less-than-pleasant mail to the evil King Jehoram of Judah after his famous angelic chariot ride in the sky." (see 2 Chronicles 21:12-15)

"God took Enoch away from those looking to murder him, but the Holy Scriptures tell us outright that Enoch eventually died, not having received the promises. It's time to put away the fables and get back to the facts. The Bible does agree with itself when people read all of it."

Common Sense By Lenny Cacchio

"Common Sense" was Thomas Paine's pamphlet from Revolutionary days written with the intent of convincing reluctant colonists that rebellion against the King was not only permissible, it was also a duty. Paine's frequent reference to Scripture is remarkable, especially because, as a Deist, he rejected the inspiration of Scripture as the Word of God. That's a lesson about propagandists: they can be fundamentally dishonest people who will say whatever it takes to get the rest of us to agree with them.

Having said that, propagandists can serve an interesting function for the historian. Propaganda has a better chance of achieving its desired impact if it repeats back to people what they are already thinking, even though those thoughts might have yet to coalesce into words. As such, "Common Sense" provides us with insight into the thinking of those early Patriots who fought and died to give us a Republic.

Paine drew heavily upon the Scottish/Presbyterian tradition as expressed by theologian s Samuel Rutherford (1600 – 1661) and John Witherspoon (a Founding Father and President of Princeton). These men opposed the common belief in the Divine Right of Kings and accepted the concept of "Lex Rex", meaning "The Law Is King."

The idea of Lex Rex is central to the founding documents of the United States. From it grew the principle that even the government is under the law, that governments cannot grant rights, but can only take them away, that such rights are endowed by our Creator, and that any government that would remove such rights without due process is contrary to the Laws of Nature and Nature's God. In such instances, the people would be justified in asserting their rights to change such governments.

Paine's frequent references to Scripture in spite of his own Deism lays bare the thoughts common among the colonists of the day. Among them:

- Government by Kings was first introduced to the world by heathens, from whom the children of Israel copied the custom.
- Gideon refused the offer of kingship by saying, "I will not rule over you, neither shall my son rule over you." Says Paine, "Gideon doth not decline the honor, but denieth their right to give it."
- God laments the demand of the people in Samuel's day for a king, observing their impure motives "that they might be like unto other nations, whereas their true glory lay in being unlike them as possible," and further noting God's comment that, by demanding a king, "they have rejected me, that I should not reign over them."

By these and other examples, Paine argues that monarchy was an illegitimate form of government because sovereignty resides in the people. Too much power residing in the hands of one man will lead to tyranny, and Paine quotes a long passage from I Samuel that lists the tyrannies that would be visited upon a nation that traded its freedom in order to be like other nations, including a military draft, high taxation, eminent domain, nationalization of private enterprise, and in short control over people's lives and livelihoods.

George Washington clearly lived these principles when, at the end of the Revolution, he could have seized the government, but instead surrendered his commission to Congress, returned the army to its control, and returned to private citizenship at Mount Vernon.

The call to be unique in the world ("unlike them as possible," to quote Paine) is an unspoken part of our heritage, one that each generation must accept and pass on to the next. I pray that our generation won't sell it for a bowl of red soup.

(Editor’s Note: The Bowl of “Red Soup” is reference to Esau (Gen. 25:27-34) who held the family birthright, but who was really hungry one day and sold it all for this one bowl of quick, temporary satisfaction, quite like what is happening across America with our birthright).

## Blending Natural Healing With Modern Medicine Dr. Lauren Cohen, D.C.

It is often thought that when using health care, one must make a choice between the medical and the natural healing worlds. The natural healing arts are often termed "alternative". Nothing could be further from the truth. These approaches are not mutually exclusive. On the contrary, when we understand the nature, purpose, and strengths of each approach, we are able to utilize the various forms of health care in an Integrated or Complimentary way to achieve the highest levels of health and healing.

First, it is important to mention that the intention of all members of the healthcare community, whether medical or natural, is to provide the best care possible within the model they practice. As consumers, it is important to understand what each model offers so that we are able to make informed choices about which practitioners and which modalities will be best suited for our particular healthcare needs. In order to make these choices, we must first understand the paradigm or come-from of each of the models.

The Allopathic model defines health according to the absence of symptoms. When symptoms are present, we are considered sick; when they are not, we are considered healthy. The intent of allopathic care is to manage, reduce and/or eliminate symptoms. This is the predominant model in our culture and the model upon which the American medical approach is based. Medications may be used as part of the treatment and are intended to alleviate the symptoms the patient is experiencing. This model is used when there is a need to intervene

with a particular physiological process. The primary focus is on the breakdown within the system attempting to slow down the progression of long term effects of the breakdown itself.

The Natural or Wellness healing modalities, on the other hand, defines health based on the presence of positive attributes such as energy, vitality and life satisfaction. Therefore, the focus is on reconnecting and enhancing a person's natural functions. Natural healthcare is founded in two concepts or philosophies. Holism sees that all organs and systems function as one interconnected unit and in turn holistic therapies treat the individual as a whole. Vitalism recognizes that the body has an intrinsic ability to heal itself, and the role of the practitioner is to facilitate the body's ability to restore the in-born or innate abilities, thereby allowing the individual to return to their intended, healthy state of function and being. Symptoms are seen as communications of an underlying imbalance within the system, that when addressed properly, the imbalance is corrected and with it, the symptom. Procedures and natural supplementation may be used to support a greater connection within the body's internal systems, such as the nervous system, hormonal or endocrine system, and energetic systems, and to lend support to the normal function of the body's cells, tissues and organs. By supporting the existing systems to return to their normal function, natural practitioners strengthen the individual's natural, healthy state.

Confusion often arises for consumers when they do not recognize these differences. For example, it is not uncommon for a person to try a natural approach while applying an allopathic expectation; or, to engage in a

medical approach while applying a holistic or Vitalistic expectation. In either circumstance, disappointment is usually the result. Because a natural approach is intended to rebuild and/or strengthen, which is a process oriented approach, a consumer looking for an immediate intervention may be confused by the lack of an immediate result. On the other hand, the medical or allopathic models focus on controlling or containing the symptom or breakdown, which is an event oriented approach. A consumer looking to regain their health once the crisis is over, may be frustrated with the lack of supportive care to help them achieve that goal.

Therefore, it is important for each consumer to be clear on what they would like to accomplish. Are they looking to simply address the symptom? Are they looking to restore or strengthen their body's natural balance and function? Or, are they looking for a combination of both? Which model one chooses will be in direct response to the result they would like to accomplish. By understanding the strength of each model, a consumer can now utilize each approach individually or in combination to achieve their ultimate health care goals.

Natural approaches are not based on symptom care, therefore, having a symptom is not a prerequisite for entry. This enables a person to strengthen their body's abilities and lessens the likelihood of system breakdown. Should a breakdown occur, a body that is healthier is better suited to receive and utilize the medical care provided. As the medical treatment addresses the breakdown directly, the natural care enhances the supportive systems of the body necessary for overall stability and healing. After a person is stabilized, natural modalities will also assist the person in restoring the body back to its normal healthy physiological state.

Although there may be times where one approach is clearly more suited to a situation, integration of medical and natural modalities provides a broader base in establishing the overall health of an individual. By understanding the distinctions, the intentions and the strengths of each approach, one can integrate their care to receive the best of both worlds.

Agriculture's (USDA) revised rule on National Organic Standards (NOS), despite over 100 comments, those concerned about fluoride were ignored. Incredibly, the new standards allow the use of the toxic substance sodium fluoride in organic agriculture. Fluoride is a persistent and non-degradable poison that accumulates in soil, plants, wildlife, and humans. Many organic farmers may be unaware that this highly toxic substance has been allowed for use in the NOS, because its presence is hidden.

To call sodium fluoride an "inert" is Orwellian and defies one of the NOS's stated principles: producers shall not use "natural poisons such as arsenic or lead salts that have long-term effects and persist in the environment." Fluoride is clearly in this category.

## H.R. 875 & S. 425 - Food Safety Modernization Act of 2009

H.R. 875 and S. 425 are abomination bills created specifically for big agribusiness, and against organic food growers and small farms and even home gardeners. The Food Safety Modernization Act of 2009 (H.R. 875) will create a new food safety bureaucracy, and require a "traceability" program for "food production facilities and food establishments."

These new farm "safety bills" were sponsored by agribusiness giants Monsanto, Cargill, Tyson, and ADM.

Example of the dangers these bills bring:

- \* Effectively criminalizes organic farming but doesn't actually use the word organic.
- \* Effects anyone growing food even if they are not selling it and only consuming it.
- \* Effects anyone producing meat of any kind including wild game.
- \* Legislation is so broad based that every aspect of personally growing or producing food can be made illegal.
- \* Section 207 requires that the state's agriculture dept act as the food police and enforce the federal requirements. This takes away the states power and is in violation of the 10th amendment.
- \* Forcing cattle owners to use NAIS "840" RFID (radio frequency identification) tags when they participate in vaccination programs
- \* Increasing compliance in the sheep and goat industries through new regulations and "increased

emphasis on enforcement."

\* Requiring premise registration for horse owners who must submit their horses for EIA testing 98% compliance by July 2009 for poultry and swine 90% compliance by July 2009 for horses, sheep, and goats 60% compliance by Oct 2010 for cattle

These figures reflect the USDA's goal of near-total control of every aspect of the livestock industry.

Under the bills, the Department of Agriculture will be able to order organic farmers what to feed their animals, how to medically treat them and what toxic sprays to use. There would also be penalties beyond the ability of most small farmers to pay.

Buried in the bills are regulations that criminalize all aspects of organic farming by listing them as 'sources of seed contamination.' The bills would industrialize farms, force farmers to buy chemicals and drugs and/or face \$500,000 in penalties.

**Pest chemical found to be a Greenhouse Gas** (Organic Consumers Association - Organic Bytes Newsletter, March 19, 2009 - Issue #166 -[organicconsumers.org](http://organicconsumers.org)).

Sulfuryl fluoride (SO2F2), a gas commonly used to rid buildings of termites and other pests, is a greenhouse gas that remains in the atmosphere about 36 years, six to 10 times longer than previously thought, according to a research team led by Jens Mühle, an atmospheric chemist at Scripps Institution of Oceanography, UC San Diego.

### Soy... Friend or foe?

Far from being the perfect food, modern soy products contain antinutrients and toxins and they interfere with the absorption of vitamins and minerals.

Soy also contains goitrogens - substances that depress thyroid function, haemagglutinin, a clot-promoting substance that causes red blood cells to clump together, and potent enzyme inhibitors that block the action of trypsin and other enzymes needed for protein digestion.

In test animals, diets high in trypsin inhibitors cause enlargement and pathological conditions of the pancreas, including cancer.

Soybeans are high in phytic acid, present in the bran or hulls of all seeds. It's a substance that can block the uptake of essential minerals - calcium, magnesium, copper, iron and especially zinc - in the intestinal tract.

### Organic Cuba

Since 1990, Cuba has carried out the world's most comprehensive and successful organic food and farming revolution, including the ongoing cultivation of over 60,000 organic urban gardens that supply 50-80% of its urban food needs.

Cutting off trade with Cuba forced the

population to live by their own means. Over time, urban areas in place like Havana have overtaken wasted space with a vast tapestry of medicinal and food gardens. The current Cuban urban agriculture model has become one of the most sophisticated and sustainable organic farming operations in the world. ### North American Oil Reserves

The Bakken, under North Dakota, western South Dakota, and extreme eastern Montana is the largest domestic oil discovery since Alaska 's Prudhoe Bay , and has the potential to eliminate all American dependence on foreign oil. The Energy Information Administration (EIA) estimates it at 503 billion barrels. Even if just 10% of the oil is recoverable... at \$107 a barrel, we’re looking at a resource base worth more than \$5.3 trillion.

The problem is real. The United Nations forecasts that by 2030, nearly half of the world’s population will be living in areas of high water stress, and climate change is compounding the problem according to a UN report released to coincide with the Istanbul conference. Global warming is causing droughts in some areas and floods in others. In Africa alone, between 75 million and 250 million people may experience increased water stress due to climate change by 2020, warns the report. Water scarcity could displace as many as 700 million people.

**Is decentralization the future of sustainable energy?** Source: European Commission, Environment DG

A team of German scientists has taken a look into the future in a unique evaluation of decentralized electricity generation. They found that there are a number of factors that affect the sustainability of decentralization. These must be fully considered in order to properly evaluate proposed changes to the power grid.

decentralization consists of small plants or even microgenerators that produce power close to its point of use, rather than relying on a central, distributed power grid. This could take the form of an industrial combined heat and power (CHP) plant, where waste products are incinerated onsite, or small, domestic units - such as solar panels or wind turbines attached to individual houses. The shift towards decentralisation can be seen in many industrialized countries. But whether it is sustainable compared with a centrally controlled grid is under debate.

**Australian Gun Law Update**  
Ed Chenel, A police officer in Australia.

It has now been one year (12 months) since gun owners in Australia were forced by a new law to surrender 640,381 personal firearms to be destroyed by our own government, a program costing Australia taxpayers more than \$500 million dollars.

The first year results are now available: -  
• Australia-wide, homicides are up 6.2 percent;  
• Australia-wide, assaults are up 9.6 percent;  
• Australia-wide, armed robberies are up 44 percent (yes, 44 percent);

In the state of Victoria alone, homicides with firearms are now up 300 percent as compared with the last one-year period when private ownership of a firearm was legal.

(NB: the law-abiding citizens did turn in their personal firearms, the criminal element did not and thus criminals in Australia still possess their guns.)

While data for the 25 years preceding the confiscation of privately owned guns showed a steady decrease in armed robbery with firearms, this has changed drastically upward in the past 12 months as criminals now are assured their victims will be unarmed.

There has also been a dramatic increase in break-ins and assaults of the elderly, while the resident is at home.

Australian politicians are at a loss to explain how public safety has decreased, after such monumental effort and expense was expended in ‘successfully ridding Australian society of guns.’

This story of well intentioned government intervention in the rights of lawful individuals to own and possess firearms won’t be seen either in the Canadian or American mainstream media or on the evening news.

If President Obama advocates a similar confiscation in the US, there will not be any reporting any of this to you.

Sixtieth Legislature First Regular Session 2009, IN THE HOUSE OF REPRESENTATIVES, HOUSE JOINT MEMORIAL NO. 3, BY STATE AFFAIRS COMMITTEE. A JOINT MEMORIAL TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE UNITED STATES IN CONGRESS ASSEMBLED, AND TO THE CONGRESSIONAL DELEGATION REPRESENTING THE STATE OF IDAHO IN THE CONGRESS OF THE UNITED STATES.

We, your Memorialists, the House of Representatives and the Senate of the State of Idaho assembled in the First Regular Session of the Sixtieth Idaho Legislature, do hereby respectfully represent that:

WHEREAS, the Second Amendment of the United States Constitution does not simply provide for a collective right or a right for the

states to establish militias, rather it provides for the right of the people to keep and bear arms, and

WHEREAS, the primary purpose of the right to keep and bear arms is to protect one’s self, family and possessions from either the private lawlessness of other persons or the tyranny of governments, and

WHEREAS, the right to keep and bear arms is also meant to protect the general private uses of firearms in activities such as hunting and other sporting activities, and

WHEREAS, the United States Supreme Court in District of Columbia v. Heller, 128 S.Ct. 2783 (2008), recently struck down a firearms ban in the District of Columbia, explicitly ruling that the Second Amendment protects the right of the people to possess firearms for private uses, and

WHEREAS, despite this ruling, legislation has been introduced in the United States House of Representatives calling for a system of mandatory federal licensing of all firearm owners, and

WHEREAS, the legislation introduced would require all firearm owners to apply for and carry a federally issued picture identification in order to keep any firearm in their homes, and

WHEREAS, the legislation introduced would make it a federal crime to keep a loaded firearm or an unloaded firearm and ammunition within any premises including, under certain circumstances, American homes where a child may be present, and

WHEREAS, the legislation introduced specifically purports to preempt any state or local law inconsistent with it, and

WHEREAS, the introduced legislation, Blair Holt’s Firearm Licensing and Record of Sale Act of 2009, is a direct imposition on each American’s individual right to keep and bear arms in their homes and for their protection.

NOW, THEREFORE, BE IT RESOLVED by the members of the First Regular Session of the Sixtieth Idaho Legislature, the House of Representatives and the Senate concurring therein, that members of the United States Congress cease and desist attempting to enact federal legislation impinging on the individual right of every American to keep and bear arms in any manner. Specifically, that members of Congress oppose the passage of the Firearm Licensing and Record of Sale Act of 2009, and any similar legislation.

BE IT FURTHER RESOLVED that the Secretary of the Senate be, and she is hereby authorized and directed to forward a copy of this Memorial to the President of the Senate and the Speaker of the House of Representatives of Congress, and the congressional delegation representing the State of Idaho in the Congress of the United States.

## OBAMA EFFORT TO END ARMED PILOTS PROGRAM AN OUTRAGE

BELLEVUE, WA – A revelation by the Washington Times that President Barack Obama is trying to quietly end the armed pilot program, making air travel more vulnerable to terrorist attack, should outrage travelers, the Citizens Committee for the Right to Keep and Bear Arms said today.

“The Washington Times nailed it,” said CCRKBA Chairman Alan Gottlieb, who proposed arming pilots just hours after the Sept. 11, 2001 terrorist attacks and championed the armed pilot program. “What Obama is doing is risking public safety, as the newspaper put it, ‘in the name of an anti-gun ideology.’”

The newspaper reported in its Tuesday edition that President Obama is “quietly ending the federal firearms program” by diverting some \$2 million from the training program to hire “supervisory” staff, whose job, it appears, will be to harass armed pilots through unnecessary field inspections.

**Memos Provide Blueprint for Police State** - by Marjorie Cohn

Seven newly released memos from the Bush Justice Department reveal a concerted strategy to cloak the President with power to override the Constitution. The memos provide “legal” rationales for the President to suspend freedom of speech and press; order warrantless searches and seizures, including wiretaps of U.S. citizens; lock up U.S. citizens indefinitely in the United States without criminal charges; send suspected terrorists to other countries where they will likely be tortured; and unilaterally abrogate treaties. According to the reasoning in the memos, Congress has no role to check and balance the executive. That is the definition of a police state.

Who wrote these memos? All but one were crafted in whole or in part by the infamous John Yoo and Jay Bybee, authors of the so-called “torture memos” that redefined torture much more narrowly than the U.S. definition of torture, and counseled the President how to torture and get away with it. In one memo, Yoo said the Justice Department would not enforce U.S. laws against torture, assault, maiming and stalking, in the detention and interrogation of enemy combatants.

What does the federal maiming statute prohibit? It makes it a crime for someone "with the intent to torture, maim, or disfigure"

to "cut, bite, or slit the nose, ear or lip, or cut out or disable the tongue, or put out or destroy an eye, or cut off or disable a limb or any member of another person." It further prohibits individuals from "throwing or pouring upon another person any scalding water, corrosive acid, or caustic substance" with like intent.

The two torture memos were later withdrawn after they became public because their legal reasoning was clearly defective. But they remained in effect long enough to authorize the torture and abuse of many prisoners in U.S. custody.

The seven memos just made public were also eventually disavowed, several years after they were written. Steven Bradbury, the Principal Deputy Assistant Attorney General in Bush’s Department of Justice, issued two disclaimer memos – on October 6, 2008 and January 15, 2009 – that said the assertions in those seven memos did “not reflect the current views of this Office.” Why Bradbury waited until Bush was almost out of office to issue the disclaimers remains a mystery. Some speculate that Bradbury, knowing the new administration would likely release the memos, was trying to cover his backside.

Indeed, Yoo, Bybee and Bradbury are the three former Justice Department lawyers that the Office of Professional Responsibility singled out for criticism in its still unreleased report. The OPR could refer these lawyers for state bar discipline or even recommend criminal charges against them.

In his memos, Yoo justified giving unchecked authority to the President because the United States was in a “state of armed conflict.” Yoo wrote, “First Amendment speech and press rights may also be subordinated to the overriding need to wage war successfully.” Yoo made the preposterous argument that since deadly force could legitimately be used in self-defense in criminal cases, the President could suspend the Fourth Amendment because privacy rights are less serious than protection from the use of deadly force.

Bybee wrote in one of the memos that nothing can stop the President from sending al Qaeda and Taliban prisoners captured overseas to third countries, as long as he doesn’t intend for them to be tortured. But the Convention Against Torture, to which the United States is a party, says that no country can expel, return or extradite a person to another country “where there are substantial grounds for believing that he would be in danger of being subjected to torture.” Bybee claimed the Torture Convention didn’t apply extraterritorially, a proposition roundly debunked by reputable scholars. The Bush administration reportedly engaged in this practice of extraordinary rendition 100 to 150 times as of March 2005.

The same day that Attorney General Eric Holder released the memos, the government revealed that the CIA had destroyed 92 videotapes of harsh interrogations of Abu Zubaida and Abd al Rahim al Nashiri, both of

## What does the Supreme Law of the Land tell us? (Conclusion)

Continuing with this issue, we are printing the first portion of the Constitution itself. Note some highlighted text as this pertains to not only the illegal application of the income tax, (See page ?? for discussion on types of taxes) but the unconstitutional application of our financial system. If we are not complying with the Constitution, we are acting illegally, and our leaders have been doing this for many decades.

### Constitution Continued!

#### Article III - The Judicial Branch Note

##### Section 1 - Judicial powers

The judicial Power of the United States, shall be vested in one supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good Behavior, and shall, at stated Times, receive for their Services a Compensation which shall not be diminished during their Continuance in Office.

##### Section 2 - Trial by Jury, Original Jurisdiction, Jury Trials

(The judicial Power shall extend to all Cases, in Law and Equity, arising under this Constitution, the Laws of the United States, and Treaties made, or which shall be made, under their Authority; to all Cases affecting Ambassadors, other public Ministers and Consuls; to all Cases of admiralty and maritime Jurisdiction; to Controversies to which the United States shall be a Party; to Controversies between two or more States; between a State and Citizens of another State; between Citizens of different States; between Citizens of the same State claiming Lands under Grants of different States, and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects.) (This section in parentheses is modified by the 11th Amendment.)

In all Cases affecting Ambassadors, other public Ministers and Consuls, and those in which a State shall be Party, the supreme Court shall have original Jurisdiction. In all the other Cases before mentioned, the supreme Court shall have appellate Jurisdiction, both as to Law and Fact, with such Exceptions, and under such Regulations as the Congress shall make.

The Trial of all Crimes, except in Cases of Impeachment, shall be by Jury; and such Trial shall be held in the State where the said Crimes shall have been committed; but when not committed within any State, the Trial shall be at such Place or Places as the Congress may by Law have directed.

##### Section 3 - Treason Note

Treason against the United States, shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same overt Act, or on Confession in open Court.

The Congress shall have power to declare the Punishment of Treason, but no Attainder of Treason shall work Corruption of Blood, or Forfeiture except during the Life of the Person attainted.

#### Article IV - The States

##### Section 1 - Each State to Honor all others

Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State. And the Congress may by general Laws prescribe the Manner in which such Acts, Records and Proceedings shall be proved, and the Effect thereof.

##### Section 2 - State citizens, Extradition

The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several States.

A Person charged in any State with Treason, Felony, or other Crime, who shall flee from Justice, and be found in another State, shall on demand of the executive Authority of the State from which he fled, be delivered up, to be removed to the State having Jurisdiction of the Crime.

(No Person held to Service or Labour in one State, under the Laws thereof, escaping into another, shall, in Consequence of any Law or Regulation therein, be discharged from such Service or Labour, But shall be delivered up on Claim of the Party to whom such Service or Labour may be due.) (This clause in parentheses is superseded by the 13th Amendment.)

##### Section 3 - New States

New States may be admitted by the Congress into this Union; but no new States shall be formed or erected within the Jurisdiction of any other State; nor any State be formed by the Junction of two or more States, or parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

The Congress shall have Power to dispose of and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing in this Constitution shall be so construed as to Prejudice any Claims of the United States, or of any particular State.

##### Section 4 - Republican government

The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

#### Article V - Amendment Note1 - Note2 - Note3

The Congress, whenever two thirds of both Houses shall deem it necessary, shall propose Amendments to this Constitution, or, on the Application of the Legislatures of two thirds of the several States, shall call a Convention for proposing Amendments, which, in either Case, shall be valid to all Intents and Purposes, as part of this Constitution, when ratified by the Legislatures of three fourths of the several States, or by Conventions in three fourths thereof, as the one or the other Mode of Ratification may be proposed by the Congress; Provided that no Amendment which may be made prior to the Year One thousand eight hundred and eight shall in any Manner affect the first and fourth Clauses in the Ninth Section of the first Article; and that no State, without its Consent, shall be deprived of its equal Suffrage in the Senate.

##### Article VI - Debts, Supremacy, Oaths

All Debts contracted and Engagements entered into, before the Adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation.

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.

The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution; but no religious Test shall ever be required as a Qualification to any Office or public Trust under the United States.

##### Article VII - Ratification Documents

The Ratification of the Conventions of nine States, shall be sufficient for the Establishment of this Constitution between the States so ratifying the Same.

Done in Convention by the Unanimous Consent of the States present the Seventeenth Day of September in the Year of our Lord one thousand seven hundred and Eighty seven and of the Independence of the United States of America the Twelfth. In Witness whereof We have hereunto subscribed our Names. Note

whom were subjected to waterboarding. The memo that authorized the CIA to waterboard, written the same day as one of Yoo/Bybee’s torture memos, has not yet been released.

Bush insisted that Zubaida was a dangerous terrorist, in spite of the contention of one of the FBI’s leading al Qaeda experts that Zubaida was schizophrenic, a bit player in the organization. Under torture, Zubaida admitted to everything under the sun – his information was virtually worthless.

There are more memos yet to be released. They will invariably implicate Bush officials and lawyers in the commission of torture, illegal surveillance, extraordinary rendition, and other violations of the law.

Meanwhile, John Yoo remains on the faculty of Berkeley Law School and Jay Bybee is a federal judge on the Ninth Circuit Court of Appeals. These men, who advised Bush on how to create a police state, should be investigated, prosecuted, and disbarred. Yoo should be fired and Bybee impeached.

“How dare the president, or anybody in his administration, take measures to erode the safety of air travelers,” Gottlieb questioned. “The armed pilot program provides a guaranteed level of security to the public. There may or may not be an air marshal aboard every airplane, but there is definitely a pilot in the cockpit.

“We trust commercial airline pilots with \$500 million aircraft,” he continued. “We can certainly trust them with \$500 pistols to defend those planes, and the lives of their passengers.

“Certain individuals have never liked the armed pilot program,” Gottlieb acknowledged. “These anti-gun, anti-self-defense bureaucrats seem more interested in their own power, and protecting their little empires, than they are in protecting the public. And now, Obama is catering to their anti-gun bigotry.”

Guess what folks, Alexander Hamilton agreed with Madison in saying “We are a Republican government. Inevitably taxes rose and controls over the private sector were imposed, and soon a number of Rome's major producers could no longer make ends meet.

Productivity declined, shortages developed, and mobs began roaming the streets demanding bread and surpluses from the government. Many were induced to trade freedom for security. Eventually the whole system came crashing down around them. They

went from a Republic to Democracy to an Oligarchy under a progression of the Caesars. Sound familiar?

What is Capitalism ? Capital defined- “The means of production.” Let me give an example; A man stranded on a deserted island, cant find food, tries catching fish with his bare hands, to no avail. Finds a stick, grinds a sharp point on the end, goes and spears a fish, and then has dinner. THE SPEAR IS HIS CAPITAL, or his means of production so he can eat dinner. Every economic system, no matter the form of government, has a capitalistic form of economics. We all use tools or have capital. The main difference is not “capitalism or no capitalism,” it is “who owns the capital.”

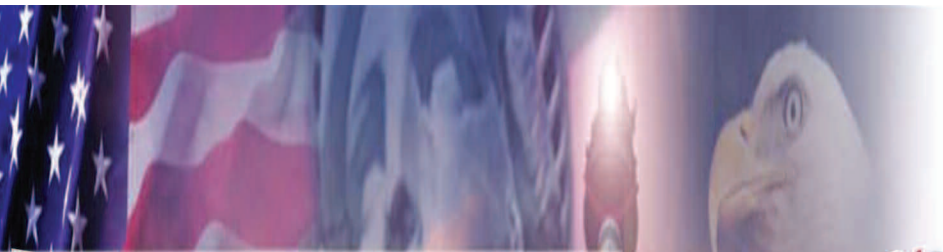

**Federal criminal complaint contends Obama ineligible**  
Ex-officer alleges prez used 'contrivance, concealment, dissembling and deceit' By Bob Unruh © 2009 WorldNetDaily.com

An ex-military officer has raised the stakes in the ongoing dispute over Barack Obama's eligibility to be president, filing a criminal complaint against the "imposter" with the U.S. attorney's office for the Eastern District of Tennessee.

Retired U.S. Navy officer Walter Francis Fitzpatrick III, who has run a campaign for two decades to uncover and try to correct what he believes are criminal activities within the military, accused the president of "treason."

In his complaint addressed to Obama via U.S. Attorney Russell Dedrick and Assistant U.S. Attorney Edward Schmutzer, Eastern District, Tennessee, Fitzpatrick wrote: "I have observed and extensively recorded insidious attacks by military-political aristocrats against the Constitution for twenty years.

"Now you have broken in and entered the White House by force of contrivance, concealment, conceit, dissembling, and deceit. Posing as an impostor president and commander in chief you have stripped civilian command and control over the military establishment."

He cited the deployment of "U.S. Army active duty combat troops into the small civilian community of Samson, Ala.," and said, "We come now to this reckoning. I accuse you and your military-political criminal assistants of TREASON. I name you and your military criminal associates as traitors. Your criminal ascension manifests a clear and present danger. You fundamentally changed our form of government. The Constitution no longer works.

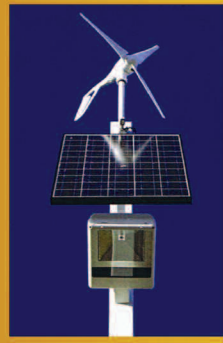
"I identify you as a foreign born domestic enemy," he wrote. That case is being handled by California attorney Orly Taitz, who is working through her Defend Our Freedoms Foundation to handle several cases raising questions over Obama's qualification to be president under the Constitution's demand that the office be occupied only by a "natural born" citizen.

Taitz was informed by Karen Thornton of the Department of Justice that all of the case documents and filings have arrived and have been forwarded to the Office of Solicitor General Elena Kagan, including three dossiers. 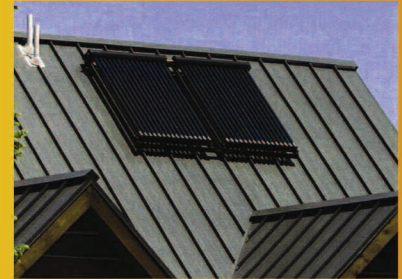
