# Act forces Congress' return to limited government - Legislator to colleagues: 'Your laws not authorized by Constitution'

As a reminder of the federal government's limited powers, 20 representatives want to ensure that every single piece of legislation passing through Congress includes a statement citing specific constitutional authority for enacting it.

Sponsored by Rep. John Shadegg, R-Ariz., H.R. 450, or the Enumerated Powers Act, states, "Each Act of Congress shall contain a concise and definite statement of the constitutional authority relied upon for the enactment of each portion of that Act. The failure to comply with this section shall give rise to a point of order in either House of Congress. ..."

# Free Press Denied Radio Talk Show:

The Free Press has been working for months to bring to the public a call-in talk radio show. We were led to believe, for the last two months, that we would be able to purchase a one hour spot on 1400 AM once a week, for a talk show where we would allow the general public to call and have a voice about local and national issues. We had worked out a legitimate contract with a radio station and through much negotiation and agreement of the needs of both parties.

Although the agreement to date was strictly verbal, we had already beat the bush for our sponsors and received huge interest and support for the show. When we approached the station about finalizing the deal, paying for our spot, and beginning the broadcast we were handed off to an associate of the owner who became the bringer of bad news for the Free Press and the interested parties of the Free Press Radio Show.

“We regret to inform you that apparently talk radio does not fit the bill for this station

format.” They believe it will disrupt the interest of all the people who listen to music on 1400 AM during the 1pm hour.

Although we believe there may be more to this story and the reason for the denial of our legitimate business offer to this station, at this time, we can not prove it.

It’s possible that the authorities simply do not want the public to have access to the local radio waves for fear it is a format of communication that would be a means of exposing any and all corruption that may exist on local and national issues, as well as working with the public in getting organized to keep the Government accountable to its citizens.

Is it possible that the power structure currently in place, or those that are happy with the current situations, do not want to hear from those that do have issues of accountability they want addressed ?

Not to worry, the Free Press will not be stopped so easily. We are currently looking at all the alternatives we have to bring the local public a voice on the air waves. We have been approached by certain individuals who are willing to put the funds up to create our own radio station here in town, or the possibility of broadcasting from a Farmington or Durango station.

We believe this to be a bad business decision for this radio station, and disservice to citizens. We wonder how many people actually listen to music on 1400 AM at the 1pm hour, we also will be inquiring as to the legality of denying equal opportunity business interests especially where access to the media is concerned, or who else has been denied a radio talk show in the area?

Please let us hear from you... We need the publics support on these issues. When we the people yell loud enough, we will be heard in one way or another.

If you would like a talk radio show, let us know. This would be a great medium to get information out on a regular basis and by owning our own transmitter, we could provide 24 hour material from all across the country.

## Celente: “America Lives in a Fascist State”

The merger of corporate and government powers in modern America is plain and simple fascism, believes Gerald Celente, the founder of the Trends Research Institute and publisher of Trends Journal.

Celente takes an in-depth look at what AIG and Goldman Sachs really are and the people behind them; explains the policies of the Obama’s administration, and the moral basis for a forthcoming new American Revolution.

RT: I’d like to begin by talking about the Treasury department. They’ve decided to extend bailout funds to a number of struggling life insurance policies. This is in addition to the auto industry and the banks. Do you think Americans are aware of what’s going on?

G.C.: They know about it, it’s a new trend. America is going from what used to be the major capitalistic country in the world of free market – a crusader – into what Mussolini would have called fascism: the merger of state and corporate powers. So it is not socialism as people believe, it is socialism’s egalitarianism. It’s not communism where the state controls monopolies – it’s fascism, plain and simple. The merger of corporate and government powers. State-controlled capitalism is called fascism, and fascism has come to America in broad daylight. But they’re feeding them it in little bits and pieces. First AIG was too big to fail. Mortgage companies Fannie Mae and Freddie Mac were too big to fail. Banks too big to fail and auto companies. And now we give money to the people that make the auto parts. And now there’s talk about the technology companies, wanting their piece of the action. The merger of state and government is called fascism. Take it from Mussolini; he knew a thing or two about it.

RT: What can Americans do if they are opposed to the road that government officials are bringing them down?

G.C.: The people don’t really have a choice, there is no ballot box. I’m of Italian descent and I’ve heard enough of mafia stories for the rest of my life. If you want to look at a mafia, you can call it a republican and democratic party. And if you want to look at the two families, the heads of the mafia, all you have to do is to look at the Bushes and the Clintons. They’ve been running the show now for some 24 years. We heard about Obama who is going to bring in ‘change’. A change you could believe in if he is dumb, stupid and blind. Look who he’s brought in as his chief policy makers. Retreads from the old Clinton administration. It’s a two-headed one-party system. So it’s very difficult for the people to vote in a new administration that isn’t part of the old one.

RT: Can you tell me one thing that you like about President Obama?

G.C.: In the Trends Journal, the top trends of 2009, one of our trends was that people are going to be putting out ‘recession gardens’. And now as we see the Obamas, they are planting their own garden, and that

trend is taking hold. So he is doing that in positive ways, he’s bringing an element of dignity back to society. Those are positives. But now let me look at whether it’s true or the hypocrisy. So, they are talking about planting their own gardens. And they are talking about buying local. Oh, all that is wonderful, but on the other side of the coin they are pushing genetically modified foods while they’re eating organic. So it’s like ‘let them eat Frankenfoods’ – this is the message. So I see hypocrisy at every level. When they show me truth and justice, and the real American way – then I’ll believe.

RT: If I revert to our previous interview, I asked you – “what kind of revolution do you think would happen and when, and why would it happen?” and you said there would be a tax revolt. And now we are hearing more and more about these ‘tea parties’. What do you make of that? Do you think that that’s just the first action and many actions to follow from the American public?

G.C.: There is going to be a lot more. This is just a beginning. As a Bronx boy, my saying is: ‘when people lose everything and they have nothing left to lose – they lose it’.

You’re gonna start to see people taking to the streets, like they do in other countries. People have had it, they are fed up. They can’t afford it anymore. Look at what is going on. Ten major states are raising taxes again as people are losing their jobs, income is going down, they are losing their pensions, they are losing their investments – and the government is saying: more taxes, more taxes, more taxes...

At the same time, what’s happening is, on the top, they are changing the regulations so the thieves could steal more, just as they did with the new banking act. They call it mark-to-market. So it is now allowing them to do rather than putting the real loss of their assets – the toxic assets that they are holding – they are letting them make up what they want! Come up with fictitious numbers and you are going to start seeing ‘bank stocks going up again’.

It is fake, and what they are doing is they’re changing the regulations on the top so the big thieves could steal more, while they clamping down on the little people – and the little people have had it.

RT: These stimulus plans, both with former President Bush and with President Obama, were rushed through so quickly and you make a comparison to the way that the US launched the War on Iraq with the same urgency of the plans.

G.C.: They push it through so that people are kept off guard – they put fear into the people’s hearts. Remember the mushroom cloud that was going to explode if we did not do it very quickly with Iraq? And remember the financial system was going to collapse if we didn’t save AIG? And who ever knew the AIG was, to begin with?! “What’s an AIG?! I’ve never heard of one before!” most people would say.

## News Briefs

### Americans Falling under the Espionage Act?

Espionage Act. Under President Wilson: It stated that anyone who disclosed information compromising national defense would face a \$10,000 fine and 20 years in prison.

The act went further than simply imprisoning people who compromised national defense, it said that “Whoever, when the United States is at war... shall willfully utter, print, write, or publish any disloyal, profane, scurrilous, or abusive language about the form of government of the United States, or the Constitution of the United States, or the military or naval forces of the United States, or the flag... shall be punished by a fine of not more than \$10,000 or imprisonment for not more than twenty years, or both....” Many people believe this to be unconstitutional.

On November 16, 1917, eight more regulations were added to the original twelve, including punishment for speaking, writing or publishing anything that was critical of the government, with a maximum penalty a \$10,000 fine and/or 20 years imprisonment.

### Bush, et al., Indictment Pending?

The imminent indictment in Spanish courts of former officials of the Bush Administration is being applauded by civil and human rights organizations and legal scholars. The popular wave of support for indictment of Bush officials will inevitably lead to Bush himself.

The rule of law, justice, and basic integrity require the indictment for criminal wrong doing of George W. Bush, Dick

Cheney, Karl Rove, Donald Rumsfeld, Alberto Gonzales and other high officials of the former Bush Administration.

### Tons of released drugs taint US water.

U.S. manufacturers, including major drugmakers, have legally released at least 271 million pounds of pharmaceuticals into waterways that often provide drinking water — contamination the federal government has consistently overlooked, according to an Associated Press investigation.

Last year, the AP reported that trace amounts of a wide range of pharmaceuticals — including

antibiotics, anti-convulsants, mood stabilizers and sex hormones — have been found in American drinking water supplies. Including recent findings in Dallas, Cleveland and Maryland's Prince George's and Montgomery counties, pharmaceuticals have been detected in the drinking water of at least 51 million Americans.

### 501(c)(3) Tax Exempt trap

Is your Church a tax Exempt government entity? If so, did you know that if your pastor says anything that the government considers to be engaging in politics (this can be most anything at all), the government can step in to cause lots of trouble and possibly even take church property? If they can take away church property, then who owns your church?

Churches Are “Automatically Tax-Exempt” regarding taxation and donations.

According to IRS Code § 508(c)(1)(A):

Special rules with respect to section 501(c)(3) organizations.

(a) New organizations must notify secretary that they are applying for recognition of section 501(c)(3) status.

(c) Exceptions.

(1) Mandatory exceptions. Subsections (a) and (b) shall not apply to—

(A) churches, their integrated auxiliaries, and conventions or associations of churches.

This is referred to as the "mandatory exception" rule. Thus, we see from the IRS' own publications, and the tax code, that it is completely unnecessary for any church to apply for tax-exempt status. In the IRS' own words a church “is automatically tax-exempt.”

The Trap? By applying for a 501(c)(3) status with the IRS, you

are applying for a privilege... which ALWAYS has strings attached, and the government can then tell you what to say and not say and control you in other ways.

### Homeland Security Secretary Apologizes... Kind of!

Homeland Security Secretary Janet Napolitano apologized to veterans after a report issued by her department said troops returning from the wars in Iraq and Afghanistan were at risk for being recruited by “right-wing extremists.”

Yes, the free press is still going... 5th paper since we took it over. We are being inundated with interest... from California to Missouri and Illinois, and finally are getting more ads to help pay for the paper.

We printed 5000 copies this last printing and ran out because of how many people and places wanted it. We were not at the Cortez tea party, but were represented at the Durango and Pagosa tea parties. The Durango tea party was a huge hit... we gave out 500+ papers at that event alone. Lots of great exposure.

We are looking for everything from ads, to letters, articles, and word of mouth support. Anything you can do to help spread the word... we welcome your interest and appreciate your willingness to spread the word.

We are strapped for distribution help... but we are getting more and more support from more and more people.

Without fanfare or even notice to the property owners the PLPOA Board of Directors voted at their April meeting to allow sewage trucks, wreckers, delivery trucks and other commercial type trucks built on one-ton truck chassis to be parked over night and longer on residential lots in PLPOA.

Why the Board decided, after 3 years, to change the commercial type truck definition to allow these commercial style trucks is anyones guess. The Master Declarations say, "No commercial type truck

shall be parked for storage over night or longer on any lot." The Vista/Trails Declarations adds no trucks larger than a pickup class can be parked. We can only wonder why the Board no longer feels that a wrecker, dump truck or other styles are no longer commercial trucks. Perhaps they believe the residents uses a tow truck as a family vehicle, or as a recreational vehicle to take on vacation. They also must believe these trucks are smaller than a pickup.

Perhaps the answer can be found in the PLPOA bylaws. The preamble says that the purpose, goals and objectives of the Association is to, "improve, protect and enhance the quality of life and environment and preserve property values at Pagosa Lakes." Are we to believe that a loaded 14000 pound delivery truck driving in and out of a residential lot will improve our roads, or that a wrecker responding to a call late at night will enhance our quality of life. Perhaps it is that a sewage truck parked next door will preserve our property values. I believe that most property owners will not believe this change meets these Association goals and objectives so why change

The second part of the bylaw preamble says to, "promote the general welfare of the members of the Association and the inhabitants of the community." Maybe this is what the Board is thinking about, owners and operators of delivery businesses, towing services, construction companies will be able to park their commercial trucks and work out of their residence saving the cost of having an office or storage place in a commercial area. The change may help commercial truck operators but what does it do for the general welfare of PLPOA members?

In 2008 the Board thought it right to more than double the number of Neighborhood Rules and Regulations and "protect" us against such offensive activity as loud talking and whistling heard from another lot. They made it an offense to store or dispose of hazardous or radioactive materials on property in the South Village Lake subdivision. They felt it important to prohibit the overnight parking of recreational vehicles in Mallard Point but not in North Village Lake even though they both have the same worded Declaration of Restriction.

They made it a requirement for animals to be confined to the area

constituting the building site in South Shore Estates. Why would the Board go to these extraordinary efforts to protect us with such rules in 2008 and yet find it okay in 2009 to allow commercial type trucks to park overnight and longer on residential properties in Pagosa Lakes?

A reasonable person would believe that this definition change allowing some commercial type trucks is not consistent with the purpose of the Declaration of Restriction prohibiting commercial type truck parking on residential lots. I can find no law that gives the Board any authority to change the meaning and intent of Declaration of Restriction without a vote of the property owners, yet they did it.

Property owners need to start getting involved in our Association. Let the Board know how you feel on these and other topics that effect your quality of life and property values. Let the Board know that you feel its only right that your opinion be solicited before they make changes that impact you. Better yet step up to the plate and run for one of the four open Board positions or apply for one of the committees and help make our Association more responsive to property owner's needs, wants and desires.

A final suggestion would be that it only takes 75 property owners signatures to place a bylaw amendment on the ballot to restrict how the Board and or the Environmental Control Committee operate. Perhaps now is the time to make them more responsive to our needs by stipulating that members should be surveyed and property owner meetings held before the Neighborhood Rules or the Building Permit Process are written or changed.

The Real Story about Capt Phillips and the Maersk Alabama

Got this from a VERY good friend who is a retired admiral. Looks like Obama and his administration are trying to take credit for the rescue when in reality they prolonged the situation.

Having spoken to some SEAL pals here in Virginia Beach yesterday and asking why this thing dragged out for 4 days, I got the following:

1. BHO wouldn't authorize the DEVGRU/NSWC SEAL

teams to the scene for 36 hours going against OSC (on scene commander) recommendation.

2. Once they arrived, BHO imposed restrictions on their ROE that they couldn't do anything unless the hostage's life was in "imminent" danger

3. The first time the hostage jumped, the SEALs had the raggies all sighted in, but could not fire due to ROE restriction

4. When the navy RIB came under fire as it approached with supplies, no fire was returned due to ROE restrictions. As the raggies were shooting at the RIB, they were exposed and the SEALs had them all dialed in.

5. BHO specifically denied two rescue plans developed by the Bainbridge CPN and SEAL teams

6. Bainbridge CPN and SEAL team CDR finally decide they have the OpArea and OSC authority to solely determine risk to hostage. 4 hours later, 3 dead raggies

7. BHO immediately claims credit for his "daring and decisive" behaviour. As usual with him, it's BS. Read the following accurate account:

Philips' first leap into the warm, dark water of the Indian Ocean hadn't worked out as well. With the Bainbridge in range and a rescue by his country's Navy possible, Philips threw himself off of his lifeboat prison, enabling Navy shooters onboard the destroyer a clear shot at his captors - and none was taken.

The guidance from National Command Authority - the president of the United States, Barack Obama - had been clear: a peaceful solution was the only acceptable outcome to this standoff unless the hostage's life was in clear, extreme danger.

The next day, a small Navy boat approaching the floating raft was fired on by the Somali pirates - and again no fire was returned and no pirates killed. This was again due to the cautious stance assumed by Navy personnel thanks to the combination of a lack of clear guidance from Washington and a mandate from the commander in chief's staff not to act until Obama, a man with no background of dealing with such issues and no track record of decisiveness, decided that any outcome other than a "peaceful solution" would be acceptable.

After taking fire from the Somali kidnappers again Saturday night, the on scene commander decided he'd had enough.

Keeping his authority to act in the case of a clear and present danger to the hostage's life and having heard nothing from Washington since yet another

request to mount a rescue operation had been denied the day before, the Navy officer - unnamed in all media reports to date - decided the AK47 one captor had leveled at Philips' back was a threat to the hostage's life and ordered the NSWC team to take their shots. Three rounds downrange later, all three brigands became enemy KIA and Philips was safe.

There is upside, downside, and spinside to the series of events over the last week that culminated in yesterday's dramatic rescue of an American hostage.

Almost immediately following word of the rescue, the Obama administration and its supporters claimed victory against pirates in the Indian Ocean and [1] declared that the dramatic end to the standoff put paid to questions of the inexperienced president's toughness and decisiveness.

Despite the Obama administration's (and its sycophants') attempt to spin yesterday's success as a result of bold, decisive leadership by the inexperienced president, the reality is nothing of the sort.

## Fort Detrick disease samples may be missing.

Army criminal investigators are looking into the possibility that disease samples are missing from biolabs at Fort Detrick.

As first reported in today's edition of The Frederick News-Post by columnist Katherine Heerbrandt, the investigators are from the U.S. Army Criminal Investigation Division unit at Fort Meade.

Chad Jones, spokesman for Fort Meade, said CID is investigating the possibility of missing virus samples from the U.S. Army Medical Research Institute of Infectious Diseases.

He said the only other detail he could provide is that the investigation is ongoing. Fort Detrick does not have its own CID office, Jones said, which is why Fort Meade's CID was brought in. Jones said he could not comment on when the investigation started.

CID is responsible for investigating crimes where the Army is, or may be, a party of interest, according to the U.S. Army Criminal Investigation Command website.

USAMRIID is the Army's top biodefense lab, where researchers study pathogens including Ebola, anthrax and plague.

In February, USAMRIID halted all its research into these and other diseases, known as "select agents" following the discovery of virus samples that weren't listed in its inventory.

The institute's commander, Col. John Skvorak, ordered research halted while workers conducted a complete inventory of the institute's select agents.

That inventory is nearly completed, though the exact end date isn't known yet, said Caree Vander Linden, USAMRIID spokeswoman.

Vander Linden said she didn't know about the CID investigation and referred questions to the CID's head public affairs office.

There is no indication whether the CID investigation is connected to USAMRIID's re-inventorying of its select agent stocks.

"Listen to what I am saying," stated the source during an interview with Doug Hagmann, founder (NEIN). "The Department of Homeland Security Intelligence Assessment that is receiving so much attention is just the tip of the proverbial iceberg, and the true patriotic citizens of this country are on the Titanic. This is what bothers me. But it goes far beyond that assessment. There have been very significant changes made over the last few years that redirect the focus and assets of the intelligence community internally. These changes have greatly accelerated under this administration, and the threats have been redefined to include those who used to be patriots. It's not only chilling but absolutely insulting to God-fearing Americans."

According to this unimpeachable source, a single-page confidential directive issued by the FBI headquarters in Washington, DC (FBIHQ) was sent to each of the 56 field offices located across the United States on or about March 23, 2009, instructing the Special Agents in Charge (SACs) of those offices to verify the date, time and location of each TEA Party within their region and supply that information to FBI headquarters in Washington. The source stated this correspondence

termed the TEA parties “political demonstrations,” and added that the dissemination of the directive was very tightly controlled. “Not all agents were privy to this correspondence,” stated the source, who compared the dissemination to an older “Do Not File” classification.  
In addition to obtaining or confirming the location and time of each “demonstration,” each field office was instructed to obtain or confirm the identity of the individual(s) involved in the actual planning and coordination of the event in each specific region, and include the local or regional Internet web site address, if any. The information collected by region was then reportedly sent to FBI Headquarters.  
The source alleges that a second directive was issued on or about April 6, 2009 that reportedly instructed each SAC to coordinate and conduct, either at the field office level and/or with the appropriate resident agency, covert video surveillance and data collection of the participants of the TEA parties. Surveillance was to be performed from “discreet fixed or mobile positions” and was to be performed “independently and outside of the purview of local law enforcement.”  
Although the level of detail collected from each operation is unclear, the information was reportedly submitted to Washington, where, “at the level of the National Security Branch (NSB), this information was to “include the office of the Directorate of Intelligence (DI), and integrated with a restricted access database, one that reportedly is accessible to only two agencies” [of the 14 agencies that comprise the U.S. intelligence community, according to the source.  
“The implications to the citizens of the U.S. are ominous. It seems that there is a hostile political agenda coming from Washington that characterizes the supporters of our constitutional freedoms as threats to our domestic security, which is totally absurd. The redirection, the refocusing of domestic threats from al Qaeda cells to ‘flag waving right-wingers’ is something that has gone from a murmur a few years ago to a roar today.”  
Training government-issued cameras on ordinary citizens, many of whom brought their children to an estimated 600 Tax Day TEA Parties is a page torn out of George Orwell’s 1984 and makes the term “God Bless America” more meaningful than ever.  
The Northeast Intelligence Network and Canada Free Press expect the government’s denial of the surveillance of the TEA Parties to go viral as soon as this story is posted.

Jerome Daly: The Man Who Humbled the Federal Reserve (NaturalNews.com)

Jerome Daly is one of the few men to take on the might of the Federal Reserve in the courts and win. 40 years ago, a Minnesota bank attempted to foreclose on Daly’s mortgage but he humiliated them, thanks to his profound knowledge of Fractional Reserve Banking and a courageous, scrupulously honest judge. The judge delivered a dynamite decision that blasted the Federal Reserve and National Banks as unconstitutional and fraudulent. Understandably, the bankers have tried to bury this case and keep the controversial decree from public knowledge.

Those of you who may be facing the grim prospect of foreclosure on your mortgage, or if you know someone who is facing foreclosure, then the incredible story of Jerome Daly will delight and amaze you.

Jerome Daly was an attorney in Minnesota in the 1960s. In May, 1964, he took out a mortgage for \$14,000 with The First National Bank of Montgomery, Minnesota, on a property described as Lot 19, Fairview Beach, Scott County, Minnesota.

Somehow, three years later, Mr. Daly fell behind on his mortgage payments and the bank initiated proceedings to foreclose. The case was heard before a jury in Credit River Township, Scott County, Minnesota, at 10 a.m. on December 7th, 1968. The trial justice was Martin V. Mahoney, a remarkable, no-nonsense man of great integrity and fair-play.

Jerome Daly, being a lawyer, defended himself. The main witness for the prosecution was a Lawrence V. Morgan, President of The First National Bank of Montgomery.

The main issues were whether or not the loan transaction constituted a legal “consideration” and whether or not Mr. Daly waived his rights to complain by having paid his loan for three years.

For any loan transaction to be legal and binding a lawful “consideration” must be brought to the table by both parties. Mr. Daly said that as a consideration he put up his property of Lot 19, Fairview Beach. Mr. Daly further asserted that the bank provided no consideration but merely created the money out of thin air!

Under cross examination by Jerome Daly, Mr. Morgan the bank president spoke candidly and truthfully. Nevertheless, his evidence astonished the judge and jury.

Mr. Morgan admitted that by making a book-keeping entry the bank created the money out of nothing but that this was standard practice exercised by his bank in conjunction with the Federal Reserve Bank of Minneapolis, another private bank. When questioned by Daly he also conceded that he knew of no United States Law or Statute that gave the bank authority to create money out of nothing.

The court was gobsmacked. Justice Mahoney was heard to say, "That sounds like fraud to me."

The bank went on to claim that the Defendant, Daly, accepted the ledger book credit and by paying his mortgage for almost three years he waived his right to complain about the consideration and was legally estopped from doing so.

At 12.15 p.m. the jury returned a verdict. They unanimously found for the Defendant, Jerome Daly not guilty.

Justice Mahoney’s Judgment and Decree makes for fascinating reading. Here are some of his major points.

1. The Plaintiff (the bank) was not entitled to recover the possession of Lot 19, Fairview Beach.
2. Because there was no lawful consideration the Mortgage was Null and Void.
3. The Bank parted with absolutely nothing except a little ink.
4. The Plaintiff had no right, title, interest, or lien on the property.
5. Defendant is awarded costs in the amount of \$75.

In his Memorandum Justice Mahoney went on to say, "The jury found there was no lawful consideration and I agree. Only God can create something of value out of nothing."

He also said, "Even if the Defendant could be charged with waiver or estoppel as a matter of Law this is no defense [sic] to the Plaintiff. The Law leaves wrongdoers where it finds them."

And incredibly... "Plaintiff’s act of creating credit is not authorized by the Constitution and Laws of the United States, is unconstitutional and void, and is not a lawful consideration in the eyes of the Law to support any thing [sic] or upon which any lawful rights can be built."

Amazing! A properly accredited U.S. judge actually said this in a properly convened U.S. court!

"...It has never been doubted that a Note given on a Consideration which is prohibited by law is void. It has been determined, independent of Acts of Congress, that sailing under the license of an enemy is illegal. The emission [sic] of Bills of Credit upon the books of these private Corporations, for the purposes of private gain is not warranted by the Constitution of the United States and is unlawful..."

Then the case took another incredible turn.

The bank appealed, as was their right to do so; but a lawful appeal must be made within 10 days and accompanied by fee of \$2. If the Clerk of the Court does not receive the appeal and the appropriate \$2 fee within 10 days, as is required by the strict Appeals Statutes, then the District Court does not acquire Jurisdiction upon Appeal.

When the Notice of Appeal and the \$2 fee arrived on Justice Mahoney’s desk for him to make his return to the District Court the judge made a second landmark decision. After examining the two \$1 bills he saw that they were Federal Reserve notes. Justice Mahoney refused the notes and refused to allow the Appeal upon the grounds that the notes were without any lawful consideration and void for any purpose.

Justice Mahoney would not accept the Federal Reserve notes to pay for the Appeal process because they were not true money but represented instruments of debt. If the bank had paid in silver dollars, half-dollars, quarters, dimes, nickels, or even pennies, their appeal would have been legitimate and would have been heard.

Justice Mahoney offered the bank a hearing on the issue but they failed to request one. Then the District Court ordered Mahoney to show cause as to why the Appeal should not be allowed. Mahoney then ordered a hearing on January 22nd, 1969, for the purposes of making Findings of Fact and Conclusions of Law.

But no representative of the First National Bank of Montgomery turned up in court, nor was there any continuance requested by the bank or its attorney.

In his Findings of Fact and Conclusions of Law Justice Mahoney made some extraordinary observations. The following 12 points are quoted directly from his report (available through Resources, page 22)

1. The Federal Reserve Banks and National Banks create money and credit upon their books and exercise the ultimate prerogative of expanding and reducing the supply of money or credit in the United States. The creation of this money or credit constitutes the creation of fiat money upon the books of these banks.

2. When the Federal Reserve Banks and National Banks acquire United States Bonds and Securities, State Bonds and Securities, State Subdivision Bonds and Securities, mortgages on private Real property and mortgages on private personal property, the said banks create the money and credit upon their books by bookkeeping entry. The first time that the money comes into existence [sic] is when they create it on their bank books by bookkeeping entry. The banks create it out of nothing. No substantial fund of gold or silver is back of it, or any fund at all.

3. The Federal Reserve Bank obtains Federal Reserve Notes [no matter what denomination] for the cost of printing of each note which is less than one cent. The net effect of the entire transaction is that the Federal Reserve Bank obtains Federal Reserve Notes comparable to the ones they placed on file with the Clerk of the District Court...for the cost of printing only.

4. From 1913 down to date, the Federal Reserve Banks and the National Banks are privately owned. As of March 18, all gold backing is removed from the said Federal Reserve Notes. No gold or silver backs up these notes.

5. The Federal Reserve Notes in question in this case are unlawful and void...being contrary to Article 1, Section 10, of the Constitution of the United States...are not lawful money of the United States; are in violation of the Constitution of the United States and are not

valid for any purpose.

6. Said Notes are fiat money, not redeemable in gold or silver coin upon their face, not backed by gold or silver, and the notes are in want of some real or substantial fund being provided for their payment in redemption.

7. The sole consideration paid for the One Dollar Federal Reserve Notes is in the neighborhood of nine-tenths of one cent, and therefore, there is no lawful consideration behind said Notes...As a matter of fact, the "Notes" are not Notes at all, as they contain no promise to pay.

8. The activity of the Federal Reserve Banks...and the First National Bank of Montgomery is contrary to public policy and the Constitution of the United States and constitutes an unlawful creation of money and credit and the obtaining of money and credit for no valuable consideration. The activity of said banks in creating money and credit is not warranted by the Constitution of the United

States.

9. The Federal Reserve and National Banks exercise an exclusive monopoly and privilege of creating credit and issuing their Notes at the expense of the public, which does not receive a fair equivalent. This scheme is for the benefit of an idle monopoly and is used to rob, blackmail and oppress the producers of wealth.

10. The Federal Reserve Act and the National Bank Act is in its operation and effect contrary to the whole letter and spirit of the Constitution of the United States; confers an unlawful and unnecessary power on private parties; holds all of our fellow citizens in dependence; is subversive to the rights and liberties of the people. It has defied the lawfully constituted Government of the United States. The two banking Acts and Sec. 462 of Title 31, U.S.C. pages 41 and 42, are therefore unconstitutional and void.

### Gun Rights Case Law:

SECOND AMENDMENT UPHELD BY  
NINTH CIRCUIT AS AGAINST A  
DEGENERATE AND TYRANICAL  
GOVERNMENT

#### NORDYKE v. KING

Martin J. Jenkins, District Judge, Presiding

#### GOULD, Circuit Judge, concurring:

I concur in Judge O'Scannlain's opinion but write to elaborate my view of the policies underlying the selective incorporation decision. First, as Judge O'Scannlain has aptly explained, the rights secured by the Second Amendment are "deeply rooted in this Nation's history and tradition," and "necessary to the Anglo-American regime of ordered liberty."

The salient policies underlying the protection of the right to bear arms are of inestimable importance. The right to bear arms is a bulwark against external invasion. We should not be overconfident that oceans on our east and west coasts alone can preserve security. We recently saw in the case of the terrorist attack on Mumbai that terrorists may enter a country covertly by ocean routes, landing in small craft and then assembling to wreak havoc. That we have a lawfully armed populace adds a measure of security for all of us and makes it less likely that a band of terrorists could make headway in an attack on any community before more professional forces arrived.

1 Second, the right to bear arms is a protection against the possibility that even our

own government could degenerate into tyranny, and though this may seem unlikely, this possibility should be guarded against with individual diligence.

Third, while the Second Amendment thus stands as a protection against both external threat and internal tyranny, the recognition of the individual's right in the Second Amendment, and its incorporation by the Due Process Clause against the states, is not inconsistent with the reasonable regulation of weaponry.

Militias and Community

The word "militia" is a loaded one.  
What image does it conjure up? The most immediate image is that of a band of citizens with weapons.  
Unfortunately, in the United States it also conjures up images of fringe groups - discontented citizens training in the mountains, filing liens against public officials and refusing to pay their taxes.  
Organizations such as the Southern Poverty Law Center and Militia Watch keep tabs on racist or bigoted organizations, and include "militias" in their estimate of threats to common decency and the rule of law.

This is unfortunate.  
While there is no question that the term "militia" has been, in many cases, appropriated by extremist groups and individuals - such appropriation does not, in any fashion, invalidate United States law.  
We are all members of the Militia.  
Here's the relevant section of the U.S. code - Title 10, Section 311:  
Sec. 311. Militia: composition and classes  
(a) The militia of the United States consists of all able-bodied males at least 17 years of age and, except as provided in section 313 of title 32, under 45 years of age who are, or who have made a declaration of intention to become, citizens of the United States and of female citizens of the United States who are members of the National Guard.  
(b) The classes of the militia are -  
(1) the organized militia, which consists of the National Guard and the Naval Militia; and  
(2) the unorganized militia, which consists of the members of the militia who are not members of the National Guard or the Naval Militia.  
In other words, you - as an able-bodied

citizen of the United States - are a member of the unorganized militia.  
What is the purpose of this?  
The defense of community. The preservation of the rule of law when social services fail. The protection of the People from violence, tyranny, and other dangers in the face of either oppression or disaster. The keeping of the peace.  
When a law enforcement officer requests that you come to his assistance, it is illegal to refuse in almost every jurisdiction of this nation. Properly so, for who would turn his back on a police officer struggling to arrest a criminal? Or fighting to save the life of an accident victim?  
When you respond, you are acting as a militia member.  
If there is an accident on the highway, with snarled traffic and wounded people - and you pull over to assist, to render aid and direct vehicles around the injured - you are doing that which common decency and a sense of community require.  
You are acting as a militia member.  
When you take a lost child by the hand and lead her to the information desk at the shopping mall; when you step from your storefront and tell a group of bullies to leave that poor kid alone; when you with your neighbors move a dead tree from the streets before your homes...  
...you are the militia.  
It matters not whether the call is that of a kitten in a tree, or the defense of your community and family against the predations of an arbitrary and outrageous government.  
It is the spirit that moves us to plow our neighbor's driveway. It is the spirit that causes you to watch out for your friend's children. It is the spirit that motivates you to care, and to act in defense of those precious things that bind us all together as Americans.  
It is the love of your fellow man.  
And that, my friends, is the most honorable motivation of all.

and National Banking System has impaired the obligation of Contract, promoted disrespect for the Constitution and Law and has shaken society to its foundations.

12. No rights can be acquired by fraud. The Federal Reserve Notes are acquired thru [sic] the use of unconstitutional statutes and fraud.

This is a thoroughly amazing legal decision, unprecedented in the history of the United States. Justice Mahoney was not a man to mince his words. He was courageous in the extreme, perhaps even reckless, to deliver such a decree against the Federal Reserve.

But the great fortitude of this remarkable judge may have cost him his life.

Less than 6 months later, in June, 1969, Justice Martin V. Mahoney died in a mysterious boating accident. Those close to him say his body was heavily poisoned.

Justice Mahoney's decree still stands and has not been challenged or overturned to this very day.

We owe it to the memory of this brave man to get his audacious milestone judgment out into mainstream public awareness.

## Military Aircraft in Southwest: Update -
