## Grand Jury Investigations Being Sought! By Jeff Machr

The corruption within Archuleta and LaPlata Counties, and many other counties across America (and state governments) is demanding a much harder approach from citizens. When the so-called leaders, our public servants, no longer listen to the will of the people, or have lost their moral compass and become derelict in their legal and Constitutional duties, one of the largest guns we have is that of the Grand Jury.

The Grand Jury was originally established to prevent corrupt courts and government from running amuck, and has teeth that can not only stop this activity, but can put those criminals and traitors behind bars through criminal indictments.

When a public servant violates their oath of office, this is treason, and a felony. When they ignore criminal activities, even after being placed on NOTICE of such, this is complicity in that criminal enterprise. When evidence of Racketeering has been obtained, on multiple fronts, the Grand Jury is the tool to crush this type of criminal behavior.

The Free Press has been contacted by several groups from Archuleta and LaPlata counties regarding illegal activities at multiple levels, and action is now in the mill that will not only send shock waves throughout our

area, but will be a wake up call to other counties where similar activities are taking

The Grand Jury is open to all citizens. No one can legally be prevented from access to the Grand Jury, or the ones stopping such access are guilty of Obstruction of Justice, a felony crime. Oftentimes, Grand Juries have been in the pockets of corrupt local judges or politicians, and are simple rubberstamping cases as they are told, but if this is the case, it can not only be stopped, but they, too, can be indicted for obstruction of Justice.

The Free Press investigated local Grand Jury information at the LaPlata County Courthouse. We were told that the last Grand Jury convened in this district was 1982... 27 years ago. Could this be why there is so much unconstitutional activity in our district? Could there be a relationship here?

National groups are proceeding with Grand Jury investigations into all aspects of local government activities, and the Archuleta County Law Club reports they're working with the same groups... and with an attorney group who is "shocked" by this behavior... to address the blatant violation of Due Process rights, violation of Oath of Offices... both felonies, among other felonious activities in

Court and County Recorder's Offices, etc. The evidence is well documented, and will be used where such behavior continues despite legal NOTICE being given to various offices and public servants.

This type of behavior creates a personal liability for everyone involved, (local AND State levels) and loss of their positions, not to mention financial loss could be substantial. Criminal charges could also develop in conjunction with the Department of Justice.

The Grand Jury, which represents the People, and a fourth branch of government, has been ignored by local governments, and even Judge Gregory Lyman, who oversees Grand Juries in this district stated that it could be that local government has been in violation of the law on this, and openly admitted to the Free Press that he "knows nothing about Grand Juries."

An independent Grand Jury, free of bias, and corruption, and consisting of average people in the community who can review evidence, conduct hearings, examine, subpoena documents and in every other way, obtain all the facts and decide whether there is enough evidence to convict... anyone... public servant or any individual involved with corruption or lawlessness in ANY manner. Let's go for it!

#### You are Not the Boss of Me! By Larken Rose

Two hundred and thirty-three years ago, in Philadelphia, a bunch of guys got together and wrote a letter to their king. The letter was very eloquent, and well thought out, but it basically boiled down to this:

"Dear King George, You're not the boss of us! Sincerely,

A Bunch of Troublemakers"

That's essentially what the Declaration of Independence was: a bunch of radicals declaring that they would no longer recognize the right of their king to rule them, at all, ever again. They went on to create a new boss, which turned into a new oppressor, but we'll get to that in a moment. First, let's consider the essence of that attitude: "You're not the boss of me!" This July 4th, like every year, millions of Americans [celebrated] Independence Day with various parades, picnics, fireworks, and so on. But how many of those people celebrating have ever actually considered what the Declaration was actually about, and what the colonists actually did? The colonists did not merely beg the king to change his ways. In fact, the Declaration explains how they had tried that, to no avail. Instead, the colonists were doing something far more drastic.

In short, they committed treason. They broke the law. They disobeyed their government. They were traitors, criminals and tax cheats. The Boston Tea Party was not merely a tax protest, but open lawlessness. Furthermore, truth be told, some of the colonists were even cop-killers. At Lexington, when King George's "law enforcers" told the colonists to lay down their guns, the colonists responded with, "No, you're not the boss of us!" (Well, that was the meaning, if not the exact verbiage.) And so we had "The Shot Heard 'Round the World," widely regarded as the beginning of the American Revolution. Looking back now, we know the outcome. We know who eventually won, and we don't mind cheering for the rebels.

But make no mistake: when you cheer for the founders of this country,

you are cheering for law-breakers and traitors. As well you should. But, for all the flag-waving and celebrating that goes on every July 4th, do Americans actually believe in what the colonists did? Do they really believe in the attitude expressed in the Declaration of Independence? Are they really still capable of supporting a mantra of "You're not the boss of me!?"

In, short, no. Imagine the equivalent of what the colonists did so many years ago, being done today. Imagine a group of people writing a letter to the United States government, sending a letter to Congress and to the President, saying that they would no longer pay federal taxes, they would no longer obey federal laws, and that they would resist--by force, if necessary--any attempt by federal agents to enforce those laws. How would a group which did such things be viewed today, by most Americans? They would be viewed as nut-cases, scofflaws and terrorists, despicable criminals and malcontents. They would be scorned as the scum of the earth, despised by just about everyone who today celebrates Independence Day. How ironic. So why the double standard? Why would the American public today condemn the exact same attitudes and behaviors which they glorify and praise in the context of the American Revolution? Quite simply, it's because, for all the proud talk of "land of the free and home of the brave," the spirit of resistance—the courage to say "You're not the boss of us!"--has been trained out of the American people. We have become a nation of wimps.

For years and years, in the churches and schools, on the news, in the media, and from everywhere around us, we have been taught one thing above all else: that obedience to authority is the highest virtue, and that disobedience is the worst sin. As a result, even most of those who now claim to be zealous advocates for individual rights and personal liberty will

Many didn't make it and turned around and went back, but they nevertheless tried. Personal independence requires some personal fortitude, some inner strength, some willingness to risk things in order to grow and develop. Not everyone throughout history had that, but enough of them did, and the story of America has been

The problem we now face is, what story is America telling today? What is the legacy Americans are leaving behind? What example to the world is on display for all to see? The sad truth is that far too many are seemingly unaware or uncaring as to where we are headed or why millions of Americans are coasting... taking a free ride on the wings of freedom, never thinking of all that freedom entails.

Over the last 10 decades, freedoms have been taken for granted, and accepted without payment by most...like accepting an inheritance from a dead relative and figuring it is all yours without any responsibility. I suppose that already some readers are thinking, "Higgs is an America hater. Why doesn't he do us all a favor and get the hell out of this great country while he still can?" Anyone who is thinking such a thought, however, is utterly mistaken. I do not hate this country, though I do despise the governments – local, state, federal, and hybrid – that now rule

Bill Clinton once felt moved to scold the people who took offense at some of the government's especially monstrous recent crimes by saying, "You can't love your country and hate your government." Au contraire, Slick Willy. I am living proof that you can indeed. I do so in every waking minute of every day, and sometimes in my sleep, too. To be perfectly frank, I have trouble in understanding how any decent, halfway honest person who loves America cannot hate its governments, inasmuch as by their laws, their judicial decisions, their regulations, and their daily conduct, they prove themselves a standing reproach to every ideal embraced by the men who shed their blood to establish this country's independence from the British Empire. Do you recall those first patriots' declared devotion to life, liberty, and the pursuit of happiness? Can anyone today look upon the pack of scoundrels, liars, thieves, and (in all too many cases) murderers who control the governments of this great country and feel anything but the most wrenching revulsion?

But if I feel this way about our glorious government leaders, how can I then maintain that I love the country? It's really easy. I simply recognize that everything I love about it – and there is a great deal – stands to its governments more or less in the same relation that matter stands to anti-

almost always couch their "demands" with disclaimers that, of course, their efforts for justice will be done "within the system," and that they would never advocate anything "illegal." They claim to be devout proponents of freedom, and yet all they ever do is seek a political solution, whether through lobbying of politicians, elections, or other government-approved means.

Of course, government never approves of anything which might actually endanger government power. As the bumper-sticker says, "If voting made a difference, it would be illegal." And why should civilized people assume that change must be done "legally" and "within the system?" That is obviously NOT what the Declaration of Independence was about. In fact, the Declaration states quite plainly that when a government ceases to be a protector of individual liberty, it is not only the right, but the DUTY of the people to ALTER or ABOLISH that form of government. In other words, when the government becomes an oppressor, instead of a protector--as is obviously the case today--the people are morally obligated to adopt an attitude of, "You're not the boss of us!"

So how many Americans are doing that? Almost none. Instead, even the most vocal critics of corruption and injustice usually do little more than banging their heads against a brick wall, begging, in half a dozen different ways, for the tyrants to please be nicer to us. (Meanwhile, they go to great lengths to distance themselves from people like me, for fear of what the general public might think of them. As a result, I believe the general public, and those in government, view them pretty much as I view them: as harmless and irrelevant conformists, destined to forever beg for freedom, and never achieve it.)

Make no mistake, begging and whining is not what the Declaration of Independence was about. It was about breaking the law, when the law is unjust. It was about committing treason, when the rulers became oppressive. It was about disobedience—civil disobedience, when effective, and not-so-civil disobedience when necessary. It was about open resistance, including violent resistance when called for. So where is that attitude today? Where is the candidate advocating such a thing? Patrick Henry, Thomas Paine, Samuel Adams—where are the modern equivalents? For all the whining about extremists, where are those willing to openly resist injustice? Not only don't most Americans believe in resisting tyranny, they feel extremely uncomfortable just hearing others talk about it, even in abstract terms (like this). Maybe it's just that we're not quite at the level of oppression to justify resistance. Is that it? Hardly.

If two or three percent taxation justified rebellion in 1776, why doesn't fifty percent taxation justify it now? If a few puny excise taxes on tea and pieces of paper justified it then, why don't the myriad of unavoidable, crushing taxes at all levels, and the hordes of callous, vindictive tax collectors justify it now? If the relatively unusual cases of Redcoats abusing colonists justified it then, why doesn't it justify it when American police see no problem with randomly stopping, detaining, interrogating and searching anyone they want, whenever they want, for any reason or no reason at all? Does anyone think Thomas Jefferson, if he were alive today, would quietly allow himself to be strip-searched, and allow his belongings to be rummaged through, by some brain-dead TSA thug? Read the Fourth Amendment. They had a revolution over that sort of thing. Does anyone think that Patrick Henry would take kindly to being robbed blind to pay for whatever war-mongering the politicians wanted to engage in this week? Read what the Founders said about standing armies.

They had a revolution over that sort of thing. Think James Madison



would go along with being disarmed, by the various state and federal control freaks? Read the Second Amendment. They had a revolution over that sort of thing. Think George Washington would be happy to have both his earnings and savings constantly looted by a parasite class, to pay for all manner of wealth redistribution, political handouts and other socialist garbage? Think Thomas Paine would gladly be extorted to give all his money to some giant, failed corporation or some huge international bank? Here is his message: "If ye love wealth better than liberty, the tranquility of servitude better than the animating contest of freedom, go home from us in peace. We ask not your counsels or arms. Crouch down and lick the hands which feed you. May your chains set lightly upon you, and may posterity forget that ye were our countrymen." When's the last time you heard a modern so-called "statesman" say something like that? So what happened? When did Americans lose their ability to say, "You're not the boss of me," and why? Yes, most people are scared, and for good reason. not whip you so hard. I'm talking about resisting, refusing to obey.

That makes sense, but there is more to it than just fear. Because not only won't most Americans resist, but they will condemn anyone who does. If you do what the founders did, most people in this country would call you a tax cheat, a malcontent, a criminal, a traitor, even a terrorist. Why? Why do Americans now vehemently condemn those who say and do exactly what the Founders did a couple hundred years ago? When did our priorities and view of the world change so drastically, and why? I'll tell you why. Gradually, and very systematically, we have been trained to measure our own worth, not by what we produce, not by how we treat other people, but by how well we obey authority. Consider the term, "law abiding taxpayer." How many people wear that label as a badge of honor? "I am a law-abiding taxpayer!"

When they say that, they mean, "I'm a good person." But is that what it really means? Well, "law-abiding" just means that you do whatever the politicians tell you to do. We speak with great reverence of this thing called "the law," as if it is the decree of the gods, which no decent human being would dare to disobey. But what is it really? It's whatever the politicians decide to command you to do. Why on earth would anyone think that obedience to a bunch of liars and crooks is some profound moral obligation? Is there any reason for us to treat with reverence such commands and demands? No rational reason, no.

matter. To qualify for my affections, a person, place, or thing almost by definition must exist (or have existed during its time) outside the sphere of government and its manifold evils...

By this time, I hope that the reader understands what I'm driving at: loving America has nothing whatsoever to do with loving its governments and their actions. Moreover, everything about this country that truly warrants a free person's love is antithetical to the operations of its governments. The America I love embraces not merely places, scenes, and settings, however, but innumerable persons whose accomplishments down through the ages glorify their country and testify to its people's courage and humanity. If you seek an example of honorable bravery, then consider how William Lloyd Garrison, at great risk to life and limb, persisted in publishing an uncompromising abolitionist newspaper, The Liberator, declaring: 'I will not equivocate – I will not excuse – I will not retreat a single inch – AND I WILL BE HEARD.'

The country worthy of our love most emphatically does not consist of its disgusting politicians or of its hired killers... or of its petty tyrants acting as regulators, police, and other wielders of unwarranted – and all too often unchecked – coercive power over their fellows.



The only reason we do it is because we have been trained to do it. Some might point out that obeying the laws against theft and murder is a good thing to do. Well, yes and no. It is this ability and power that is


being systematically eroded, even to the extent that we, ourselves, are beginning to believe the lies and accepting the slavery status as normal. How far we have fallen.

you to know; a secret some of the Founders hinted at, though even most of them didn't seem to fully grasp it. Ready for it? You own yourself. You are not the property of the politicians, or anyone else. I own me, and you own you. Each of you owns himself. Sounds simple enough, right? And most people respond with, "Well duh, of course. That's no secret. We knew that." But in reality most people don't know that. If you own yourself, would anyone have the right to take, without your consent, the fruits of your labor? What you earn, with your time and effort, does anyone have the right to take that from you by force? Of course not, most will answer. Really? And what if they call it "taxation?" "Oh, well, that's different." No, it isn't.


If you own yourself, would anyone have the right to force you to pay rent for a house you already paid for, under threat of taking your house away? Of course not. What if they call it "property taxes?" Oh, that's different. No, it isn't. And you can go right down the list: if you truly own yourself, the vast majority of so-called "laws," at all levels, are absolutely illegitimate. As Jefferson put it, ANY so-called "law" that infringes upon individual liberty--which is dang near all of them--is inherently bogus. But let's take it one step further. If you own yourself--

In other words, you have the right to be armed--the right to possess the equipment to exert whatever force is necessary to repel any attempts to infringe upon your rights to life, liberty and property. I know it makes people uncomfortable (especially people who work for the government) when I say the following: I want every sane, adult American to have the ability to use force, including deadly force, against government agents. I don't want people randomly gunning down cops, but I do want the people to retain the ability to forcibly resist their own government. The very concept bothers a lot of people, but what is the alternative? The alternative is something a lot scarier: that the people should NOT have the means to resist their own government. But, once again, even most people who claim to be vehemently profreedom, don't like to talk about what that really means. Many "gun rights" organizations, for example, go to great lengths to beg the politicians to LET them remain armed. Why? At Lexington, when the British troops told the colonists to lay down their weapons, what was the response? Did the colonists say, "Awe, can't we keep them, pretty please??" No, they had a very different attitude, something alone the lines of, "You're not the boss of us!" If you own yourself--and this is a big one--it is not only your right, but your most profound obligation as a human being, to judge for yourself what is right and wrong, and to act accordingly. But what if people claiming to be "authority" want to force you to do something contrary to what you deem to be right? Do you have an obligation to obey them, and ignore your own conscience? No. What if their threats are called "legislation?" It makes no difference.

You are always, at all times, in every situation, obligated to do what you deem right, no matter what so-called "government" and "authority" and "law" have to say about it. #### Arizona Legislature Takes The Lead In Backing Self-Defense

The Arizona Senate passed three important self-defense bills in a session that lasted into the early morning hours Wednesday. First, SB 1113 enables law-abiding Right-to-Carry permit holders to carry firearms for self-defense in restaurants. This NRA-backed bill passed by an overwhelming, bi-partisan majority of 19-8 and will now be sent to Governor Jan Brewer's (R) desk for her consideration.

Kansas Attorney General Steve Six (D) today announced that the State of Kansas will now recognize non-resident Right-to-Carry permits issued by any of the 22 states already recognized.

#### The Real ID has morphed into the PASS Act

S-1261, the morphed "Real ID Act" is now being pushed through Congress by our treasonous Representatives. This "Act" will facial recognition and technologies. "All Americans are being enrolled into a single global biometric identification system that will link their body to the ability to buy and sell. This Drivers License "pass" will be used as a one-card-fits-all piece of ID... border crossing, purchasing, as a credit card, even to obtain cash. U.S. Rep. Marsha Blackburn, a Tennessee Republican, has become the sixth co-sponsor of a proposal by Rep. Bill Posey, R-Fla., that would require documentation of eligibility from presidential candidates.

A participant at a forum on a political website noted "average citizens have to have a copy of our birth certificate just to apply for a passport, but the president of the United States doesn't have to show theirs??? This doesn't make sense at all."

#### Senate bill fines people refusing health coverage.

Americans who refuse to buy affordable medical coverage could be hit with fines of more than \$1,000 under a health care overhaul bill unveiled Thursday by key Senate Democrats looking to fulfill President Barack Obama's top domestic priority.

The Congressional Budget Office estimated the fines will raise around \$36 billion over 10 years. Senate aides said the penalties would be modeled on the approach taken by Massachusetts, which now imposes a fine of about \$1,000 a year on individuals who refuse to get coverage. Under the federal legislation, families would pay higher penalties than individuals.

In a revamped health care system envisioned by lawmakers, people would be required to carry health insurance just like motorists must get auto coverage now. The government would provide subsidies for the poor and many middleclass families, but those who still refuse to sign up would face penalties.

#### Minn. lawmaker vows not to complete Census

Outspoken Republican Rep. Michele Bachmann says she's so worried that information from next year's national census will be abused that she will refuse to fill out anything more than the number of people in her household.

In an interview Wednesday morning with The Washington Times "America's Morning News," Mrs. Bachmann, Minnesota Republican, said the questions have become "very intricate, very personal" and she also fears ACORN, the See News Briefs, Page 9


#### GMO Corn now has Contraceptive

#### Colorado Attorney General Signs Amicus Brief Supporting Second Amendment Incorporation!

Two-thirds of the nation's attorneys general have filed an amicus brief asking the U.S. Supreme Court to grant certiorari in the case of NRA v. Chicago and hold that the Second Amendment applies to state and local governments through the Due Process Clause of the Fourteenth Amendment. This bi-partisan group of 33 attorneys general, along with the Attorney General of California in a separate filing, agrees with the NRA's position that the Second Amendment protects a fundamental individual right to keep and bear arms, disagreeing with the decision recently issued by a three-judge panel of the U.S. Court of Appeals for the Seventh Circuit.

## Stop the Federalization of the Agricultural Industry

Last week The John Birch Society updated people on the Clean Water Restoration Act (S. 787) which would place virtually all waters of the United States under the control of the federal government. (This includes your well or pond, and all other bodies of water).

Representative Rosa DeLauro (D-CT) introduced the Food Safety Modernization Act of 2009 (H.R. 875) on February 4, 2009. ## Splicing Drugs Into Plants-Dangers of GE Pharming

"PHARMING" HOLDS PROMISE, BUT ALSO DANGERS By Katherine Stapp - NEW YORK, NY

Edible vaccines and spermicide made from plants that contain human genes could someday save lives and help prevent overpopulation, but watchdog groups are worried about the repercussions if genetic material from these crops gets loose in the food chain.

Animals like mice and gerbils typically have been used to produce human antibodies -- proteins that fight disease -- but the refining process in vats called "bioreactors" is still expensive and inefficient, and is vulnerable to viral and bacterial contamination.

Some scientists see greater promise in plants, which are not affected by human diseases and could produce antibodies at costs up to 100 times less than traditional cell fermentation. Several companies are growing crops that have been engineered to produce human antibodies to diseases like Hepatitis B and malaria — or even to sperm, in what the press has dubbed "contraceptive corn." The San Diego-based company Epicyte hopes to begin clinical trials of a topical spermicide made from genetically modified (GMO) corn this year. It currently has one crop growing in a greenhouse in Indiana and a second stage is planned in Hawaii, said Sandy Strauss, Epicyte's spokesperson.

"We're following all the (federal) guidelines," Strauss said. "The chance is almost nil (that there would be inadvertent cross- pollination), but I can't say 100 percent, because one never knows."

This is exactly what makes environmental groups like Greenpeace nervous. "There has been reportage of widespread contamination (by GMO crops) in Mexico and that was something that was predicted could never happen -- and it's happened to a rather extreme degree," said Craig Culp, the GMO media coordinator for Greenpeace.

The contraceptive corn is not yet in open field trials, which is usually the point at which Greenpeace actively opposes such experimental research. Last September, the group staged a protest in California, where a company was growing rice outdoors that had been spliced with human genes. Greenpeace says some 20 companies worldwide are engaged in this kind of "pharming."

"We are very much aware of this," Culp said of the contraceptive corn. "It's a pretty terrifying scenario that this could get into regular corn and end up in someone's cornflakes."

"Open field trials are inherently a danger to the natural environment. Buffer zones (a barrier of regular crops surrounding the GM crops) are absolutely insufficient," he added. "Even if they're miles wide, there's simply no way to contain it; genetic material can be carried by the wind, pollen, insects, seed matter, animal faeces and birds. There are lots of ways this genetic material can escape contained zones."

The technology, termed "plantibodies" by Epicyte, has a long way to go before hitting the market. Some experts caution it is too early to judge its usefulness or the hazards it may present. "Biotech has changed the way we think about plants," said Michael Rodemeyer, executive director of the Washington-based Pew Initiative on Food and Biotechnology, an independent research group that takes a neutral position on biotechnology.

"Corn is a wonderful protein factory that could be of value for pharmaceuticals, diagnostics, and industrial applications," Rodemeyer said. "Plants are a renewable resource, with environmental and energy advantages. This technology may offer a way to do things that couldn't be done otherwise."

Still, he said, "as we've seen with the Starlink case, there are concerns that genetic traits could drift to other organisms." In 2000, a brand of GMO corn known as Starlink that had only been approved for animal feed somehow found its way into numerous food products in the United States, including taco shells and tortilla chips. Allegations that Starlink caused allergic reactions in some people prompted more than 300 product recalls and raised questions about the efficacy of government regulation of GMO products.

"The question is how do we make sure that the (GMO) versions - - particularly for non-food uses -- do not get into the food crops, and that's something the regulatory agencies here are looking at," Rodemeyer said. Gene Laos, the chief executive of a Texas-based company called Prodigene that is experimenting with plant-based vaccines, said its cost-effectiveness could be a boon for poorer countries.

"It will definitely benefit the underdeveloped countries, since the carrier for the antigen would be a seed," he said. "Although edible vaccines have to be administered by a doctor, other factors -- transportation, refrigeration -- are negated for poor countries, as well as the cost of needles and other supplies."

"We've had a vaccine stored in a corn seed for five years without

degradation," he added. Prodigene has two products about to go into clinical trials -- a hepatitis B vaccine and one that fights the bacteria known as e. coli.

Ultimately, Rodemeyer said, "it's hard to make predictions (about how beneficial this technology could be for the developing world). What's important is do it in a safe, effective and affordable way."

#### Editor's Note:

It is amazing the depth of stupidity and schemes humankind descends to. ## False Christianity, False Beliefs! By D

There's a saying - "Someone who is deceived, doesn't know they are deceived, or they wouldn't be deceived." Deception is a subtle and profoundly difficult thing to see through. It usually takes some "in-your-face" confrontation or wake up call to alert us to the possible fact that we could be deceived about something.

The Southwest Free Press has been sounding the alarm for months on multiple issues where deception plays a great part, and many are waking up to the facts, and are no longer deceived.

Politics is a touchy area... and a hard thing to admit wrong in, and where great damage is being done because so many won't face the truth.

In religion... it is much worse. The vested interest we've had in religion simply doesn't allow us (without a love for the truth regardless of what that means to our belief system) to admit wrong, or that we wasted such time and resources in false concepts.

The Bible is the book which all of Christianity - 1.2 billion people - base their beliefs on. It is the definitive authority, claiming to be the very words of the Universal Supreme creator in written form as instructions for humanity as to whom and what God is, what this force is doing and where humanity is going on this physical journey. While there are varying beliefs within different Christian sects, the core beliefs remain constant.

If we believe there really is a true God, and that He is capable of communicating His thoughts to us, despite naysayers who claim the original Bible has been perverted by "interpretations" over the millennia, then we have no choice but to prove that Bible, prove the words within it and put the pieces of the puzzle together.

But what happens when we find a conflict between what people believe about God and the Bible, and what the Bible actually says? One of the most often mentioned warnings in the Bible is that of false religion, but not the type of false religion most would consider false. Christ Himself spoke of a false "christian" religion, one that sounded good, looked good and seemed good, but was, in fact, deceptive:

Matthew 24:5 "For many will come in My name, saying, 'I am the Christ,' and will deceive many." NKJV

Most read this scripture and believe it is speaking about people coming who claim to "be" the Christ, but this is not what Christ is warning about here. However, remember that punctuation was not part of the original manuscripts, so the commas are misleading...

Try this: "For many will come in My name, saying I am the Christ, and will deceive many."

Christ was telling people that "many" would come... in His name.. and telling people that He, Jesus, is the Christ. This isn't saying that "many" people would be claiming "they" were the Christ, but that Jesus is the Christ... the Lord... "do you know Jesus..." and what did He warn would be involved with that "Christian" message?

He simply stated that this would be part of deceiving many utilizing a message "about" Him and even practicing things that seem right, but aren't...

Matt 7:21 "Not everyone who says to Me, 'Lord, Lord,' shall enter the kingdom of heaven, but he who does the will of My Father in heaven. :22 Many will say to Me in that day, 'Lord, Lord, have we not prophesied in Your name, cast out demons in Your name, and done many wonders in Your name?' 23 And then I will declare to them, 'I never knew you; depart from Me, you who practice lawlessness!'" NKJV

Do you realize what Christ is stating here? These "many" (the same "many" who would hear a christian message and yet be deceived?) are practicing the form of Christianity they were taught by those coming in Christ's name, (ministers, pastors, evangelists...) teaching that He is the Christ, etc., and yet Christ didn't know them and told them that they were practicing lawlessness

Luke 6:46 "But why do you call Me 'Lord, Lord,' and not do the things which I say?" NKJV

Even in Christ's time, there were those who called Him Lord, and yet they were practicing something different than what Christ taught or expected.

Rev 6:2 "And I saw, and behold a white horse: and he that sat on him had a bow; and a crown was given to him: and he went forth conquering, and to conquer." NKJV.

The white horse here, and it's rider, are the first of the 4 horseman. Many people assume this is discussing Christ Himself, because of Rev 19:11, but this is not correct:

Rev 19:11 "And I saw heaven opened, and behold a white horse; and he that sat upon him was called Faithful and True, and in righteousness he doth judge and make war." NKIV.

The first white horse is representative of a false Christianity... something that resembles what many have been led to believe is Christ and His teachings, but isn't. This is a shock for many to consider at first, but there are many other scriptures which discuss this topic.

So the serious question to ask is, how do we know whether we are being deceived by a

message that sounds "Christian?" How do we protect ourselves from being deceived, because, remember, someone who is deceived doesn't realize it and sincerely believes that what they believe, is true?

Where do we start to touch on this false Christianity... this false teaching about Christ and the Father's plan for humanity?

John 3:13 "No one has ascended to heaven but He who came down from heaven, that is, the Son of Man who is in heaven." NKJV


Christ called death a "sleep." Why would He identify someone who is dead as "asleep" if they are awake in heaven or hell?

Mark 5:39 "When He came in, He said to them, 'Why make this commotion and weep? The child is not dead, but sleeping.' :40 And they ridiculed Him." NKJV.

## Preparing for Civil Unrest - By Claire Wolfe

The most remarkable thing about civil unrest is that there hasn't been more of it.

Politicians are making a hash of this country-and much of the rest of the civilized world. We know it. They know it. They know we know it. But we don't feel we can do anything much to stop them.

That right there is the pre-condition for civil unrest-when people are frustrated and politicians are nervous.

Worse, that was how things stood before last fall's crash. Before polls on both left and right launched the biggest mass transfer of wealth in history—transferring our wealth (what we had left of it!) to their friends on Wall Street and in the banking industry. In other words, that's how things were before things got bad!

Now everybody's talking about the ongoing catastrophe (even if we are in a momentarily sunny mood). But almost nobody is talking about the logical—maybe even inevitable consequences of cynical or desperate politicians abusing an already fed-up populace: civil unrest.

I mean people taking to the streets. Or mass resistance. Or crackdowns because the government fears we might do something to upset its apple cart. It's going to happen. Somewhere. At some time. It's going to.

One of the few VIPs to mention the matter openly was Zbigniew Brzezinski, former National Security Advisor and the ultimate insider's insider. He commented on the millions of unemployed or soon-to-be-unemployed and the "...public awareness of this extraordinary wealth that was transferred to a few individuals at levels without historical precedent in America." He told "Morning Joe" Scarborough, "Hell, there could be even riots." I'd say that's an understatement.

Although few in power are talking about it, rumors abound that governments at many levels are planning for civil unrest. One rumor is about a document supposedly being circulated right now among top federal officials. It's called the "C&R Document"—with C&R standing for "conflict & revolution." The much-storied paper is said to be a plan for controlling the American people when we get out of hand. True? Who knows. But the very rumor tells us a lot about these times.

Other things are not mere rumor. When the federal government established a North American Army command in 2002, its purpose wasn't to repel foreign invaders. It was domestic operations—something long and rightly forbidden by the Posse Comitatus Act. In February of 2009, when military commanders in Canada and the U.S. signed a pact allowing their armies to operate inside each other's something out of the blue, something would rather not talk about what we should do country they didn't even bother to get impossible to anticipate—to set us against each

authorization from Congress—an illegal and unprecedented move. And once again, the handling purpose was "domestic civil emergencies."

For several years, the Centers for Disease Control tried to get states to adopt something called the Model State Emergency Health Powers Act (MEHPA). This act would allow state governments to become police-state dictatorships in event of any ill-defined health emergency—vaccinating people by force, destroying or seizing property without compensation, and rationing medical supplies, food, and fuel. To their credit, most state governments rejected the act. A few adopted portions of it before a fervent opposition campaign caused the CDC to back off. However, the concept of a health dictatorship hasn't gone away. Not hardly. Within days of the news that a new strain of swine flu had arisen in Mexico in April 2009, states were again considering legislation to give themselves martial-law powers in event of an epidemic.

And what of the dozens and dozens of federal agencies that now have SWAT teams? Seriously, what justifies the Bureau of Land Management or the Department of Housing and Urban Development having paramilitary

Now maybe you like the idea of an Army that watches over its own citizens. Maybe it makes sense to have a government seize total dictatorial power in event of a health emergency. Maybe you believe SWAT teams will never be used except against bad guys. But do you really trust these people?

After all, these are the same folks, and this is the same mentality, that not only spent \$325,000 to produce a souvenir photo of a presidential 747 zooming low over the Statue of Liberty, but ordered the New York Police Department, the FBI, the Secret Service, and the New York mayor's office not to tell the public. Never mind that they realized full well that passenger jets and military planes plunging low over Manhattan would evoke panic.

Still, peace reigns. Mostly. At least here in North America. But not everywhere. Not long ago, France was brought to its knees by night after night of rioting. In that country it's become almost common for workers to hold their bosses hostage in hopes of winning economic concessions. Greece, too, saw its normal life and business shut down by days of rioting. So did Iceland—a country that's normally the picture of civility.

Can the U.S. be forever immune?

other and against the "Trust us; we'll fix it" political crowd.

In a way, this national silence on a matter so many people are afraid of is similar to the silence about general preparedness issues before 9-11 or Hurricane Katrina. Only Mormons and us wingnuts spoke of preparedness way back when. Since then, of course, advice on preparedness is mainstream and common.

In another sense, this silence is different. Because when unrest finally erupts, it's not going to be us merely taking care of ourselves. It's going to be "us against them." It might be workers against bosses. Or the poor against bankers. Or blacks against Hispanics. Or little folk against Big Men in public office. Or farmers against the USDA. Or xenophobes against xenophiles. But however it happens, the implications aren't as Boy-Scoutish as just taking care of ourselves in an emergency.

#### Defining civil unrest!

Look up "preparations for civil unrest" on Google and...What's that echo I hear?-you'll find nothing that's going to help you. In fact, you won't even easily turn up a good definition of what civil unrest is.

Like "indecency," the definition seems to be in the eye of the beholder.

I wouldn't consider a peaceful anti-war march to be civil unrest, for instance, but a police chief might. Similarly, I wouldn't consider acts of localized non-violent lawbreaking (like environmental activists chaining themselves to a tree) to be civil unrest; but a timber company official probably believes

Civil unrest occurs when anger, frustration, or fear turn disruptive on a mass scale. Or when government officials crack down because they anticipate such disruptions. Crackdowns can lead to further frustration, leading to further crackdowns and so on-especially when the crackdowns look unwarranted and tyrannical.

In other words, civil unrest can arise from the anger of people or the folly of government or

Anger over an unpopular policy, a new war, a collapse of the currency, panic over a pandemic, a food shortage, a bank run—anything like that could cause civil unrest, especially in a population that's already on edge and no longer trusts its authority figures.

Another thing you won't find via Google is how various types or levels of unrest are likely to affect us and how we should respond, if we're affected. Again, although the men and women at the top are quite concerned for their own It might not take much—and it could be sakes, they (and their media mouthpieces)

### ARCHULETA COUNTY CLUB REPORTS

#### The Archuleta County Law Club

The Law Club met July 7th & 20th. Topics were foreclosures, and methods to stop them in their tracks, property taxes, and reports on further law information obtained, the 5 elements of criminal fraud, Rules of Evidence, and case law on Causes of Actions needing to have an "injured party" in fact, Grand Jury details, separation of powers routine violations, and court watching The next Law Club meeting will be Monday, July 27th, at the ???? at 6:30.

#### The Archuleta County Guard (ACG)

The Guard met on July 14th. In light of the huge amount of legal issues coming to light, and the fact that much of any groups power is in knowing what the law actually says and how to use it, the Guard decided to focus mostly on Law Club issues which were time sensitive, and which were good lessons.

Topics of discussion were court "Objections," Concealed Carry weapons certification trainer presentation, Grand Jury facts and contacts, and general legal issues and answers.

The ACG was recently called by a local citizen, Warren Goodman, telling of how Chris Crump, the local Animal Control officer, was trespassing on his property in response to an alleged complaint that one of his dogs approached a woman and her daughter while walking on the road near his property. Mr. Crump was attempting to search this property for animal control violations, but had no warrant

to legally do so. Mr. Crump left the property, but showed up on Warrens mother's property where Mr. Goodman and his dogs were driven to by Mrs. Goodman.

Within a short time, Mr. Crump drove upon this property, got out and began searching around once again, without a warrant. At one point, Mr. Crump approached with a stick in his hands, provoking the dogs, and then

claimed the dogs would have attacked him without it.

The guard member on the phone told Mr. Goodman to tell Mr. Crump that he was trespassing and that he needed a warrant to be there, but Mr. Crump stated, "he doesn't know what he is talking about." Mr. Crump was told to leave multiple times, and refused to leave, wherein the guard member contacted other guard members, dialed 911 to report the trespass and arrival of the ACG, and drove out to the property.

Along with Mr. Crump's vehicle, were all three on duty deputy vehicles, and then Sheriff Pete Gonzalez drove up as well. Video and audio were being taken of this entire event, and the Sheriff was placed on notice that he was in violation of the law, to which he simply waved his hand and dismissed the warning. Three Deputies were accomplices to this criminal action, and stood by as Mr. Crump then proceeded to issue an illegally presented

Summons. All this was not only a violation of Mr. Goodman's Due Process rights, but was a breach of these officers' Oath of Office to uphold not only the US Constitution, but the Colorado Constitution and Statutes.

Three more ACG members arrived within 10 minutes, and were witnesses to this, and a fifth just after the officers all left. There will be continued follow-up on this and other similar illegal conduct being performed under the color of law by our public servants.

Why were all on duty Deputies, along with the Sheriff, needed for this event? Why leave all of the County without deputies, just to deal with a minor issue? Likely because it was an illegal search, and trespass, and they wanted to protect their activities. The video, along with 911 records are self explanatory... the lawlessness being accepted and practiced in this county under the color of law, must, and will, end. Next Archuleta County Guard meeting will be Monday, July 27th, 6:30 at the same location as the Law Club meeting.

But that's not good enough for we independent-minded people, is it? Here are my definitions of levels of civil unrest and a little bit about how they might affect us:

LEVEL ONE: The lowest level of civil unrest is when people turn on their own neighborhoods—as happened during the race riots of the 1960s and the Rodney King riots in Los Angeles. Level One civil unrest can be deadly and destructive, but primarily to people who live, work, or must travel in the immediate area. Level One unrest is spontaneous, Dionysian, is confined to a narrow geographical zone where the protestors live. Police response may be harsh, but it's localized. Unless you're in the middle of it, you're unaffected.

LEVEL TWO: Level Two civil unrest may also be focused on a single area. But in this case, rioters or protesters have deliberately targeted a business district, a facility, a transportation system, or an organization to impose maximum disruption. One example: the World Trade Organization protests in Seattle in 1999; young people with violence in mind and rage in their hearts attacked an entire downtown, affecting hundreds of businesses and tens of thousands of workers who hardly knew what hit them. Another example: This spring, protesters in Thailand shut down the Bangkok airport, affecting who knows how many individuals and businesses. Level Two unrest is usually planned or semi-planned. The target is chosen deliberately. Although still focused in one area, Level Two can disrupt normal life and business in a whole region or country.

LEVEL THREE: Level Three comes when mass unrest or authoritarian crackdown causes disruption at state or regional level. Then, no matter what the original cause or location of the trouble, everyone in the region is affected. Effects might include travel restrictions, random ID checks, mass arrests, food and fuel rationing, controls on money and banking, roadblocks, and other harsh "emergency" restrictions.

LEVEL FOUR: Level Four is Level Three—but on a national or even international scale. It's martial law. If things ever get this bad, it's likely that the government itself will be a far bigger threat to everyone's well being than whatever the original cause of the clampdown was.

And of course, any level of civil unrest can lead to laws, regulations, and harsher police policies that end up affecting everybody in the long run.

Yes, it can involve us!

We make a mistake if we think civil unrest is strictly an urban

phenomena. It can happen anywhere. When 400 government agents and soldiers descended on one isolated family in the Idaho mountains, the roadblocks, helicopters, Humvees, media presence, and furious protestors surrounded the Randy Weaver family and brought the normal life of Boundary County, Idaho, to a halt. The siege against the Branch Davidian church in Waco, Texas, wasn't conducted in the inner-city, either. Yet both of these were large scale catastrophes with all the hallmarks of civil unrest—individuals or groups resisting, government insisting.

I can easily envision strictly rural-based unrest that urban dwellers will never even hear about (except perhaps in highly distorted reports). What happens, for instance, if farmers, 4H families, owners of saddle horses, and holders of small chicken flocks decide to resist en masse the National Animal Identification System (NAIS)? It's easy to imagine, in these crazy days, USDA SWAT teams descending on the countryside to make arrests, forcibly register or destroy non-compliant animals, and burn down non-registered facilities.

The future could see rural resistance to invasive census-taking, forced vaccination programs, land takings, water-rights policies, or the destruction of herds for real or bogus health reasons. As country people increasingly see governments as foreign organizations driven by the interests of city dwellers, pharmaceutical companies, and mega-agribusiness, it wouldn't surprise me.

If we ever have serious food shortages, expect rural areas to be besieged. Even when civil unrest confines itself to the cities, airports, or highways it can affect us in crazy ways. Here's a funny example of unpredictable (in this case mild) consequences. A friend was due to have her first book published in Canada. She was very excited—then disappointed when weeks dragged by and the book didn't appear. Turns out that a band of Indians was blocking a highway bridge the printer's truck had to cross. The union truckers, in solidarity, refused to route around the protest. Just one small consequence. But you can see the unpredictability.

The simple truth is that we don't know what kinds of unrest to anticipate. We don't know when, or if, we'll see civil unrest. But thinking about the problem and preparing ourselves mentally and physically to deal with it should be just another aspect of our personal preparedness.

#### What we can do!

1. Keep standard emergency preps up to date. First thing to do is make sure all our typical household preparedness supplies and plans are current.

shortage (or something has driven city people out into the countryside), prepare to protect your resources day and night. Here again neighbors can do each other valuable services, like taking shifts guarding fields, barns, private roads, and gardens. Yes, this is an apocalyptic scenario. Not a likely one. But if it happens, it's a Level Three or Level Four emergency—delivered to your own front yard.

6. Get advance word on local conditions when traveling. We're used to hopping into our vehicles or onto airplanes and going wherever we want to go. But as the worldwide economy deteriorates, it's wise to keep an eye on our destination. Right now, this warning pertains more to overseas travel than jaunts within the U.S. If you plan to go visit online sites like abroad, Travelfish.org. They'll have bulletins about adverse conditions in areas you plan to visit; you may even be able to receive alerts via email that will warn you about anything from political protests to disease outbreaks in places you plan to

7. Watch for signs of trouble when in an unfamiliar area. Sometimes the only advance notice you get is the notice your own senses give you. When walking, driving, biking, or otherwise traveling in unfamiliar places, stay in what gunfolk call "condition yellow." This is different than the meaningless colored threat levels the Department of Homeland Security puts out. It just means "be alert!" Never simply allow yourself to slouch along obliviously. Always be aware of who's nearby and what's going on around

you. If you spot trouble developing, turn. Avoid it if at all possible.

8. If you stumble into a "hot zone" of unrest, be prepared to think on your feet. Not many people are qualified to give you advice about how to behave if you unavoidably find yourself in the midst of trouble—a riot, a mass protest that suddenly engulfs your familiar downtown, a spot where police are bashing heads or hurling tear gas seemingly at random. That's because not many people have ever been there and every catastrophe is different. If street-level chaos surrounds you, do your best to keep a cool head, move away from the worst of it if you get the chance, and get inside if possible.

9. If you're swept up in mass arrests during a riot or demonstration, the officers probably aren't going to be listening to your protestations of being an innocent bystander. You'll only tick them off and possibly get a charge of resisting arrest. The best advice I've received from my friends who've been busted during out-of-hand protests: Go along as best you can. Usually, all charges in such cases are either dropped or reduced once calm is restored. Only if we've reached the extreme point where police are rounding people up and throwing them into detention camps, or "disappearing" them, is fighting cops on the street likely to be worth it; then...fight like a demon.

10. Have a good lawyer and carry his or her card with you. Once again, in the heat of chaos it may not do you much good. But that card will come in handy later. Besides, if you and a police officer have an encounter in calmer circumstances, a lawyer's card, along with your calm assertion of your legal rights, will help you to be taken seriously. Police officers are like anybody else; they're more likely to go after easy targets than ones who are obviously knowledgeable and prepared. My lawyer has a helpful little list on the back of his card of the things you should do—nor not do when accosted by a police officer. I'd trust that more than my own nerves in a tight situation.

11. Be careful of roadblocks. This is a hard one. If we reach Level Three or Four of unrest, we may not only see the obnoxious police "checkpoints" we're burdened with today. We might also see two other things. One would be expanded police roadblocks, with warrantless searches, harsh questioning, and possibly mass arrests. Another could be "freelance" roadblocks—roadblocks set up by anybody from political protesters to

As BHM readers know, backup food, water, and other supplies are our mainstay for everything from bad storms to long-term unemployment, from power outages to social breakdowns. During civil unrest, especially at Level Three or Four, we might not be able to get out to buy things we need—or we might consider it more prudent to stay at home. On the other hand, if we ourselves are part of the unrest, we may need those supplies to sit out a siege.

2. Don't fall into foolish complacency. We who live in the country tend to have an "it can't happen here" attitude toward political violence or social upheaval. We see those things as urban phenomena. And mostly, they are. But there's no ironclad rule that says they have to be. If anything disrupts the supply chain, for instance, rural areas could be the first to be cut off from food, medicines, fuel, or other necessities. If government breaks down to the point where it can't deliver food stamps, housing vouchers, social security, or bureaucrats' pay, the rural poor and unemployed could become just as restive as their urban counterparts.

3. Watch your health. As I write this, the airwaves are shrilling about swine flu. This outbreak may fizzle; after all, perfectly normal flu kills many every year without causing panic, martial law, or incessant media coverage. On the other hand, it's certain that one day some illness will rampage across the globe. Few things inspire public panic more quickly than contagious disease, and once again rural areas are not immune. Take all the standard recommended precautions like frequent handwashing. Make sure your preparedness kit includes surgical masks and disposable gloves as well as a selection of frequently updated medications. And be ready to lay low at home for a long time in the event a serious plague gets loose.

4. Make common cause with your neighbors. I've said it before, but establishing a strong bond with people in your community—right now—is vital to every sort of emergency preparedness. In event of a Level One or Two emergency, these are the folks who could come to your house to make sure you're okay. They might give you a ride out or a place to sleep if you accidentally end up in a "hot zone" of riot or protest. In a deeper or more long-term emergency, they could pool resources with you to make supply runs. They can advise you if they've spotted a roadblock. They might let you cross their land to avoid a route that has become dangerous.

5. If you grow crops or raise food animals and the unrest is due to a food

highwaymen. (Just as gangs of home invaders now masquerade as SWAT teams, highwaymen might masquerade as government officials to rob the unwary.) If it's humanly possible, avoid roadblocks. It's not illegal to turn away from them, as long as you don't disobey any traffic laws. Police do consider it suspicious behavior and may come after you, even if you've done nothing wrong; but in a time of civil unrest, avoiding a roadblock could save your skin. Of course, both police and freelancers will set up their blockades to make them as hard as possible to avoid—all the more reason to be alert, know where roadblocks are likely to be, and have a mental map of alternate routes. If, in a time and place of unrest, you're in a line approaching a roadblock, watch what happens to the people ahead of you. If you see any sign that the motorists ahead are being abused, get out of there.

So far, we've talked mostly as if civil unrest is something apart from us—something we might have to be wary of, something we might stumble accidentally into. But the fact is that as our country becomes less free, we might of course be the civil unrest. We might resist having our premises tagged for NAIS or having our herds slaughtered for real or bogus health reasons. We might end up fighting evictions (as farmers and many rural dwellers have for centuries during hard times). We might be the ones who say, "Hell no, we won't go!" when the mobile vaccination van comes to town, or the ones who try to keep our neighbors from being rounded up and sent to camps. Times are uncertain. We simply don't know.

But in every case, preparedness, foreknowledge, and a cool head will come in handy. Some of us already have lines in the sand that would inspire us to resist abuses of authority. And that, right there, is something our would-be masters fear—our disobedience. What will happen? And when? Nobody has a crystal ball. But the combination of public frustration and governmental apprehension is an explosive one. Someday, somebody will light the match.



## Pope calls for a "global authority" on economy

VATICAN CITY (Reuters) - Pope Benedict called on Tuesday for a "world political authority" to manage the global economy and for more government regulation of national economies to pull the world out of the current crisis and avoid a repeat.

The pope made his call for a re-think of the way the world economy was run in a new encyclical which touched on a number of social issues but whose main connecting thread was how the current crisis has affected both rich and poor nations.

Parts of the encyclical, titled "Charity in Truth," seemed bound to upset free marketers because of its underlying rejection of unbridled capitalism and unregulated market forces, which he said had led to "thoroughly destructive" abuse of the system and "grave deviations and failures."

An encyclical is the highest form of papal writing and gives the clearest indication to the world's 1.1 billion Catholics -- and to non-Catholics -of what the pope and the Vatican think about specific social and moral

The pope said every economic decision had a moral consequence and called for "forms of redistribution" of wealth overseen by governments to help those most affected by crises.

Benedict said "there is an urgent need of a true world political authority" whose task would be "to manage the global economy; to revive economies hit by the crisis; to avoid any deterioration of the present crisis and the greater imbalances that would result."

Such an authority would have to be "regulated by law" and "would need to be universally recognized and to be vested with the effective power to ensure security for all, regard for justice, and respect for rights."

"Obviously it would have to have the authority to ensure compliance with its decisions from all parties, and also with the coordinated measures adopted in various international forums," he said.

The United Nations, economic institutions and international finance all had to be reformed "even in the midst of a global recession," he said in the encyclical, a booklet of 141 pages.

The pope's call for a supranational body to tackle global economic woes disturbed some Catholic capitalists.

"There is a difference between coordination and mandate ... a reckless loan in the United States can and did impoverish people in Latvia. So obviously coordination is important as long as it is not mandates," said Frank Keating, CEO of the American Council of Life Insurers and former Governor of Oklahoma.

The encyclical was addressed to all Catholics and "all people of good will" and was released on the eve of the start of the G8 summit in Italy and three days before the pope is due to discuss the global downturn with U.S. President Barack Obama.

In several sections of the encyclical, Benedict made it clear he had great reservations about a totally free market.

"The conviction that the economy must be autonomous, that it must be shielded from 'influences' of a moral character, has led man to abuse the economic process in a thoroughly destructive way," he said.

"In the long term, these convictions have led to economic, social and political systems that trample upon personal and social freedom and are therefore unable to deliver the justice that they promise," he added.

Profit was useful only if it served as a means to a brighter future for all humanity.

"Once profit becomes the exclusive goal, if it is produced by improper means and without the common good as its ultimate end, it risks destroying wealth and creating poverty," he said.

effects of sin" in the economy.

"Financiers must rediscover the genuinely ethical foundation of their activity ...," he said.

German Chancellor Angela Merkel, who had rebuked the pope earlier this year at the height of the row over a Holocaust-denying bishop, welcomed the encyclical as important encouragement for world leaders ahead of a G8 meeting in Italy.

"Pope Benedict has encouraged the state leaders to create rules so that this sort of worldwide economic crisis isn't repeated," Merkel told reporters. "I also saw this as an order to work toward a social market economy in the world."

The pope appeared to back government intervention "in correcting errors and malfunctions" in the economy, saying "one could foresee an increase in the new forms of political participation, nationally and internationally."


