H1N1 Flu Vaccine: Mercury and Live Virus!

An Infowars reader has sent a vaccine insert (See Page 16) that proves Fluzone contains thimerosal, the deadly antiseptic and antifungal agent. "Thimerosal is a very effective preservative that has been used since the 1930s to prevent contamination in some multi-dose vials of vaccines," according to the Centers for Disease Control.

"In 1977, a Russian study found that adults exposed to ethylmercury, the form of mercury in thimerosal, suffered brain damage years later," writes Dawn Prate for Natural News. "Studies on thimerosal poisoning also describe tubular necrosis and nervous system injury, including obtundation, coma and death. As a result of these findings, Russia banned thimerosal from children's vaccines in 1980. Denmark, Austria, Japan, Great Britain and all the Scandinavian countries have also banned the preservative."

According to a number of researchers, thimerosal is responsible for a dramatic increase in autism and other neurological disorders. There is also a link between thimerosal and speech delays, attention-deficit disorder, hyperactivity and autism. The Institute of Medicine conducted a study on thimerosal and concluded that the link between thimerosal and neurodevelopmental disorders was biologically plausible and called for the removal of thimerosal to "reduce mercury exposure of infants and children as much as possible."

"Fluzone vaccine is indicated for active immunization in people 6 months of

History Unfolding - By David Kaiser

I am a student of history. Professionally, I have written 15 books on history that have been published in six languages, and I have studied history all my life. I have come to think there is something monumentally large afoot, and I do not believe it is simply a banking crisis, or a mortgage crisis, or a credit crisis. Yes these exist, but they are merely single facets on a very large gemstone that is only now coming into a sharper focus.

Something of historic proportions is happening. I can sense it because I know how it feels, smells, what it looks like, and how people react to it.. Yes, a perfect storm may be brewing, but there is something happening within our country that has been evolving for about ten to fifteen years. The pace has dramatically quickened in the past two.

We demand and then codify into law the requirement that our banks make massive loans to people we know they can never pay back? Why? We learned just days ago that the Federal Reserve, which has little or no real oversight by anyone, has "loaned" two trillion dollars (that is \$2,000,000,000,000) over the past few months, but will not tell us to whom or why or disclose the terms. That is our money, yours and mine. And that is three times the \$700 billion we all argued about so strenuously just this past September. Who has this money? Why do they have it? Why are the terms unavailable to us? Who asked for it? Who authorized it? I thought this was a government of "we the people," who loaned our powers to our elected leaders, apparently not.

thought I would never come to experience what the ordinary, moral German must have felt in the mid-1930s In those times, the "savior" was a former smooth-talking rabble-rouser from the streets, about whom the average German knew next to nothing. What they should have known was that he was associated with groups that shouted, shoved, and pushed around people with whom they disagreed; he edged his way onto the political stage through great oratory. Conservative "losers" read it right now.

And there were the promises. Economic times were tough, people were losing jobs, and he was a great speaker. And he smiled and frowned and waved a lot. And people, even newspapers, were afraid to speak out for fear that his "brown shirts" would bully and beat them into submission. Which they did - regularly. And then, he was duly elected to office, while a full-throttled economic crisis bloomed at hand - the Great Depression.

Slowly, but surely he seized the controls of government power, person by person, department by department, bureaucracy by bureaucracy. The children of German citizens were at first, encouraged to join a Youth Movement in his name where they were taught exactly what to think. Later, they were required to do so. No Jews of course, How did he get people on his side? He did it by promising jobs to the jobless, money to the money-less, and rewards for the military-industrial complex. He did it by indoctrinating the children, advocating gun control, health care for all, better wages, better jobs, and promising to re-instill pride once again in the country, across Europe, and across the world. He did it with a compliant media - did you know that? And he did this all in the name of justice and change. And the people surely got what they voted for.

If you think I am exaggerating, look it up. It's all there in the history books. So read your history books. Many people of conscience objected in 1933 and were shouted down, called names, laughed at, and ridiculed. When Winston Churchill pointed out the obvious in the late 1930s while seated in the House of Lords in England (he was not yet Prime Minister), he was booed into his seat and called a crazy troublemaker. He was right, though. And the world came to regret that he was not listened to.

Shocker! Judge orders trial eligibility issue - Arguments planned Jan. 11 for major

Obama challenge - By Jerome R. Corsi © 2009 WorldNetDaily.

A California judge today tentatively scheduled a trial for Jan. 26, 2010, for a case that challenges Barack Obama's eligibility to be president based on questions over his qualifications under the requirements of the U.S. Constitution.

If the case actually goes to arguments before U.S. District Judge David Carter, it will be the first time the merits of the dispute have been argued in open court, according to one of the attorneys working on the issue.

In a highly anticipated hearing today before Carter, several motions were heard, including a resolution to long-standing questions about whether attorney Orly Taitz properly served notice on the defendants, which she had.

In a second ruling, Carter ordered that attorney Gary Kreep of the United States Justice Foundation can be added to the case to represent plaintiffs Wiley Drake and Markham Robinson, who had been removed by an earlier court order. Drake, the vice presidential candidate for the American Independent Party, and Robinson, the party's chairman, also were restored to the case.

But the judge did not immediately rule on Taitz' motion to be granted discovery – that is the right to see the president's still-concealed records. Nor did Carter rule immediately on a motion to dismiss the case, submitted by the U.S. government, following discussion over Taitz' challenge to the work of a magistrate in the case.

The judge did comment that if there are legitimate constitutional questions regarding Obama's eligibility, they need to be addressed and resolved.

Carter ordered a hearing Oct. 5 on the motion to dismiss and ordered arguments submitted on the issue of discovery. If the case survives that challenge, a pretrial hearing has been scheduled for Jan. 11 and the trial for two weeks later. The case would be the first time, according to Kreep, that the actual merits of the dispute will have been heard in open court. A multitude of such disputes have been rejected out of hand by various state and federal courts. Even the U.S. Supreme Court repeatedly has rejected See Trial, P. 5

Fluoride and Human Health - Joel Griffiths and Chris Bryson

Some 50 years after United States authorities began adding fluoride to public water supplies to reduce cavities in children's teeth, recently discovered declassified government documents are shedding new light on the roots of that still-controversial public health measure, revealing a surprising connection between the use of fluoride and the dawning of the nuclear age. Today, two-thirds of US public drinking water is fluoridated. Many municipalities still resist the practice, disbelieving the government's assurances of safety.

Since the days of World War II when the US prevailed by building the world's first atomic bomb, the nation's public health leaders have maintained that low doses of fluoride are safe for people and good for children's teeth. That safety verdict should now be re-examined in the light of hundreds of once-secret WWII-era documents obtained by these reporters [authors Griffiths and Bryson], including declassified papers of the Manhattan Project-the ultra-secret US military program that produced the atomic bomb.

Fluoride was the key chemical in atomic bomb production, according to the documents. Massive quantities-millions of tons-were essential for the manufacture of bomb-grade uranium and plutonium for nuclear weapons throughout the Cold War. One of the most toxic chemicals known, fluoride emerged as the leading chemical health hazard of the US atomic bomb program, both for workers and for nearby communities, the documents reveal.

Much of the original proof that fluoride is safe for humans in low doses was generated by A-bomb program scientists who had been secretly ordered to provide "evidence useful in litigation" against defense contractors for fluoride injury to citizens. The first lawsuits against the American A-bomb program were not over radiation, but over fluoride damage, the documents show.

Human studies were required. Bomb program researchers played a leading role in the design and implementation of the most extensive US study of the health effects of fluoridating public drinking water, conducted in Newburgh, New York, from 1945 to 1955. Then, in a classified operation code-named "Program F", they secretly gathered and analyzed blood and tissue samples from Newburgh citizens with the cooperation of New York State Health Department personnel.

The original, secret version (obtained by these reporters) of a study published by Program F scientists in the August 1948 Journal of the American Dental Association1 shows that evidence of adverse health effects from fluoride was censored by the US Atomic Energy Commission (AEC)-considered the most powerful of Cold War agencies-for reasons of "national security".

The bomb program's fluoride safety studies were conducted at the University of Rochester-site of one of the most notorious human radiation experiments of the Cold War, in which unsuspecting hospital patients were injected with toxic doses of radioactive plutonium. The fluoride studies were conducted with the same ethical mindset, in which "national security" was paramount.

urgent appeals to hear the evidence.

The suit alleges Obama is actually a citizen of Indonesia and "possibly still citizen of Kenya, usurping the position of the president of the United States of America and the commander-inchief."

WND has reported on dozens of legal challenges to Obama's status as a "natural born citizen." The Constitution, Article 2, Section 1, states, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President."

Some of the lawsuits question whether he was actually born in Hawaii, as he insists. If he was born out of the country, Obama's American mother, the suits contend, was too young at the time of his birth to confer American citizenship to her son under the law at the time.

Other challenges have focused on Obama's citizenship through his father, a Kenyan subject to the jurisdiction of the United Kingdom at the time of his birth, thus making him a dual citizen. The cases contend the framers of the Constitution excluded dual citizens from qualifying as natural born.

Complicating the situation is Obama's decision to spend sums estimated over \$1 million to avoid releasing a state birth certificate that would put to rest the questions.

EVIDENCE OF FLUORIDE'S ADVERSE HEALTH EFFECTS

The US Government's conflict of interest and its motive to prove fluoride safe in the furious debate over water fluoridation since the 1950s has only now been made clear to the general public, let alone to civilian researchers, health professionals and journalists. The declassified documents resonate with a growing body of scientific evidence and a chorus of questions about the health effects of fluoride in the environment.

Human exposure to fluoride has mushroomed since World War II, due not only to fluoridated water and toothpaste but to environmental pollution by major industries, from aluminum to pesticides, where fluoride is a critical industrial chemical as well as a waste by-product.

The impact can be seen literally in the smiles of our children. Large numbers (up to 80 per cent in some cities) of young Americans now have dental fluorosis, the first visible sign of excessive fluoride exposure according to the US National Research Council. (The signs are whitish flecks or spots, particularly on the front teeth, or dark spots or stripes in more severe cases.)

Less known to the public is that fluoride also accumulates in bones. "The teeth are windows to what's happening in the bones," explained Paul Connett, Professor of Chemistry at St Lawrence University, New York, to these reporters. In recent years, pediatric bone specialists have expressed alarm about an increase in stress fractures among young people in the US. Connett and other scientists are concerned that fluoride-linked to bone damage in studies since the 1930s-may be a contributing factor.

The declassified documents add urgency: much of the original 'proof' that low-dose fluoride is safe for children's bones came from US bomb program scientists, according to this investigation.

Now, researchers who have reviewed these declassified documents fear that Cold War national security considerations may have prevented objective scientific evaluation of vital public health questions concerning fluoride.

"Information was buried," concludes Dr Phyllis Mullenix, former head of toxicology at Forsyth Dental Center in Boston and now a critic of fluoridation. Animal studies which Mullenix and co-workers conducted at Forsyth in the early 1990s indicated that fluoride was a powerful central nervous system (CNS) toxin and might adversely affect human brain functioning even at low doses.

(New epidemiological evidence from China adds support, showing a correlation between low-dose fluoride exposure and diminished IQ in children.) Mullenix's results were published in 1995 in a reputable peer-reviewed scientific journal.2

During her investigation, Mullenix was astonished to discover there had been virtually no previous US studies of fluoride's effects on the human brain. Then, her application for a grant to continue her CNS research was turned down by the US National Institutes of Health (NIH), when an NIH panel flatly told her that "fluoride does not have central nervous system effects".





In the U.S., the FDA has acknowledged that there have been as many as 1,800 reports of kids experiencing abnormal behavior when they're given Tamiful. In Japan, they've actually banned the use of Tamiflu by kids.

But because the UK is in such a cold panic over swine flu, they're handing out Tamiflu like candy. Believe it or not, there's even a telephone hotline and website where people can order prescription without having to consult a doctor.

Peasants, or Sovereigns?

We take for granted freedom of the press, freedom to peacefully assemble, to speak, and hold our religious beliefs. If any of these were stripped away, or encumbered, there would be widespread dissent.

Few know this simple truth: that these "first amendment rights," are neither government grants nor constitutional privileges; but are rather limitations on the power of the federal government. Note that the amendment reads, "Congress shall make no law respecting . . . prohibiting ...abridging ..."

Unbeknownst to many, is the Preamble to the Bill of Rights. It begins, "The conventions of a number of the States having at the time of their adopting the Constitution, expressed a desire, in order to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added.." The so-called "Bill of Rights" was not intended to be a declaration of the peoples' rights. The Bill of Rights specifies limitations on the powers granted to the federal government by the Constitution.

The Declaration of Independence, the foundation of American law, establishes the principle that the people have a right to abolish their government when it becomes destructive to the end for which it was established. This principle also is expressed in Art. 2 sec. II of the Colorado Constitution. The Declaration of Independence also requires that the people have a duty to throw off their government "when a long train of abuses and usurpations. evinces a design to reduce them under absolute Despotism."

Wall Street To Securitize People's Deaths?

The New York Times published a pretty creepy article on Saturday (September 5th). The article focuses on Wall Street's new plan to make money. What's so bad about Wall Street making money?

Well, their new plan is to buy life insurance plans from elderly and sick people for cash. The example that the New York Times gives is someone selling a million dollar policy for a \$400,000 payout, but the payout amount would all depend on the seller's life expectancy. These "life settlements" would then be bundled together to form bonds that can be sold to investors. The investors would start paying for the person's policy from then on. When the person dies, the investors collect on the policy. Apparently, the faster the person dies, the more money the investors make. However, regardless of whether you die sooner or later, Wall Street firms will profit off of fees collected from creating the bonds and facilitating transactions. You could say that Wall Street is planning to "securitize" people's lives (or deaths, as it may be) into a kind of CDO. And we all know how great that whole CDO adventure played out for Wall Street, right? What could be dangerous about creating a similar class of financial products with sick people's life expectancy as the focus?

Apparently, these type of "life settlement" investments aren't new for banks. They already exist in a lot of portfolios. Whats new is the plan to securitize these "life settlements" and market them as a big-time asset class of their own. Keep in mind, this isn't something banks are just talking about potentially doing. The Times states that Credit Suisse is "building a financial"

assembly line to buy large numbers of life insurance policies, package and resell them — just as Wall Street firms did with subprime securities." Estimates are putting the market for this class of investment product at \$500 Billion, according to the article. I don't doubt it one bit. Considering how many people losing their jobs or facing pay cuts and how high medical bills are these days, does anyone really

doubt that there are a whole lot of elderly and sick people out there who would be eager to sell their life insurance policies for an immediate cash payout? Especially if they foresee a future inability to pay their premiums?

So whats the upside? Right now a lot of people just let their life insurance policies lapse. If they're lucky they'll still get a small payout but its usually not much compared to the premiums they've payed up to that point. Under this "life settlement" proposal, policy sellers get a bigger payout and eventually investors get their payout too. So insurance companies end up paying out on their policies more often than they do now. But, insurance companies could end up just raising rates and premiums to make up for the

difference, which could end up leaving the average policyholder worse off. Wall Street profits. Insurance companies profit. The consumer pays up.

Still, its hard to really get that angry over a proposal like this. As I pointed out, these type of "life settlements" are already held in a lot of investment bank portfolios. And, who am I to say what kind of financial relationships elderly and sick people should or shouldn't engage in?

But there are so many disturbing ramifications that come out of this proposal that I can't help but be worried. The article mentions that investors lost out on these type of investments in the '80s when people with AIDS ended up living longer thanks to new medications. It also mentions that risk managers

records, any baptism records, and his adoption records.

In the U.S. Justice Department's motion to dismiss, attorneys didn't address the concerns directly, but instead focused their efforts on technical procedures, suggesting the matter can't be decided in court and that the dozens of plaintiffs cannot demonstrate they have been injured by having Obama in the Oval Office.

"It is clear, from the text of the Constitution, and the relevant statutory law implementing the Constitution's textual commitments, that challenges to the qualifications of a candidate for president can, in the first instance, be presented to the voting public before the election, and, once the election is over, can be raised as objections as the electoral votes are counted in the Congress," wrote Assistant U.S. Attorneys Roger West and David DeJute. "Therefore, challenges such as those purportedly raised in this case are committed, under the Constitution, to the electors, and to the Legislative branch." President Obama's defenders also said they would file a motion seeking to block any discovery of evidence at this point.

Kreep said said his addition to the case probably will mean additional arguments over the president's eligibility.

Among the long list of plaintiffs are former ambassador and presidential candidate Alan Keyes and longshot vice-presidential candidate Gail Lightfoot, both of whom ran in 2008.

Justice officials say because neither had a mathematical chance at winning, they were not directly harmed by the election of Obama.

But among the issues that appear to be looming is a claim that Obama's actual birth certificate from Kenya has emerged.

As WND reported over the holiday weekend, Lucas Smith, the man who tried to sell an alleged Barack Obama Kenyan birth certificate on eBay, filed court papers insisting – under threat of perjury – that the Obama birth certificate in his possession is the genuine article.

Taitz posted on her blog Smith's declaration, which claims he obtained the alleged birth certificate from Coast General Hospital in Mombasa, Kenya, and insists it's real.

"The true and correct photocopy of the birth certificate obtained is attached to this affidavit as Exhibit A," the declaration reads. "I declare, certify, verify, state and affirm under penalty of perjury under the laws of the United States of America that the foregoing statements of fact and descriptions of circumstances and events are true and correct."

Smith's affidavit, which includes a copy of the certificate, has been filed Carter, whose works in the Central District of California.

In his filing, Smith declares that he traveled to Kenya in February and paid off a military officer in order to obtain a copy of the birth certificate from Coast General Hospital in Mombasa. The declaration also states that the hospital administrator signed and sealed the copy, which indicates Obama's birth in Africa on Aug. 4, 1961, at 7:24 p.m.

As WND reported, Smith released a video of the document he claims is a copy of Obama's hospital birth record, though WND's own investigation failed to substantiate the document's authenticity.

WND first reported earlier this year when Lucas Smith, a former resident of Cedar Rapids, Iowa, and known by the eBay handle "colmado_naranja," claimed to have a document proving Obama's birth in Mombasa, Kenya.

After promising to reveal the document to WND, Smith then dropped communications with a team of people offering to help him verify the document, only fueling the belief the sale – and therefore the alleged document – was a scam.

WND followed Smith's ongoing saga as "colmado_naranja" as he attempted several times to sell the document, or photos and stories surrounding it, on eBay, only to have the auctions repeatedly removed by site administrators.

WND also launched an investigation into "colmado_naranja," which led through several online aliases and reported collaborators, including Dawnella Wilson, "InspectorSmith" and, eventually, Lucas Smith.

Smith, whose background includes a lengthy criminal record and a reported attempt to sell his kidney to a man in need of organ transplant, nonetheless insists that his motives are above board, even if his past looks dubious.

"I do have a background. I've made mistakes in my life," Smith told WND in an e-mail. "It took a guy like me to go and get tangible proof about Obama. I don't mind breaking a few laws or policies here and there.

I don't mind paying the military in foreign countries to look the other way ... The military [in Africa] will grant you access to anything for just a few dollars. People are starving.

The Truth About the Health Care Bill - Michael Connelly

Well, I have done it! I have read the entire text of proposed House Bill 3200: The Affordable Health Care Choices Act of 2009. I studied it with particular emphasis from my area of expertise, constitutional law. I was frankly concerned that parts of the proposed law that were being discussed might be unconstitutional. What I found was far worse than what I had heard or expected.

To begin with, much of what has been said about the law and its implications is in fact true, despite what the Democrats and the media are saying. The law does provide for rationing of health care, particularly where senior citizens and other classes of citizens are involved, free health care for illegal immigrants, free abortion services, and probably forced participation in abortions by members of the medical profession.

The Bill will also eventually force private insurance companies out of business and put everyone into a government run system. All decisions about personal health care will ultimately be made by federal bureaucrats and most of them will not be health care professionals. Hospital admissions, payments to physicians, and allocations of necessary medical devices will be strictly controlled.

However, as scary as all of that it, it just scratches the surface. In fact, I have concluded that this legislation really has no intention of providing affordable health care choices. Instead it is a convenient cover for the most massive transfer of power to the Executive Branch of government that has ever occurred, or even been contemplated. If this law or a similar one is adopted, major portions of the Constitution of the United States will effectively have been destroyed.

The first thing to go will be the masterfully crafted balance of power between the Executive, Legislative, and Judicial branches of the U.S. Government. The Congress will be transferring to the Obama Administration authority in a number of different areas over the lives of the American people and the businesses they own. The irony is that the Congress doesn't have any authority to legislate in most of those areas to begin with. I defy anyone to read the text of the U.S. Constitution and find any authority granted to the members of Congress to regulate health care.

This legislation also provides for access by the appointees of the Obama administration of all of your personal healthcare information, your personal financial information, and the information of your employer, physician, and hospital. All of this is a direct violation of the specific provisions of the 4th Amendment to the Constitution protecting against unreasonable searches and seizures. You can also forget about the right to privacy. That will have been legislated into oblivion regardless of what the 3rd and 4th Amendments may provide.

If you decide not to have healthcare insurance or if you have private insurance that is not deemed "acceptable" to the "Health Choices Administrator" appointed by Obama there will be a tax imposed on you. It is called a "tax" instead of a fine because of the intent to avoid application of the due process clause of the 5th Amendment. However, that doesn't work because since there is nothing in the law that allows you to contest or appeal the imposition of the tax, it is definitely depriving someone of property without the "due process of law.

So, there are three of those pesky amendments that the far left hate so much out the original ten in the Bill of Rights that are effectively nullified by this law. It doesn't stop there though. The 9th Amendment that provides: "The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people;"The 10th Amendment states: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are preserved to the States respectively, or to the people." Under the provisions of this piece of Congressional handiwork neither the people nor the states are going to have any rights or powers at all in many areas that once were theirs to control.

I could write many more pages about this legislation, but I think you get the idea. This is not about health care; it is about seizing power and limiting rights. Article 6 of the Constitution requires the members of both houses of Congress to "be bound by oath or affirmation" to support the Constitution. If I was a member of Congress I would not be able to vote for this legislation or anything like it without feeling I was violating that sacred oath or affirmation. If I voted for it anyway I would hope the American people would hold me accountable.

best-selling author David Horowitz likens President Barack Obama to the "Manchurian Candidate" — a tool of the far left fostering the implementation of its radical agenda.

In the 1959 book "The Manchurian Candidate" by Richard Condon — which has been made into two movies — an American soldier is captured during the Korean War, taken to Manchuria in China, and brainwashed into being an unwitting assassin for the communists.

He becomes part of a plot to kill a U.S. presidential nominee to aid the ascension of the "Manchurian Candidate" — a candidate secretly backed by communists.

Horowitz is a former leftwing radical who turned conservative. He sees Obama's manipulators as a coalition of left-wing groups who have helped pave Obama's road to the White House.

One is the Center for American Progress, which is funded by billionaire George Soros and headed by John Podesta, co-chair of the Obama transition team.

Another is the Apollo Alliance, a "coalition of radicals, left-wing union leaders and corporate recruits, which had a major role in designing Obama's green economy plans, including the 'cash for clunkers' program," Horowitz writes on the FrontPageMag.com Web site.

Apollo Alliance's board includes Van Jones, who recently resigned as Obama's "green jobs czar" after his past inflammatory statements came to light. Horowitz notes that Jones is a "self-styled 'communist' and a proponent of the idea that the Katrina catastrophe was caused by 'white supremacy.'"

A key moment in the progress of the leftwing coalition came in 2004 when Soros decided to integrate "anti-American radicals" — including left-wing unions, environmental radicals, and the political organization ACORN — "into the structure of Democratic Party politics," writes Horowitz, founder of The David Horowitz Freedom Center and author of the new book "One Party Classroom."

Soros created what Horowitz called a "Shadow Party" to torpedo President George W. Bush's re-election effort in 2004.

"Soros failed to achieve his goal in 2004 but he went on working to create new elements of the network, such as the Apollo Alliance," Horowitz wrote.

Horowitz argues that Obama's true colors are beginning to show to the American people.

"Just eight months into his presidency, however, a new Barack Obama has begun to emerge. With unseemly haste Obama has nearly bankrupted the federal government, amassing more debt in eight months than all his predecessors combined. He has appeased America's enemies abroad and attacked America's intelligence services at home. He has rushed forward with programs that require sweeping changes in the American economy and is now steamrolling a massive new healthcare program that will give the government unprecedented control of its citizens."

As for Van Jones, "the rest of us should be wondering who his sponsors were within the White House," Horowitz observed. "Then we should ask ourselves what they are planning next."

White House Backs Controversial Domestic Surveillance Provisions

The Obama administration is urging lawmakers to extend three provisions of the controversial domestic surveillance law known as the USA Patriot Act.

The U.S. Justice Department issued a letter Tuesday asking Congress to renew provisions of the law that allow authorities to conduct roving electronic eavesdropping, or wiretaps, access business records and track so-called "lone wolf" suspects with no known links to foreign powers or terrorist groups.

The roving wiretaps would let agents track the communications of suspects who change their cell phones or other devices.

The provisions are due to expire on December 31.

Some lawmakers and civil libertarians have criticized the provisions, saying they infringe on Americans' right to privacy. The Justice Department says the administration is willing to consider stronger privacy protections as long as they do not "undermine the effectiveness" of the provisions.

Senator Patrick Leahy, a Democrat from the northeastern state of Vermont, who chairs the Senate Judiciary Committee, says it is important for the administration and Congress to work to protect both national security and civil liberties.

Aborn Defeat In Manhattan Repudiates Gun Prohibition Agenda, Says Ccrkba

BELLEVUE, WA – Yesterday's primary defeat of career anti-gunner Richard Aborn in his race to become Manhattan's District Attorney shows that even residents of a city with some of the strictest gun laws in the nation reject the gun control philosophy espoused by Aborn

and those who supported him, the Citizens Committee for the Right to Keep and Bear Arms said Wednesday.

Aborn, a former president of Handgun Control Inc. – now known as The Brady Campaign to Prevent Gun Violence – ran primarily on his gun control record. He collected only 26 percent of the vote.

"Keeping guns out of the hands of law-abiding citizens may appeal to demagogues like New York Mayor Michael Bloomberg and Congresswoman Carolyn McCarthy," noted CCRKBA Chairman Alan Gottlieb, "but it doesn't play well with average citizens who are tired of being victimized, not only by criminals, but by the very laws that people of Aborn's ilk have forced on them.

"Richard Aborn had the endorsement of the Brady Campaign, Million Mom March, New Yorkers Against Gun Violence and other antigun-rights organizations," he added. "We hope that his rejection sends a message to other gun control extremists that voters have had enough rhetoric and are fed up with restrictions on their gun rights."

Gottlieb said Aborn's last-place finish in the three-way race, which was won by attorney Cy Vance, is a repudiation of the gun prohibitionist philosophy he has represented over the past 17 years.

"Aborn's defeat should be a signal to other politicians that an endorsement from the Brady Campaign or any other anti-gun group is a political kiss of death," Gottlieb observed. "This defeat shows that there is no room in politics, especially in a prosecutor's office, for anyone harboring the kind of extremist opinions about gun rights and gun ownership that Richard Aborn has wanted to enforce as public policy."





had been genetically modified to include a well-known weed and insect killer.

Strilli Oppenheimer's indigenous African chickens were refusing to eat the mealies in the chicken feed bought from a large supplier. Concerned that the birds may be ingesting genetically modified maize, she had the maize tested.

The results confirmed Oppenheimer's initial suspicion -- the maize had been genetically engineered to produce proteins that are toxic to certain insects and weeds.

About her chickens' refusal to eat their maize, Oppenheimer said: "They're smart."

Mexico is outraged over influx of its own citizens.

The United States is a sovereign nation, not a subsidiary of Mexico, and American taxpayers are not responsible for the welfare of Mexico's citizens. It's time for Mexico - and its citizens - to stop parasitically feeding off the United States and start taking care of its citizens' own needs.

At a news conference the legislators said Sonora, Arizona's southern neighbor comprised mostly of small towns, cannot handle the demand for housing, jobs and schools it will face as Mexican workers here return to their country without jobs or money.

The Arizona law, which took effect Jan. 1, punishes employers who knowingly hire individuals who don't have valid legal documents to work in the United States. Penalties include suspension or loss of business licenses. Because more companies are complying, illegal immigrants are finding it more difficult to find work, so they are going home.

The Mexican legislators are angry because the influx of their own citizens is placing a burden on the state government.

"How can they pass a law like this?" asked Mexican representative Leticia Amparano-Gomez, who represents Nogales.

"There is not one person living in Sonora who doesn't have a friend or relative working in Arizona," she said, speaking in Spanish. "Mexico is not prepared for this, for the tremendous problems it will face as more and more people working in Arizona and sending money to their families, return to their hometowns without jobs."

Cameras keep track of all cars entering Medina

City signs have a unique way of greeting people. In Issaquah, for instance, motorists are told they're entering "a special place where people care." For years, Bothell invited people to stay "for a day or a lifetime."

In Medina, a new sign bears this warning: "You Are Entering a 24 Hour Video Surveillance Area."

Cameras have recently been installed at intersections to monitor every vehicle coming into the city.

Under the "automatic license plate recognition" project, once a car enters Medina, a camera captures its license-

plate number. Within seconds, the number is run through a database.

If a hit comes up for a felony — say, the vehicle was reported stolen or is being driven by a homicide suspect — the information is transmitted instantaneously to police, who can "leap into action," said Police Chief Jeffrey Chen.

"These cameras provide us with intelligence," Chen said. "It gets us in front of criminals. I don't like to be on a level



playing field with criminals."

He declined to give the number and location of all the cameras.

Medina — a city of 3,100 with an average household income of \$222,000 — had discussed the idea for years as a way to discourage crime, city officials said.

Last year, there were 11 burglaries, Chen said.

"Some people think [that number of burglaries] is tolerable," he said. "But even one crime is intolerable."

All captured information is stored for 60 days — even if nothing negative turns up, he said. That allows police to mine data if a crime occurs later, Chen said.

Doug Honig, spokesman for the American Civil Liberties Union of Washington, said such a system smacks of privacy violations.

"Government shouldn't be keeping records of people's comings and goings when they haven't done anything wrong," he said. "By actions like this, we're moving closer and closer to a surveillance society."

Medina City Council member Lucius Biglow said crime prevention "outweighs concern over privacy."

"Privacy is considerably less nowadays than it was, say, 50 years ago," he said. "I think most of us are pretty well-documented by the federal government ... simply because of the Internet and credit cards."

It's no secret cameras are everywhere — in stores, streets, parks and intersections where police want to cite drivers for running red lights.

includes the lesser. A greater right includes a lesser right; a greater duty includes a lesser duty. Since the people have a right, nay, a duty to abolish, to throw off their government when it becomes destructive to the end for which it was established, the lesser right, the lesser duty, includes holding the government accountable. The government is an agent of the people. The Constitution is a grant of power. The people have a duty to hold their government to account. How is this duty exercised?

Another right is mentioned in the First Amendment to the federal constitution. This right also is mentioned in the Colorado Constitution: the right to petition the government for redress of grievances. This right, known as the "capstone right," provides the people an avenue to hold the government accountable, a means to check their servant

when it gets out of line. The reason for the right to peaceably assemble is to discuss grievances against the government. Look at the First Amendment again: Congress shall make no law . . . abridging . . . the right of the people to peaceably assemble and to petition the Government for a redress of grievances."

Inherent in the right to petition for redress of grievances is the duty of the government to answer such petitions. The Magna Carta, where the right has its origin, declares that if such a petition goes unanswered after forty days, the people may seize the lands and possessions of the king until such time as the petition is answered. America's founding fathers petitioned

King George for redress of grievances many times, all of which not only went unanswered, and were met with repeated injury. Finally, in 1776, the founders determined that the King's silence warranted a separation, and thus the Declaration of Independence was written.

About ten years ago, a group called We the People Congress was formed. This Congress petitioned the government for redress of grievances on constitutional issues such as: America's involvement in wars without declarations of war, the Federal Reserve Act of 1913, the Patriot Act, the North American Union, and the failure of the President to enforce the immigration laws - each an abuse of federal power. Despite many opportunities to respond, the government refused to answer our petitions.

So we sued the government, asking the court to direct the government to answer the petitions. The court ruled that the government has no obligation to respond. We appealed, the court of appeals upheld the ruling. The Supreme Court twice refused to hear the case.

The Congress will convene for two weeks with three non-governmental delegates elected from each state to discuss what a free people are to do when their government turns against the people and holds the people's petitions for redress of grievances in contempt.

MONEY IS IT REALLY that they took? If your loan was paid off, why are you still paying someone who claims to be the lender or "Holder in Due Course," and yet can't even produce the actual, original note? (Don't have ANY standing to foreclose on you OR receive your monthly payments because they are NOT the true lender).

When they "sold" your Note or Loan, (separating the note from the loan), transfered servicing, or whatever juggling act they've done, they've broken and essentially destroyed the contract.

Now, what can YOU do, regardless of where you are in any mortgage? FIRST, and VITALLY important... obtain a Qualified Written Request (QWR) document. A QWR is a means you have to request documentation, verification, and prove they are the true Holder of the Note.

They are required by law to respond within 60 days. Send the QWR to all the mortgage companies or banks you've dealt with on the present loan you have. ReFi's stop the original mortgage, and a new one is established, so the

Census worker hanged with 'fed' on body.

The FBI is investigating the hanging death of a U.S. Census worker near a Kentucky cemetery, and a law enforcement official told the Associated Press the word 'fed" was scrawled on the dead man's chest.

The body of Bill Sparkman, a 51-year-old part-time Census field worker and occasional teacher, was found Sept. 12 in a remote patch of the Daniel Boone National Forest in rural southeast Kentucky.

The Census has suspended door-to-door interviews in rural Clay County, where the body was found, pending the outcome of the investigation.








