Sheriff Mack Freedom Event Great Success. . . Despite Local Law Enforcement Interference - By Jeff Maehr

Sheriff Richard Mack, the nationally known champion of Constitutional roles for Sheriffs all across the country, spoke to a packed house August 26th at the Pagosa Springs Community Center.

As the crowd began to fill up the chairs, not once, not twice, but three times, bleachers were needed to seat the growing numbers of citizens extremely interested in their freedoms and rights. At least seven Colorado counties were represented at this Freedom Event, including Archuleta, LaPlata, Montezuma, Mineral, Rio Grande, Conejos and Gilpin counties, and several unidentified New Mexico Counties.

After initial open comments to set the stage by MC, Dennis Spenser, a member of the Archuleta County Guard, Diane Luppe, a local Pagosa resident spoke about her experience with the illegal actions taken by the U.S. Forest Service against her private property within the National Forest, beginning in 1997, eventually including her losing her home and every penny she had through malicious prosecution and theft of her property... actions that should have been immediately thwarted by the County Sheriff, (at the

time, Tom Richards), but wasn't, despite repeated requests for help to him and the county commissioners. (A future event may be planned to allow Diana, and any others who may have run into similar activities to voice their experiences, and to gather documents for future actions).

Dennis Spenser then introduced Sheriff Mack, who



was welcomed by all with a standing ovation.

Sheriff Mack, for the next hour and half, told of his "transformation" from a "law enforcement officer," to a Peace Officer, the true role of any in public service whether Police or Sheriff's departments. This transformation occurred when he was confronted with a traffic stop where a frazzled woman with 3-4 kids going wild in the car, ran a stop sign. He could clearly tell this poor woman was at her wits end, and she simply was overwhelmed.

As he wrote out the ticket, he watched all that was taking place for this woman. Long story short, his conscience was knocked up side the head, and he suggested to this woman to take the kids to the park across the street, and let them get out to play and then turned and walked back to his car, tore the ticket up and drove off, leaving the woman there wondering what just happened. This was the start of Sheriff Mack's trek back to the Constitution and true law, and realizing the true role of a public servant involved with the law, and away from what he called "taxation through



citations," among other damaging behavior.

He went on to state plainly that "trying to change the federal government was simply impossible." The only solution Sheriff Mack provided was the single greatest solution we have at our disposal... educating our local County Sheriffs on the Constitution, and their Oath of Office to defend county citizens against federal encroachment and violation of laws, by ANYONE, or electing an honorable person who WILL stand for our rights and freedoms, and NOT violate their Oath of Office.

It is a felony for County Sheriff's, deputy Sheriffs or local Police Officers to violate their oath of office to defend the Constitution of either the U.S., or the state, PERIOD. So, too, are other county officials subject to this oath, and treason is a serious issue. Sheriff Mack stated to Sheriffs... "If you are not securing our rights, you are not doing your job," and that "the people are the only boss the Sheriff Answers to."

Sheriff Mack explained his first major stand against federal trespass. The Brady Bill was passed in 1993. Federal "men in black" came to Arizona and provided papers ordering Arizona Sheriff's to begin applying the laws in their state. After some tap dancing by many of the sheriffs fearful of doing anything to say no, Sheriff Mack went forward with a lawsuit against the federal government.

BBB Alerts Consumers about U.S. Census Workers: Be Cooperative, But Cautious!

For years, Better Business Bureau has educated consumers about not giving out personal information over the telephone or to anyone who shows up at their front door. With the U.S. Census process beginning, BBB advises people to be cooperative, but cautious, so as not to become a victim of fraud or identity theft.

The first phase of the 2010 U.S. Census is under way as workers have begun verifying the addresses of households across the country. Eventually, more than 140,000 U.S. Census workers will count every person in the United States and will gather information about every person living at each address including name, age, gender, race and other relevant data.

“Most people are rightfully cautious and won’t give out personal information to unsolicited phone callers or visitors, however the Census is an exception to the rule,” said Steve Cox, BBB spokesperson. “Unfortunately, scammers know that the public is more willing to share personal data when taking part in the Census and they have an opportunity to ply their trade by posing as a government employee and soliciting sensitive financial information.”

The Census data will be used to allocate more than \$300 billion in federal funds every year, as well as determine a State’s number of Congressional representatives. Households are actually required by law to respond to the Census Bureau’s request for information.

During the U.S. Census, households will be contacted by mail, telephone or visited by a U.S. Census worker who will inquire about the number of people living in the house. Unfortunately, people may also be contacted by scammers who are impersonating Census workers in order to gain access to sensitive financial information such as Social Security, bank account or credit card numbers. Law enforcement in several states have issued warnings that scammers are already posing as Census Bureau employees and knocking on doors asking for donations and Social Security numbers.

The big question is - how do you tell the difference between a U.S. Census worker and a con artist? BBB offers the following advice:

- If a U.S. Census worker knocks on your door, they will have a badge, a handheld device, a Census Bureau canvas bag and a confidentiality notice. Ask to see their identification and their badge before answering their questions. However, you should never invite anyone you don’t know into your home.
- Census workers are currently only knocking on doors to verify address information. Do not give your Social Security number, credit card or banking information to anyone, even if they claim they need it for the U.S.

Census. While the Census Bureau might ask for basic financial information, such as a salary range, it will not ask for Social Security, bank account or credit card numbers nor will employees solicit donations.

- Eventually, Census workers may contact you by telephone, mail or in person at home. However, they will not contact you by e-mail, so be on the look out for e-mail scams impersonating the Census. Never click on a link or open any attachments in an e-mail that are supposedly from the U.S. Census Bureau.

Editor’s Note:

While the census is a constitutionally supported “event,” the government typically expands their search for information and adds lots of other unconstitutional, unrelated and irrelevant questions under the color of law which they have no right to ask, and YOU have no legally duty to answer.

Article I: “The actual Enumeration (census) shall be made within three years after the first meeting of the Congress of the United States, and within every subsequent term of ten years, in such manner as they shall by law direct.”

Here it simply states that the ONLY item of information authorized by the Constitution in the census is “how many people are there.” Do you see anything about your income, your work hours, how many TV’s you have, or the host of other question on the census form? They will try to tell you that you are “legally required” to complete the entire form, but this is NOT supported by the Constitution and is an invasion of privacy.

Newsvine.com states: “Next year’s census will determine the apportionment of House members and Electoral College votes for each state. To accomplish these vital constitutional purposes, the enumeration should count only citizens and persons who are legal, permanent residents. But it won’t.

Instead, the U.S. Census Bureau is set to count all persons physically present in the country—including large numbers who are here illegally. The result will unconstitutionally increase the number of representatives in some states and deprive some other states of their rightful political representation. Citizens of “loser” states should be outraged. Yet few are even aware of what’s going on.” (End Quote)

Most all discussion regarding the census is simply “counting” the number of people, PERIOD. To claim that the additional several dozen questions are relevant to the Constitutional requirements to establish representatives is bogus, and is simply government wanting to know every detail it can about your life. Building Codes... Linked to Global Warming! - Jeff Maehr

Once upon a time, a man named Jim Starry built a house in Boulder Colorado in 1979. He lived in this house and rented it out for 21 years. This wasn't just any house, it was an environmental wonder. You see, his "R" factor (heat loss prevention) was an astounding 70. Most homes are in the range of R9 (measure taken with winds) or R19 (no winds), so one would think that this would be trumpeted all across the country and world... but it wasn't..

The building inspection "professionals" caught up with him, out of spite and because they didn't like Jim because he was trying to get them to change the code to help personal energy costs and the environment. So,, what was Jim's energy secret? It was in the building design, not in any special miracle insulation material. It was all design, and yet Boulder wouldn't accept this revolutionary design.

The Department of Energy today says a home should be R39, which is still half of Jim's house R value. What difference would R70 make in the world? It is estimated that the lower R9-19 values are responsible for 48% of global warming due to the dramatic heat and cooling loss in most every building worldwide. CONCENTRATION CAMPS IN US: ARE THEY REAL?

A bill introduced on Jan. 22 of this year “to direct the Secretary of Homeland Security to establish national emergency centers on military installations,” as the text of HR 645 actually states as its central purpose, could conceivably be geared toward creating what many Americans have feared in recent years—detention centers, or concentration camps, on American soil.

These fears are more acute these days due to the imploding economy, swine flu scares and other fear factors—real, imagined or concocted—that could lead to food runs, bank runs, and other signs of civil unrest that may spark a government crackdown.

Thus, AMERICAN FREE PRESS, in dealing with an issue that includes speculation and unverified sightings of these detention facilities, takes a cautious approach to monitor this issue. AFP obtained a copy of HR 645 and determined that the bill had just two cosponsors as of July 13. On Feb. 6 it was referred to the House Subcommittee on Terrorism, Unconventional Threats and Capabilities. It apparently has not moved.

So, the bill’s status regarding potential passage appears to be nearly “dead in the water,” but there is much more to this subject than HR 645, whose sponsor is U.S. Rep. Alcee Hastings, a Florida Democrat whose career has been mired in controversy and wrongdoing. Regardless of its status, the bill’s text reads like it’s mainly about emergency recovery for first responders, various other local, state and federal personnel and the general public—although the Defense and Homeland Security secretaries, not just emergency management agencies, are directly involved in decision making. The bill calls for “not fewer than six national emergency centers on military installations,” which would be located in designated Federal Emergency Management Agency (FEMA) regions. The bill specifies “a preference for designation of closed military installations.”

There are many of these since a special panel, the Base Realignment and Closure Commission, began to close bases when the “ColdWar” with the USSR ended.

The bill also states it would provide for creating facilities “capable of hosting the infrastructure necessary to rapidly adjust to temporary housing, medical and humanitarian assistance needs. . . .”

But whenever closed military installations are not available, the bill’s wording says that the secretaries of Defense and Homeland Security “shall jointly designate portions of existing military installations . . . as national emergency centers.”

Notably, the use of former military bases, or parts of operational ones, is what many observers say is apparent when they venture out to view U.S. detention facilities that reportedly have already been built, HR 645 notwithstanding. Martial law could be right around the corner, some fear, pointing to 15 executive orders that—if ever implemented—would give the federal government control over all communications, food, transportation and almost everything else imaginable. Thus, the big

picture regarding this issue is disturbing, but also is unclear. A lengthy list of about 800 alleged detention centers/concentration camps has circulated on the Internet for several years. AFP west coast correspondent Anthony Hilder, an author and filmmaker, said in March 2009 (see AFP news video posted at American-FreePress.net) that a Russian-made film, Concentration Camps in America, claims to have solid proof that such camps are a reality and are sitting empty, awaiting some sort of major civil breakdown—be it another terrorist attack or mass influx of illegal aliens—that would justify a limited or full-scale use of such facilities, many of which are said to have guard towers, barbed wire, various barracks and other menacing surroundings.

Hilder himself said that, of the places on the list, perhaps 40 percent are actual camps, in his estimation.

In the Midwest, for example, the list of camps includes everything from a former hospital across from the Crown Point, Indiana County jail—the hospital is reportedly 80 percent vacant and is thought to be a Federal Emergency Management Agency holding facility—to the highly scrutinized former Amtrak repair facility in Marion County, Indiana near Indianapolis, where the rail lines, the high razor-wire fencing, the huge vacant buildings, color-coded zones allegedly designed for processing incoming people, helicopter landing pads and other physical features suggest to observers that this is among the largest detention centers in the continental United States.

Another large facility is claimed to be in Alaska at, or near, Elmendorf Air Force Base, near Anchorage, with a capacity of 500,000. The biggest of them all is said to be just outside of Fairbanks, which is described as having a capacity for 2 million people, with mental health facilities.

AFP will continue probing this subject while checking out facilities across the nation.

Interestingly, HR 645’s sponsor, Rep. Hastings, is a former federal judge who is one of only six judges ever to be impeached by the U.S. Congress—which is no small distinction in a nation where federal impeachment efforts rarely get past first base. Previously a practicing attorney, Hastings spent 10 years as a federal judge until 1989 but was impeached, convicted and removed from office for corruption and perjury. “He was the sixth federal judge to be impeached and removed from office in American history,” his Wikipedia online profile states. The 23rd District Democrat, first elected to the U.S. House in 1992 and never seriously challenged for his seat since then, was impeached for some early shenanigans that caught up with him. Back in 1981, he was charged with accepting a \$150,000 bribe in exchange for a lenient sentence and the return of seized assets for 21 racketeering counts against Frank and Thomas Romano. Hastings also was charged with perjury in his testimony about the case. So in 1988, the Democratic controlled House took up the case, and Hastings was impeached for bribery and perjury by a resounding vote of 413-3. He was then convicted by the Senate in 1989.

TAMPA, Fla. – An American soldier questioning the eligibility of President Obama to hold office has had his latest legal challenge dismissed "as frivolous and wholly without merit," though the basic constitutional issue has yet to have a legal ruling.

The Aug. 6 order by U.S. District Judge Richard A. Lazzara came less than two hours after motions were filed by Maj. "There was no reasoning, no nothing," said Maj. Cook, who noted previous legal decisions in his case included three or four pages of legal explanations.

Congressman eyes lawsuit over president's eligibility - Republican finds birth certificate sizzling topic at Arizona town hall

WASHINGTON – U.S. Rep. Trent Franks, R-Arizona, told a townhall meeting in Kingman yesterday he is considering a lawsuit to establish Barack Obama's eligibility for the presidency.

Franks said there is conflicting evidence on the question of Obama's status as a "natural born citizen."

Mercury Dumping Ground in Grand Junction

The Department of Energy has identified Grand Junction as a potential disposal site for our nation's mercury waste -- dumping as much as 17,000 tons of mercury over the next 40 years. The proposal would require mercury from around the country to be shipped through Colorado communities and along vital water sources such as the Colorado River, posing a huge risk to Colorado's air and water.

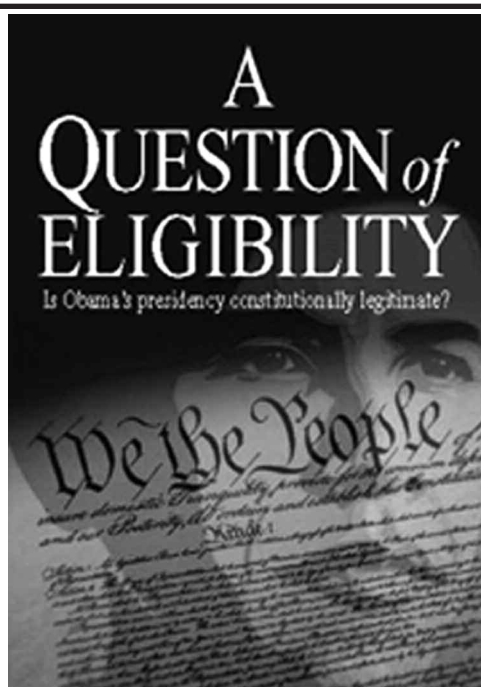

unwarranted numbers of euthanizations. I have volunteered at the shelter for the past two years, and I have personally seen troubling conditions and treatment of the animals, especially recently, that has saddened me and frustrated the shelter staff. I think it is important for the public to be aware of existing conditions before they reach into their pockets and contribute to an organization that I believe is highly autocratic and detrimental to the animals.

At least 22 dog euthanizations have been reported up to June 2009, and there have been more since that time. Previous years' dog euthanizations are as follows: 2005- 46 including 3 puppies; 2006- 43, including 14 puppies; 2007- 24 (no puppies); 2008- 13 (no puppies). Although the euthanizations for 2007 and 2008 decreased, the shelter has euthanized over 22 dogs in just six months in 2009, and they are well on their way to matching, if not exceeding, 2005 and 2006 statistics. This, to me, is alarming.

The reports I have do not indicate how many dogs were euthanized specifically for temperament aggression, but I know that many of them were. Temperament testing is a method by which a dog's temperament can be evaluated to determine the adoptability of a dog. It is supposed to be a gentle, humane 15 minute evaluation that takes specialized training to implement effectively. Through this testing, shelter staff can determine and accommodate a dog's behavioral needs and make informed decisions regarding that dog's adoptability. The goal is to match families with safe pets with consideration given as to what dogs would be appropriate with children, cats and other dogs. Although in an ideal world, it would be wonderful to only adopt out dogs that get along with everyone, dogs have different personalities and temperaments just like people. For instance, some dogs just do better in households without children or cats; that doesn't mean the dog is not adoptable.

With that in mind, a dog's temperament cannot always be truly assessed upon their initial evaluation because they often come into the shelter scared and confused. Dogs with seemingly initial aggression can actually become adoptable dogs with fair evaluations and effective behavioral modification. I believe that the Humane Society of Pagosa Springs conducts temperament testing on the dogs that is fear-based and designed to provoke aggression that sets the dogs up for failure, is highly judgmental, and made with no input from shelter staff. In fact,

only one person determines whether an otherwise potentially adoptable dog lives or dies. Testing is sometimes done until a negative reaction is seen, despite a dog's initial non-aggression. Food aggression tests are unfair; second and third evaluations are rarely allowed, and I know that in one particular case, when a reevaluation was permitted after behavioral modification by a shelter employee, and the dog passed, the dog was nevertheless euthanized just to teach the shelter employee a lesson.

State law (C.R.S. §35-80-106.3) requires that dogs that come in to the shelter are on a five day hold before they can be adopted out. Shelter employees were told they cannot handle or exercise dogs that are on a five day hold because of a "new law." I know of no new law and conversations with the Department of Agriculture have confirmed that no such law exists. In fact, there is a requirement that dogs be exercised "for a period not less than 20 minutes, twice daily", if minimum space requirements are not met. In addition, written records must be kept of the exercise of these dogs while each dog is in the facility. (The official version of the rules and regulations pertaining to the administration and enforcement of the Pet Animal Care and Facilities Act, also known as PACFA, are published by the Office of the Secretary of State in the Colorado Code of Regulations at 8 CCR 1201-11 and may be obtained from the following website: <http://www.sos.state.co.us/CCR/Welcome.do>.) Since temperament testing is generally not done until after the five day hold, and sometimes long after that time at the Pagosa Springs shelter, it would seem to make sense that a dog that

is not being provided handling and exercise is being set up for failure. This is especially true if there are two dogs to a kennel or if minimum space requirements are not being met, which is sometimes the case.

Sometimes a frightened animal will bite an employee upon being brought into the shelter. Dogs sometimes bite a veterinarian upon examination. Does that mean the dog is aggressive? The Humane Society of Pagosa Springs' policy is that such dogs are immediately euthanized after the 10 day mandatory rabies hold rather than be allowed a second evaluation. I realize they are concerned with liability and reputation in the community. The subject of dog bite law comprises a unique combination of city, county, state statutory law, state case law, and common law that is too long and complicated for discussion at this time. I can say, however, that evaluations at two other shelters that I researched are always conducted on dogs after the mandatory rabies hold for biting to determine if it was an isolated incident. Most of the animals on rabies holds for biting an employee at these shelters are rehabilitated, pass the evaluation and are considered adoptable. I want to make it clear that I am not suggesting that the Humane Society adopt out aggressive dogs; I am only saying that before it is definitively determined that the dog is aggressive, the dog should be given a chance to be fairly assessed and rehabilitated. Appropriate testing will weed out those dogs who are truly dangerous.


One shelter that I researched conducts their behavioral evaluations in 24 to 48 hours after a dog is brought into their shelter. The evaluations are conducted in a

gentle manner, designed to take into account the stressful situation that the dog is in, and conducts second and sometimes third evaluations, especially after food aggression tests which a dog may initially only tentatively pass, allowing the dog to "free feed" (giving them as much food as they can eat) to ensure fair testing upon the second or third evaluation. This other shelter makes euthanasia decisions with input from shelter employees to ensure no dog is put down needlessly or without consideration of all factors. They engage in behavioral modification to correct deficiencies in a dog's behavior. I have seen what Maria at the shelter can do with a dog, how she can modify a dog's seemingly aggressive behavior so that the dog passes an evaluation and becomes an adoptable dog. She is outstanding with animals and she deserves to be commended for her efforts.

For persons who are as concerned as I am about these matters, go to a board meeting and ASK QUESTIONS! Demand fair temperament testing, rehabilitation and behavioral modification methods, and that euthanasia of an animal be a team decision. Demand that the bylaws be amended to allow evaluations on rabies holds, ask why puppies are being euthanized and why they are putting two dogs to a kennel that does not meet minimum space requirements instead of purchasing more kennels, ask why they are so far behind on Phase II of the construction of the new facility. Hold them accountable to the Department of Agriculture's rules and regulations, and if you have a complaint, call the Department of Agriculture at 303.239.4100. If you

EXECUTIVE ORDER 11001 allows the

government to take over all health, education and welfare functions.

EXECUTIVE ORDER 11002 designates the postmaster general to run a national registration.

EXECUTIVE ORDER 11003 allows the government to take over all airports and aircraft, including ones in the commercial service.

EXECUTIVE ORDER 11004 allows the Housing and Finance Authority to relocate communities, build new housing with public funds, designate areas to be abandoned, and establish new locations for populations.

EXECUTIVE ORDER 11005 allows the government to take over railroads, waterways and public storage.

EXECUTIVE ORDER 11051 specifies the responsibility of the Office of Emergency Planning and gives authorization to put all Executive Orders into effect in times of increased international tensions or crises.

EXECUTIVE ORDER 11310 grants authority to the Department of Justice to enforce the plans set out in Executive Orders, to institute industrial support, to establish judicial

The suit was eventually joined by Sheriff Prince, and 5 other Sheriffs. The case went to the Supreme Court, where a huge victory took place for freedom. Sheriff Mack won the case, and this case has become one of the best documents supporting state sovereignty rights from the federal government, and showing the extremely limited role the federal government's actual lawfully authority in our country, AND any County.

After the event, Sheriff Mack signed the many books purchased, and answered questions. Everyone expressed appreciation for his dedication to the Constitution, and for educating people across the country in what citizens should expect from law enforcement... meaning... Constitutional "law enforcement," not statutory laws which violate the Constitution.

Despite all efforts by parties who do not want you to know what power you have at your disposal and how to put legal pressure on your local Sheriff, the Mack freedom event initiated a wave that will continue to give all of us means to get involved, whether through the Archuleta County Guard, the Law Club, or the Free Press. Who is Qualified to Give “Legal” Advice?

How many times have we heard the warning that “you are not allowed to give legal advice, and can be charged with practicing law without a license?”

What seems wrong to you about that statement? Anything at all? let’s discuss this a bit. let’s go back to your mid teens, when you were getting ready to take your driver’s license exam. You, and many of your friends were discussing the “Rules of the Road,” or something similar regard what the “law” said about dozens of driving elements, right?

The trinity has been a long standing Christian belief system for many centuries, but where does it come from?

The word "trinity" is NOWHERE used in the Bible. In fact, you can look from cover to cover and not find any direct reference to anything clearly suggesting a “trinity.”

days and three nights in the heart of the earth. (“Hell,” or the grave.)

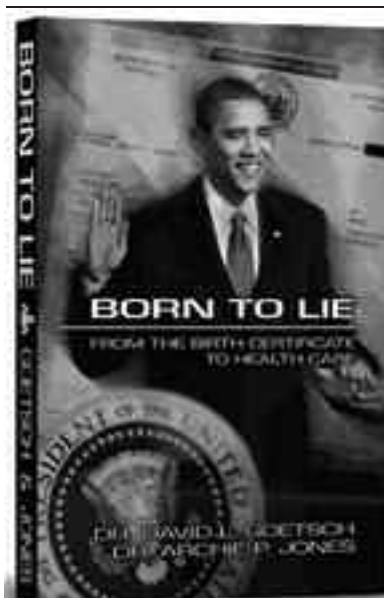

In the sixth month of his presidency, Obama has turned an economic downturn into an economic disaster, taking over and trashing entire companies, and driving the nation deep into deficit spending expected to pass 10 trillion dollars.

Colorado Governor Ritter proposes Tax on Gun Owners

Though this idea has been rejected by both Republican and Democrat controlled legislatures, Ritter now claims it will bring \$500,000 to state coffers.

"The Governor's office is using estimates for firearms purchases based on recent purchase numbers, and it highly inflates the number," said the Dudley Brown, the Executive Director of the largest pro-gun organization in Colorado, Rocky Mountain Gun Owners. Since the election of Barack Obama the number of firearms sales have skyrocketed across the nation.

"But even with a smaller number, he's forcing citizens who practice a constitutionally protected right to pay a tax first, much like the old Jim Crow laws," said Brown. "We don't believe gun owners should have to ask permission to buy a firearm in the first place, and we're now supposed to pay for their gun control?"

Colorado uses a "Baby Brady" Registration system system to check purchasers' backgrounds. This puts gun owners in double jeopardy, since they must go through the FBI check as well as that of the Colorado Bureau of Investigation. If Colorado's Brady Act was repealed, the FBI would conduct Brady Registration Checks, which wouldn't cost Colorado citizens and would shorten the wait

the last day. 40 And this is the will of Him who sent Me, that everyone who sees the Son and believes in Him may have everlasting life; and I will raise him up at the last day." NKJV

Notice that Christ clearly revealed that He had His own will... His own mind, thoughts, will, and He set THAT aside to do the Father’s will. Remember, “His” will was that the cup” that He was about to drink... His crucifixion, “pass from Him.” It didn’t. (As a side note, notice that Christ stated that He would “raise him up at the last day!” This is direct reference to being raised from the grave and death at the resurrection.)

If“death”is the penalty for sin, and Christ didn’t really die, where does that leave humanity, and their hope of a future?

God CANNOT DIE as a spirit being. If Christ were a part of the trinity, then HE, as a conscious being, REALLY DIDN'T DIE. Doesn't it seem a little ridiculous to believe that God went through this charade? How do you comprehend the SERIOUSNESS of sin and the death penalty when all that died on the stake 2000 years ago was a human body? Remember, the penalty for sin is DEATH, NOT to suffer some physical pain and torment. Some might conclude that was all that Christ experienced, but that is not DEATH. Why should Christ go through the act of feeling pain and suffering all that He did? THAT WAS NOT THE PENALTY FOR SIN.

Scripture states that "God so loved the world that He gave HIS ONLY BEGOTTEN SON." If Christ was a part of a “trinity,” then how is the above scripture valid? Why would Christ be the "only" son when the Holy Spirit is supposedly ALSO a part of the Trinity? God stated this fact about His “only begotten son" because IT WAS THE TRUTH. This eternal being GAVE the ONLY OTHER ETERNAL GOD BEING that existed. THAT is why He is called "ONLY." This is the vital dimension to this equation that most people are missing. If Christ was just "in" a human body, then God could have created another "only begotten son" which the “Son part of the trinity” could have used, which of course, moots the whole concept of "only." Since God could create millions of other human bodies for Christ to "dwell" in, the term "only" becomes worthless.

Naturally, Satan wants to minimize and make as foolish as he can, any aspect of the truth. Don't you think he has done a good job? How can thinking, reasoning human beings conclude that God and His plan is REAL if they see this simplistic, empty show as the "meat and potatoes" of religious truth? Can a being who is both the eternal, ever living God AND a human being capable of dying, be one and the same thing?

NO! The being we know as the Christ, literally ceased to exist as a conscious being when He died on that stake almost 2000 years ago. He was "asleep," lifeless in the tomb for three days and three nights. During those three days and nights, He had NO consciousness. For the first time in His existence, the being who had known eternity was completely dead and lifeless. His state for those three days was an example of what the state

of OUR existence would be FOREVER, without the penalty being paid for us.

Because Christ was sinless, His life COULD pay for all mankind, and because He DID NOT deserve eternal death, God the Father resurrected Christ, as an example of how He will resurrect every human being who achieves the right state of mind and character, just as Christ's example demonstrated. Remember, we are being shaped into the image of Christ, BY CHRIST. (Eph 4:13 “...till we all come to... a perfect man, to the measure of the stature of the fullness of Christ; NKJV) Who would be better able to relate to us, then He who was fully one of us? Here are a few challenges to consider:

1. There are ten books in the New Testament that begin with, "Grace be to you, and peace, from God our Father, and from the Lord Jesus Christ." Doesn't this seem odd if the Holy Spirit were an equal "person" in a trinity? Why doesn't Paul acknowledge this element of a trinity? Wouldn’t this be disrespectful of this “being?”

2. Matt 1:20 "But while he thought on these things, behold, the angel of the Lord appeared to him in a dream, saying, Joseph, you son of David, fear not to take to you Mary your wife: for that which is conceived in her is of the Holy Ghost.”

If Christ is called the son of the “Father,” which He is, but His conception is of the Holy Spirit, why is He not called the “Son of the Holy Spirit?”

3. IF God is a trinity, how can it be that Christ is sitting on a separate throne, next to the Father, and others will be sitting on the right and left of Christ in the Kingdom? These clearly indicate that God is NOT a trinity, and that Christ has His own consciousness and being, and that “God”will be a soon to expand family of beings like the Father and Christ.

4. “I and my Father are One. If you have seen me, you have seen the Father.” Why is there no mention of the Holy Spirit being part of this relationship of beings?

How can it be that Christ is sitting on a separate throne, next to the Father, and others will be sitting on the right and left of Christ in the Kingdom, yet He is supposed to be a part of “one” being?

The Holy Spirit is what God IS... He is spirit... it is He and Christ’s nature and power, not a separate, thinking being. It is His way of communicating with mankind via the “Spirit “IN” man” mentioned earlier.
